董事長報告

Chairman's Report

各位股東:

本人欣然向各位提呈北京北辰實業股份有限公 司截止二零零二年十二月三十一日止年度報 告。

主營業務持續發展

二零零二年本公司投資物業主動適應市場,繼 續擴大市場佔有率,實現了投資物業的持續增 長,全年營業額289.571.000元人民幣,較上年 增長 9.1%。 經營溢利 110,339,000 元人民幣, 比上年增長21.3%。發展物業通過引進人才、 加強營銷、優化設計、強化管理,使各個項目 的整體運作水平邁進一大步,全年累計實現營 業額 374,785,000 元人民幣,經營溢利 17,821,000 元人民幣。雖然二零零二年本公司 零售業務面對開業以來最嚴峻的市場競爭,但 仍勇於挑戰,全年實現營業額974,329,000元人 民幣,經營溢利55,748,000元人民幣,比上年 增長 0.6%。

重點工作順利推進

二零零二年北京市奧運前期工程已全面啟動, 項目開發的國際招標拉開了序幕。本公司繼成 功獲得二零零八年奧運會媒體村開發權後,本 年度公司更成立了奧運投標工作組,正式展開 了奧運項目的投標準備工作,與國外有實力的 企業組成奧運項目投標聯合體,對奧運項目的 功能定位、投標策略進行了深入研討,為參與 進一步投標奠定了穩健的基礎。

I am pleased to present to you the annual report of Beijing North Star Company Limited for the year ended 31st December 2002.

Continued growth in core operations

The Company took initiatives to adapt to the investment property market during 2002 with continuous growth in both market share and the enlargement of its investment properties portfolio. Turnover for the year amounted to Rmb289,571,000, representing an increase of 9.1% from the previous year, operating profit increased by 21.3% to Rmb110,339,000 operational efficiency of the Company's property development increased resulting from the additional recruitment of high caliber staff, strong marketing efforts, better design quality and strengthened management. The Company achieved a turnover and profit of Rmb374,785,000 and Rmb17,821,000 respectively from flat sales for the year. The year 2002 proved to be the most challenging year for the retail operation of the Company since its inception. In spite of this, the Company successfully attained turnover of Rmb974,329,000 and an operating profit of Rmb55,748,000, an increase of 0.6%.

Smooth progression in major projects

Preliminary works for the 2008 Beijing Olympic Games started during the year together with the commencement in the submission of tenders for Olympic projects by international corporations. After the successful bidding for the construction of the 2008 Olympic Village for the media, the Company formed a special task force to tender for additional Olympic projects. Preparation is underway for tendering the Olympic projects. Alliances were formed with established international conglomerates to bid for Olympic projects, in-depth study on the technical specification of individual projects and the bidding strategies were in discussion, laying down a solid foundation for the future success.

改革和管理取得實效


