Directors

Mr. Gu Chu Jun, aged 44, graduated with a master's degree in engineering from Tianjin University, the PRC. He is the inventor and patent rights holder of Greencool Refrigerants. Mr. Gu is also the founder of the Greencool Group. He is the chairman of the board for Greencool Enterprise Development Company Limited, Greencool Refrigerant (China) Company Limited and Greencool Technology Holdings Limited. Mr. Gu has over 17 years of experience in the refrigeration engineering and refrigerant industry. Prior to founding the Greencool Group, he taught at Tianjin University and devoted himself to the research of thermodynamics and refrigeration engineering. The new environmentally friendly refrigerants invented by the Greencool Group are a family of the refrigerants designated by the American Society of Heating, Refrigerating and Air-conditioning Engineers, Inc. (ASHRAE), an authoritative organization in the refrigeration industry worldwide, and have reached ASHRAE standards. To date, they are the only refrigerants in Asia to which ASHRAE serial names have been assigned. They have been recommended by the relevant authoritative organizations in several countries as CFC replacements. In 1998, Greencool Refrigerants were recommended by the State Environmental Protection Administration of China as a type of Class A Environmentally Friendly Products.

Mr. Liu Cong Meng, aged 58, joined the Greencool Group in July 1998. Currently he is the standing vice-president of Greencool Enterprise Development Company Limited and the executive director of Greencool Technology Holdings Limited. In January 2002, he became the president and chief executive officer of Kelon. Mr. Liu studied international relations and economics in Beijing University. He is experienced in environmental protection, international cooperation and management. Before joining the Greencool Group, Mr. Liu held such official posts as a diplomat of the Chinese embassies in countries such as the United States of America, and the head of the Department of International Cooperation of the Ministry of Agriculture of the PRC. He was responsible for handling the bilateral and the multilateral cooperation between the PRC and international organizations such as the World Bank and other related countries. Mr. Liu was a member of the Pacific Economic Cooperation Committee (PECC) and a guest foreign consultant of the Policy Advisory Council of the Australian Centre for International Agriculture Research (ACIAR) of the Australian Government.

Mr. Li Zhen Hua, aged 51, completed diploma education. He was general manager of Shunde Wan Jia Le Group Limited, chairman of Wan Jia Le Holdings Company Limited, general manager of Shunde Cheng Shun Investment Company, deputy chief of Rongqi Economic Development Committee, deputy township chief of Rongqi, deputy chief of Ronggui Public Asset Management Committee and deputy chief of Ronggui Town.

Mr. Yan You Song, aged 38, graduated with a master's degree in material science from Beijing Aeronautics & Space-flight University in 1989. Between 1991 and 1994, he was deputy factory manager and chief engineer of Beijing Dongshong Group Corporation Ltd. and was in charge of marketing, supplies and production management of the entire factory. He has led experiments using Greencool Refrigerants in new products and been active in the Group's business negotiations.
