Biographical Details of Directors

Mi Zengxin, aged 52, is currently Chairman of the Board. He was appointed a Non-Executive Director and Deputy Chairman of the Board of the Company between 28th February, 2001 to 31st December, 2002. He is an Executive Director and Vice President of China International Trust and Investment Corporation (CITIC). Prior to his appointment to the present position, he held executive management positions with various subsidiaries of CITIC and was the Chief Executive Officer of CITISTEEL in the United States from 1992 to 1997. He is also Chairman of the Board of CITIC USA Holdings and CITIC Australia Pty. He joined CITIC in 1985 and holds a Master of Science degree.

Romain Bausch, aged 49, is currently Deputy Chairman of the Board. He was appointed a Non-Executive Director and the Chairman of the Board of the Company between 1st January, 2001 to 31st December, 2002. He is the President and CEO of SES GLOBAL S.A. (SES GLOBAL). He started his career in the Luxembourg civil service. After subsequent promotions, he became General Administrator of the Ministry of Finance. He occupied key positions in the banking and media sectors and spent a five-year term as a Director and Vice Chairman of SES. He graduated with a Master of Arts degree in Economics (specialisation in Business Administration) from University of Nancy (France).

Peter Jackson, aged 54, has been the Chief Executive Officer of the Company since May 1996, having served in that position with AsiaSat since July 1993 prior to the listing of the Company. He has over 24 years' experience in the telecommunications field. Prior to his appointment as the Chief Executive Officer in 1996, he was employed by Cable & Wireless plc where he held engineering, marketing and management positions and was responsible for several satellite telecommunications ventures.

William Wade, aged 46, has been the Deputy Chief Executive Officer of the Company since May 1996, having served in that position with AsiaSat since April 1994 prior to the listing of the Company. He has over 18 years' experience in the satellite and cable television industry. He speaks Mandarin Chinese and holds a Bachelor of Arts (Honours) degree in Communications from the University of Utah, and a Masters of International Management degree from Thunderbird (the American Graduate School of International Management).

Robert Bednarek, aged 45, was appointed a Non-Executive Director of the Company on 14th March, 2002. He is an Executive Vice President Corporate Development and a Member of the Executive Committee of SES GLOBAL. Prior to joining SES GLOBAL, he was the Executive Vice President and Chief Technology Officer of PanAmSat Corporation. He graduated with a Bachelor of Science degree in Electronic Engineering from the University of Florida.

Professor Edward Chen, C.B.E., J.P., aged 58, has been an Independent Non-Executive Director of the Company since May 1996. He was educated at Hong Kong University (Bachelor of Arts, Master of Social Science) and Oxford University (Doctor of Philosophy) and is currently the President of Lingnan University in Hong Kong. He was a member of the Executive Council of Hong Kong from 1992 to 1997, and Chairman of the Consumer Council from 1991 to 1997. He is now Chairman of the Press Council, a director of First Pacific Company Limited, a Trustee of Eaton Vance Management Funds (Boston), and also a director of The Wharf (Holdings) Limited.
