### DIRECTORS

#### Executive Directors

**Mr. So Pang Gen**, aged 66, is the founder of the Group, and is currently the Chairman and the Managing Director of the Company. He is responsible for the overall strategic planning and formulation of the corporate policies of the Group. Mr. So graduated from Shanghai Tong Ji University in 1959 with a Bachelor's degree in architecture. Prior to the establishment of the Group in 1989, Mr. So was principally involved in the property development and investment business in the PRC and Hong Kong. Mr. So has extensive experience in the field of property development in both Hong Kong and the PRC. He is currently a member of the Changchun People's Political Consultative Conference, a consultant professor of Shanghai Tong Ji University. Mr. So is an adviser of Pok Oi Hospital and was engaged as the chairman during 1995/1996.

**Mr. Lam Hon-Keung, Keith**, OBE, JP, aged 63, joined the Group in May 2000 and is currently the Deputy-Chairman of the Company. He is responsible for marketing and business development strategy. Mr. Lam has over 26 years' experience in real estate business and financial field in Hong Kong. He was a former District Board Member (both appointed and elected) as well as a former appointed Legislative Councillor, committee member of Far East Exchange Limited (1975-86), a council member of the Stock Exchange (1983-1986, 1987-1988, and 1989-1994), the vice-chairman of the Management Committee of The Stock Exchange of Hong Kong Limited (1988), a director of Hong Kong Securities Clearing Company Limited (1990-94) and the Hong Kong District Adviser to Xinhua News Agency (Hong Kong Branch) (1994-97). Mr. Lam is an independent non-executive director of Wah Ha Realty Company Limited. Mr. Lam is also very active in community and social involvements — he is the chairman of the Hong Kong Buddhist Hospital, the vice chairman and the secretary of the Hong Kong Buddhist Association, a director of Buddhist Heung Hoi Ching Kok Lin Association and Buddhist Li Chong Yuet Ming Nursing Home for the Elderly, the supervisor of Buddhist Mau Fung Memorial College, a member of the Board of Kowloon-Canton Railway Corporation and the Board of Management of the Chinese Permanent Cemeteries etc. Mr. Lam was bestowed a Badge of Honour in 1977 and was appointed as an Unofficial Justice of Peace in the year 1981, he was also bestowed an Officer of The Order of the British Empire (O.B.E.) by the Queen in 1993; he is a fellow of the Institute of Directors and also a member of the British Institute of Management.
