酒店及水療按摩



Other Investments

The Group has invested in premier specialized healthcare providers in Hong Kong, Mainland China and the Philippines to offer healthcare services from cancer centres and endocrine disorder treatment to dental and ambulatory networks. Meanwhile, the Group also operates a building products plant in Mainland China to supply products of elaborate quality to the Chinese and overseas markets.
