

## Biographical Details of Directors and Senior Management

### Directors

**Dr. Hwang Jen** (aged 70), has been the chairman since 1987. Dr. Hwang is the president of the Hong Kong Factory Owners Association and the Hong Kong Printers and Dyers Association.
