PRINCIPAL ACTIVITIES

During the year, the Company acted as an investment holding company and its subsidiaries were principally engaged in property investment, manufacturing, trading and leasing of energy saving machine.

Particular of the Company's principal subsidiaries as at 31st March, 2003 are set out in note 47 to the financial statements.

CORPORATE RESTRUCTURING

The Group has been operating at a substantial loss for the past few years and recorded a negative consolidated net tangible asset value since 31st March, 2001. The Group was unable to draw down existing facilities or arrange new facilities for the settlement of outstanding debts and unable to maintain its normal operations. The Company has requested for the suspension of the trading of its shares on The Stock Exchange of Hong Kong Limited ("Stock Exchange") since 19th February, 2003 and remained suspended up to the date of this report.

On 15th July, 2003, the Company entered into the restructuring agreement with Chinese Estates Holdings Limited and its subsidiary, Million Point Limited ("Million Point") (together "Restructuring Proposal"). The Restructuring Proposal involved schemes of arrangement between the Company and its creditors, capital reorganisation of the Company and the subscription of new equity capital of the Company by Million Point. The Restructuring Proposal, if implemented, would enable the Group to return to a positive consolidated net tangible asset value position.

Details of Restructuring Proposal are set out in note 50 to the financial statements.

TURNOVER AND CONTRIBUTION BY SEGMENT

The Group's turnover and contribution to loss from operations analysed by principal activities are set out in note 6 to the financial statements.
