SUMMARY

- The Offer Price has been fixed at HK\$8.50 per Offer Share (excluding brokerage fee, SFC transaction levy, investor compensation levy and Stock Exchange trading fee).
- A total of 7,438 valid applications have been received pursuant to the Public Offer on **WHITE** and **YELLOW** application forms and through giving electronic application instructions to HKSCC (“EIPO”) for a total of 2,963,049,500 Public Offer Shares, equivalent to about 118.6 times of the total number of 24,977,000 Public Offer Shares initially available for subscription under the Public Offer.
- Due to the over-subscription in the Public Offer, the clawback mechanism has been applied. A total of 99,908,000 Placing Shares initially available for subscription under the Placing have been reallocated to the Public Offer. As a result of such reallocation, there are 124,885,000 Public Offer Shares available for subscription under the Public Offer, representing 50% of the total number of Offer Shares offered under the Share Offer.
- The 224,793,000 Placing Shares initially available for subscription under the Placing was significantly over-subscribed.
- H Share certificates for Public Offer Shares allotted to wholly or partially successful applicants applying for less than 500,000 Public Offer Shares using **WHITE** application forms and the relevant refund cheques which are not available for personal collection will be posted by ordinary post to those entitled at their own risk on Tuesday, 23rd September, 2003. The Offer Price has been fixed by agreement between BNP Paribas Peregrine, on behalf of the Underwriters, and the Company at HK\$8.50 per Offer Share (excluding 1% brokerage fee, 0.005% SFC transaction levy, 0.002% investor compensation levy and 0.005% Stock Exchange trading fee payable).

The net proceeds of the Share Offer (after deducting the relevant expenses and based on the final Offer Price of HK\$8.50 per Offer Share and assuming that the Over-allotment Option is not exercised at all) are estimated to amount to about HK\$2,034.7 million.

APPLICATIONS RECEIVED AND ALLOCATION OF PUBLIC OFFER SHARES

The Directors are pleased to announce that at the close of the application lists at 12:00 noon on Thursday, 18th September, 2003, a total of 7,438 valid applications have been received pursuant to the Public Offer on **WHITE** and **YELLOW** application forms and through E IPO for a total of 2,963,049,500 Public Offer Shares, equivalent to about 118.6 times of the total number of Public Offer Shares initially available for subscription under the Public Offer.

Of the applications received on **WHITE** and **YELLOW** application forms and through E IPO, a total of 6,598 valid applications in respect of a total of 536,706,000 Public Offer Shares were made for Public Offer Shares with an aggregate subscription amount (excluding 1% brokerage fee, 0.005% SFC transaction levy, 0.002% investor compensation levy and 0.005% Stock Exchange trading fee payable, based on the maximum Offer Price of HK\$8.55 per Offer Share) of HK\$5 million or less per application (equivalent to about 43.0 times of the total number of 12,488,500 Public Offer Shares initially available for allocation in pool A), and a total of 840 valid applications in respect of a total of 2,426,343,500 Public Offer Shares were made for Public Offer Shares with an aggregate subscription amount (excluding the 1% brokerage fee, 0.005% SFC transaction levy, 0.002% investor compensation levy and 0.005% Stock Exchange trading fee payable, based on the maximum Offer Price of HK\$8.55 per Offer Share) of more than HK\$5 million per application (equivalent to about 194.3 times of the total number of 12,488,500 Public Offer Shares initially available for allocation in pool B).

Application not based on the denominations set out in the application forms is rejected. No application for more than 100% of the H Shares initially being offered to the public for subscription under either pool A or pool B in the Public Offer (i.e., more than 12,488,500 H Shares) has been identified.

As the total number of Public Offer Shares validly applied for under the Public Offer is more than 118.6 times the number of Public Offer Shares initially available for subscription under the Public Offer, the clawback mechanism has been applied. A total of 99,908,000 Placing Shares initially available for subscription under the Placing have been reallocated to the Public Offer. As a result of such reallocation, there are 124,885,000 H Shares available for subscription under the Public Offer, representing 50% of the total number of Offer Shares offered under the Share Offer, whereas the total number of Placing Shares available for subscription under the Placing has been reduced to 124,885,000 H Shares, representing 50% of the total number of Offer Shares under the Share Offer. The H Shares offered under the Public Offer were conditionally allotted on the basis set out in the paragraph headed “Basis of allotment” below.

The Directors confirm that no Public Offer Shares have been allocated to applicants who are connected persons of the Company within the meaning of the Listing Rules. None of the Sponsor, the Underwriters and their respective affiliated companies has subscribed or taken up any Offer Shares for their own account under the Share Offer.
