## RESULTS

For the period ended 30th June 2003, the Group's turnover and net profit were HK\$210,674,000 (2002: HK\$210,134,000) and HK\$15,865,000 (2002: HK\$18,069,000) respectively.

## INTERIM DIVIDEND

The Board resolved to recommend an interim dividend of HK\$0.015 per share for the period ended 30th June 2003. The interim dividend will be payable on 28th October 2003 to shareholders whose names appear on the Register of Members of the Company on 21st October 2003.
