#### **Executive Directors**

Mr. Chen Jinyan (陳錦艷), aged 34, is the chairman and general manager of the Company responsible for the Group's operation and product development. Mr. Chen has over 12 years of experience in the textile industry. From September 1987 to July 1990, Mr. Chen studied at the Jiangxi Textile Industry Academy (江西紡織工業學院) and obtained a diploma in the design of textile products from the textile engineering faculty. In July 1990, he was appointed as deputy general manager of the Changle Wen Rong Fabrics Knitting Factory (長樂市文榕織布廠, "Wen Rong"), a founding shareholder of Fuzhou Huaguan Knitting and Sprinning Co., Ltd. (福州華冠針紡織品有限公司, "Fuzhou Huaguan"). As the deputy general manager, Mr. Chen was mainly responsible for product development and quality assurance at Wen Rong. He is a founder of the Group and worked as the general manager of Fuzhou Huaguan since 1995. He is the son of Mr. Chen Qinzhi and the elder brother of Mr. Chen Dong.

Mr. Chen Qinzhi (陳勤枝), aged 60, is a deputy chairman of the Company. He is a founder of the Group responsible for designing corporate policy and development strategy as well as overseeing the operation and management of the Group. Mr. Chen has over 17 years of experience in the textile industry. From 1985 to 1994, Mr. Chen had been the general manager of Wen Rong responsible for the overall management of Wen Rong in production management, sales of products and administration and finance related matters. He is the father of Mr. Chen Dong and Mr. Chen Jinyan.

Mr. Chen Dong (alias 陳錦東(Chen Jin Dong)), aged 32, is a deputy chairman and deputy general manager of the Company responsible for administration and finance of the Group. Mr. Chen has over 9 years of experience in the textile industry. In 1990, Mr. Chen obtained a diploma in industrial and financial accounting from the Fuzhou Industrial Academy (福州工業學院). He is a founder of the Group and worked as the deputy general manger of Fuzhou Huaguan responsible for its administration and finance. He is the son of Mr. Chen Qinzhi and the younger brother of Mr. Chen Jinyan.

Ms. Kong Ping (江萍), aged 35, is an executive Director responsible for sales and marketing of the Group, especially implementing the Group's plan of expansion into overseas markets such as establishing the Group's distribution network. Before she joined the Group in July 2003, Ms. Kong worked in the sales department of Fuzhou Fuhua Knitting and Dyeing Co., Ltd. (福州福華紡織印染有限公司, "Fuzhou Fuhua") from February 1993 to June 2003.
