The allowance paid to each of the independent directors was Rmb50,000, including the travel and accommodation expenses incurred from attendance of board meetings and general meetings.

3. Changes in directors, supervisors and senior management of the Company

The Company held its third meeting of the 2003 board on 25 March 2003. The following resolutions were passed to approve: the resignation of Mr. Xu Zuyuan as the general manager of the Company, the appointment of Mr. Yan Mingyi as the general manager of the Company and Mr. Wang Kunhe as the deputy general manager of the Company; the resignation of Mr. Ye Yumang and the appointment of Ms. Yao Qiaohong as the company secretary of the Company.

The Company held its 2002 Annual General Meeting ("AGM") on 28 May 2003, the following resolutions were passed to approve: the reappointment of Mr. Li Kelin, Mr. Li Shaode, Mr. Wang Daxiong, Mr. Xu Zuyuan and Mr. Yan Mingyi as executive directors of the Company was approved; the appointment of Mr. Yao Zuozhi as an executive director of the Company, and Mr. Zhou Zhanqun, Mr. Hu Honggao and Mr. Xie Rong as independent directors of the Company; the reappointment of Mr. Zhang Rongbiao and Mr. Wang Xiangyun as supervisors of the Company; the appointment of Mr. Kou Laiqi as a supervisor of the Company.

4. Information of employees

As at 31 December 2003, the number of employees of the Company was 7,897, of which 6,936 were operating employees. The number of employees who have various technical titles was 3,305, accounting for approximately 41.9 per cent of the staff. Among the 3,305 employees who have technical titles, 160 of them have senior technical titles. The number of employees graduating from colleges or universities was 2,126, accounting for approximately 26.9 per cent of the staff. The total number of employees retiring and being laid-off during the reporting period was 4,053 whose expenses were paid by the Company.
