





- 以上列出的股東情況中代表國家持有 股份的單位為熊貓電子集團有限公 司,持有本公司股份355,015,000 股, 佔本公司已發行股本的 54.20%, 為未上市流通的國有法人 股。熊貓電子集團有限公司前身成立 於1936年,後於1999年7月5日經南 京市政府批准改制轉為有限責任公 司,又於2003年6月4日完成「債轉 股」, 現註冊資本為人民幣126,606 萬元,其股東為中國華融資產管理公 司(佔股本36.84%),南京新港開發 總公司(佔股本22.07%), 江蘇省國 信資產管理集團有限公司(佔股本 21 59%),中國信達資產管理公司 (佔股本8.87%),中國長城資產管理 公司(佔股本6.31%),南京市國有資 產經營(控股)有限公司(佔股本 4.32%)。法定代表人為奚永明,經 營範圍為無線電通信設備,廣播電視 設備,電器機械及器材,電子系統工 程等。其所持股份於報告期內未有變 化,亦無質押或凍結的情況。
- (2) 香港中央結算(代理人)有限公司所持 有本公司H股237,063,899股(佔本公 司已發行股本的36.19%),乃分別代 表其多個客戶所持有。本公司並不知 悉任何個別客戶持有本公司已發行股 本5%以上的權益。
- (3) 以上第二至第十大股東所持H、A股 均為向社會公開發行的可流通股。
- (4) 前十名股東均不是本公司的戰略投資 者,熊貓電子集團有限公司與第2-10名股東之間不存在關聯關係或屬 於一致行動人,公司未知第2-10名 股東之間存在關聯關係或屬於一致行 動人。

Notes:

- Among the shareholders named above. Panda Electronics Group Limited ("PEGL") held 355,015,000 shares, representing 54.20% of the issued share capital of the Company, on behalf of the State. The State-owned legal person shares are non-circulating shares. The predecessor of PEGL was formed in 1936 and converted into a limited company upon approval by Nanjing Municipal Government on 5 July 1999, and subsequently completed the conversion of indebtedness into equity interests on 4 June 2003. The registered capital of PEGL is RMB1.266.060.000 and its shareholders include 中國華融資產管理公司(China Huarong Assets Management Company),(representing 36.84% of the share capital), 南京新港開 發總公司 (Nanjing Xingang Development Corporation), (representing 22.07% of the share capital), 江蘇省國信資產管理公司 (Jiangsu International Trust and Investment Corporation), (representing 21.59% of the share capital),中國信達資產管理公司(China Xinda Assets Management Company), (representing 8.87% of the share capital), 中國長城資產管理公司(China Changcheng Assets Management Company), (representing 6.31% of the share capital) and 南京市國有資產經營(控股)公司 (Nanjing Municipal Statedowned Assets Operation (Holding) Company), (representing 4.32% of the share capital). The legal representative of PEGL is Mr. Xi Yongming. PEGL engages in the manufacture of wireless telecommunication equipment, broadcasting television equipment. electrical machinery and apparatus, electronic system projects, etc. There was no change in the shareholding held by PEGL and the shares were neither subject to pledge nor being frozen during the reporting period.
- (2) HKSCC Nominees Ltd. held 237,063,899 H Shares, representing 36.19% of the issued share capital of the Company, on behalf of several clients. The Company is not aware of any individual client holding more than 5% of share capital issued by the Company.
- (3) The H and A shares held by the above second to the tenth largest shareholder are circulating shares issued to the public.
- (4) All the top ten shareholders are neither strategic investors of nor connected with the Company. There is no connection or any party acting in concert between Nanjing Panda Electronics Group Limited and its 2nd-10th shareholders. The Company does not know there is any connection or any party acting in concert among its 2nd-10th shareholders.

就本公司董事、監事及高級管理人 員所知,根據「證券及期貨條例」第 336條規定備存之登記冊,各主要股 東在本公司股份及相關股份的好倉 如下(本公司董事、監事及高級管理 人員除外):(1)熊貓電子集團有限公 司持有內資股355,015,000股,佔已 發行內資股股份的概約百分比為 85.96%, 佔已發行總股份的概約百 分比為54.20%,該股份權益類別為 法團權益,並以實益持有的身份持 有。(2) Lewis Joseph持有H股 20,260,000股, 佔已發行H股股份的 概約百分比為8.38%,佔已發行總股 份的概約百分比為3.10%, 該股份權 益類別為個人權益,並以實益持有 的身份持有。(3) Tuesday Thirteen Inc.持有H股16,920,000股,佔已發 行H股股份的概約百分比為7.00%, 佔已發行總股份的概約百分比為 2.59%,該股份權益類別為法團權 益,並以受控制法團的身份持有。 以上主要股東所持有的股份均未出 現淡倉。

除上文披露外,本公司並不知悉任何人士(本公司董事、監事及高級管理人員除外)概無擁有須按「證券及期貨條例」第336條於登記冊內備存的權益或淡倉。

6. Substantial shareholders' interests and short positions in the shares or underlying shares of the Company

So far as the directors, supervisors and senior management members of the Company are aware, long positions in shares or underlying shares of the Company held by substantial shareholders (exclusive of directors, supervisors and senior management members of the Company) which were required. pursuant to section 336 of the Securities and Futures Ordinance ("SFO"), to be entered in the register referred to therein are as follows: (1) Panda Electronic Group Ltd. holds 355,015,000 domestic shares, accounting for approximately 85.96% of the domestic shares in issue and approximately 54.20% of the total shares in issue. The nature of Interests in such shares is corporate interest which is held in the capacity of beneficial owner; (2) Lewis Joseph holds 20,260,000 H shares, accounting for approximately 8.38% of the H shares in issue and approximately 3.10% of the total shares in issue. The nature of Interests in such shares is personal interest which is held in the capacity of beneficial owner; and (3) Tuesday Thirteen Inc., holds 16,920,000 H shares, accounting for approximately 7.00% of the H shares in issue and approximately 2.59% of the total shares in issue. The nature of Interests in such shares is corporate interest which is held in the capacity of controlled corporation. No short positions are found in any shares held by the above substantial shareholders.

Save as disclosed above, so far as is known by the Company, no any other persons (exclusive of directors, supervisors and senior management members of the Company) has any interests or short positions which were required to be entered in the register as required pursuant to section 336 of the SFO.
