#### **DIRECTORS**

Sun Weijun, aged 58, is the Chairman and General Manager of the Company. Mr. Sun joined the Company in 1980 and had held positions of Factory Manager of the fertilizer plant, Deputy Factory Manager of Sinopec Zhenhai General Petrochemical Works ("ZGP"), Deputy General Manager and General Manager of the Company. Mr. Sun has extensive experience in management of large-scale enterprise and project construction. Mr. Sun graduated from Nanjing Chemicals Institute in 1968 majoring in inorganic chemical industry and holds the title of senior engineer and enjoys special governmental allowance.

Zhan Juping, aged 58, is the Deputy Chairman and Party Committee Secretary of the Company. Mr. Zhan joined the Company in 1976 and used to be a department manager and a Deputy Factory Manager of ZGP and a Deputy General Manager of the Company. Mr. Zhan has extensive experience in the construction of major refining and chemical projects and corporate management. Mr. Zhan graduated from Zhejiang University in 1970 majoring in mechanical manufacturing and holds the title of senior engineer and the title of senior political scientist of professor level.
