### DIRECTORS

#### Executive directors

**Mr. FENG Guangcheng**, aged 52, chairman and the founder of the Company. He is qualified as a senior engineer as certified by Shaoxing City Educational Training Group in April 1999. He completed his study in Zhejiang Finance and Economics College with a major in Business Administration in 1989. In June 1994, he founded Zhejiang Float Glass Industry Company Limited (former name of the Company) and became the chairman and general manager of the Company. Mr. Feng Guangcheng has extensive experience in the construction materials industry, glass manufacturing, corporate management and administration.

**Mr. FENG Liwen**, aged 32, director and sales manager of the Company and Mr. Feng Guangcheng's nephew. He attended an economic administration study program in Zhejiang Industrial University of the PRC from August 1998 to December 1999. Mr. Feng Liwen joined the Company in 1998 and is responsible for the sales department of the Company. Mr. Feng Liwen has extensive working experience in construction businesses and product marketing.

**Mr. HUANG Bingzhi**, aged 63, director and assistant manager of the project development department of the Company. He is a senior engineer. Mr. Huang graduated from the Wuhan City Development College with a major in Silicate Production Process in 1960. Mr. Huang joined the Company in 1996 and is responsible for the construction of the Company's production lines. He has extensive experience in glass manufacturing. Before joining the Company, Mr. Huang worked as a technician of production research and development centre of Beijing Pottery Research Institute and as the factory manager of Wuhan Zhuzhou Glass Factory.

**Mr. XU Haichao**, aged 40, director and purchasing manager of the Company and Mr. Feng Guangcheng's brother-in-law. He attended an economic administration study program in Zhejiang Finance and Economics College from July 1997 to December 1998. Mr. Xu has been working in the Company since 1996 and has extensive experience in material supply management.

### Non-executive directors
