# **BIOGRAPHY OF DIRECTORS AND SENIOR MANAGEMENT**

#### INDEPENDENT NON-EXECUTIVE DIRECTORS

**Professor Woo Chia Wei**, aged 66, is an independent non-executive director and the non-executive chairman of the Group, appointed on 16th September 2003. Professor Woo was the founding president of the Hong Kong University of Science and Technology from 1988 to 2001. He was a professor of physics at Northwestern University, University of Illinois, and University of California. In 1983, he became the president of San Francisco State University, the first Chinese-American to serve as president of a major university in the United States. Professor Woo also serves on Hong Kong's Commission on Strategic Development and Council of Advisers on Innovation and Technology, and the Chinese People's Political Consultative Conference. Professor Woo acts as an independent non-executive director of First Shanghai Investments Limited and Lenovo Group Limited and a non-executive director of Shanghai Industrial Holdings Limited and IDT International Limited, the shares of all of which are listed on the Stock Exchange.

**Mr. Shih Wing Ching**, aged 55, is an independent non-executive director appointed on 16th September 2003. Mr. Shih has more than 25 years of experience in the real estate agency industry. He established Centaline Property Agency Limited in 1978 and is currently the chairman of Centaline (Holdings) Company Limited. Mr. Shih is the chairman of the Board of Governors of Hong Kong Sinfonietta and a member of Oxfam Hong Kong. Mr. Shih is also a member of the Hospital Governing Committee of the Rehabaid Centre. In 2003, Mr. Shih was appointed by the Hong Kong Housing Authority to be a member of the Subsidised Housing Committee.

#### NON-EXECUTIVE DIRECTOR

**Mr. Lai Ming, Joseph**, aged 59, is the non-executive director of the Group appointed on 5th August 2003. Mr. Lai is a fellow member of the Hong Kong Society of Accountants, CPA Australia and the Chartered Institute of Management Accountants. He has over 30 years of corporate finance and management experience. Mr. Lai was the president of the Hong Kong Society of Accountants in 1986 and is currently on the Audit Committee and the Investigation Panel of the Society. He was an executive director of the companies of the Hsin Chong Group until 1992. After a number of years in Canada, Mr. Lai rejoined the Hsin Chong Group in 2001 and served as an executive director of Hsin Chong Holdings (H.K.) Limited and the managing director of Hsin Chong International Holdings Limited until December 2003 when he retired. He is also an Adviser to the Corporate Governance Committee of the CPA Australia Hong Kong China Division, a director and the Hon. Treasurer of Opera Hong Kong Ltd. and a director of the Hong Kong University of Science and Technology R and D Corporation Ltd.

Mr. Kwong graduated from the University of Hong Kong and was awarded a Master of Philosophy degree in Economics and Politics of Development by the University of Cambridge, England. He served in the Government of Hong Kong for 27 years and held positions principally in the economic and financial fields before he left the Government in 1998. Mr. Kwong then served as the chief executive of the Hong Kong Exchanges and Clearing Limited until April 2003. He is currently an independent non-executive director of chinadotcom corporation, the shares of which are listed on the NASDAQ, and Giordano International Limited and an alternate director of Hsin Chong Construction Group Ltd., the shares of both of which are listed on the Stock Exchange. Mr. Kwong is also the managing director of Hsin Chong International Holdings Limited. Mr. Kwong holds a number of public service positions, including council member of the Chinese University of Hong Kong and board director of the Hong Kong Community Chest.
