## EXECUTIVE DIRECTORS

*Mr. Ku Ngai Yung, Otis*, aged 37, is the chairman and managing director of the Group. He holds a bachelor of arts degree majoring in administrative and commercial studies from the University of Western Ontario, Canada. He joined the Group in June 1988 upon graduation from university. He is responsible for the Group's overall corporate policy making, strategic planning and business development. *Mr. Ku Ngai Yung, Otis* has been actively involved in all aspects of the Group's business, including design, product development, sales and marketing, as well as production.
