#### Executive Directors

**Mr. Wu Yijian**, aged 43, is the Chairman of the Company. Mr. Wu joined the Group in 2001. He set up Ginwa Enterprises Group ("Ginwa Group") in 1991 and is now the President of Ginwa Group.
