"CEPA" [「CEPA」]	means 指	Mainland and Hong Kong Closer Economic Partnership Arrangement. 內地與香港關於更緊密經貿關係的安排
"China" or "PRC" [「中國」]	means 指	The People's Republic of China. 中華人民共和國
"China Mainland" or "Mainland" [「中國大陸」或「國內」]	means 指	China, excluding Hong Kong, Macau and Taiwan. 中國，不包括香港、澳門及台灣
"Daye" [「大業」]	means 指	Daye Transmedia Co., Ltd. 大業影視傳播有限公司
"Directors" [「董事」]	means 指	The Directors of the Company. 本公司之董事
"GDP" [「本地生產總值」]	means 指	Gross domestic product, a measure of the total value of production of all resident producing units of a country or territory in a specified period. GDP can be measured using different approaches. For the PRC, GDP is compiled using the production approach and the income approach. 本地生產總值，某國家或地區的常駐生產單位於某段期間內的生產總值。本地生產總值可以不同方法計算，而中國則以生產面和收入面計算本地生產總值

"KMB" [「九巴」]	means 指	The Kowloon Motor Bus Holdings Limited, a company incorporated in Bermuda in August 1997 and who securities are listed on the Stock Exchange. 九龍巴士控股有限公司，一九九七年八月於百慕達註冊成立的公司，其證券於聯交所上市
"KMB (1933)" [「九巴(1933)」]	means 指	The Kowloon Motor Bus Company (1933) Limited, a member of KMB Group. 九龍巴士(一九三三)有限公司，九巴集團的成員公司
"Listing Date" [「上市日期」]	means 指	"28 June 2001, the date on which the trading of the Company's shares commenced on the Stock Exchange. 二零零一年六月二十八日，本公司股份開始在聯交所買賣當日
"Listing Rules" [「上市規則」]	means 指	The Rules Governing the Listing of Securities on the Main Board of the Stock Exchange. 聯交所主板證券上市規則
"Main Board" [「主板」]	means 指	The stock market operated by the Stock Exchange prior to the establishment of The Growth Enterprise Market of the Stock Exchange (excluding the option market) and which continues to be operated in parallel with the Growth Enterprise Market. 早於聯交所創業板成立前已由聯交所管理並與創業板一同繼續由聯交所管理之股票市場（不包括期權市場）
