Executive Directors

LI Zhenjiang (李振江), aged 49, is an executive Director and one of the founders of the Group. Mr. Li obtained a diploma in Chemical Mechanics from Hebei Province Chemical Industrial Institute in 1982 and in 1989 graduated from the Modern Management Institute where he majored in Industrial Business Administration. He is currently studying for an EMBA at the Yangtze Commercial Institute. Mr. Li joined the predecessor of the Group in 1974 and has been the Chairman and President of the Group and its predecessor since 1984 with responsibility for business development and strategy. He has more than 20 years' experience in the operation and management of modern Chinese medicine enterprises. Mr. Li takes charge of the overall management of the Group and is also specifically responsible for the Group's research and development activities. Mr. Li is a Representative to the 10th National People's Congress and to the 7th, 8th and 9th Hebei Province People's Congress. He has been named as an Outstanding Entrepreneur in the PRC Pharmaceutical Industry in 1994, and as a China Outstanding Young Entrepreneur in 1995 and has received a National Wu Yi Labour Award.
