EXECUTIVE DIRECTOR

Ms. WANG Feixue (王飛雪女士), aged 37, is an executive Director and the chairman of the Group. She became a shareholder of ZZNode (Beijing) in April 2001, after Shanghai Zhizhen Telecommunications Technology Company Limited transferred its 19.8% interest in ZZNode (Beijing) to her.
