DIRECTORS

Executive Directors

Dr. Yang Ding-Yuan, aged 57, is the chairman of the Group and is responsible for strategic development of the Group. He is one of the founders of Winbond Electronics Corporation (“Winbond”) an integrated chip manufacturer in Taiwan and had been the vice-chairman of Winbond from 1998 to 2001. Dr. Yang has also made a number of private high-tech investments and is a director and/or chairman of several high-tech companies based in Taiwan and the USA. Prior to 1987, Dr. Yang held various academic and governmental research positions in Taiwan.

Ms. Meng Tung-Mei Grace, aged 59, is the vice-chairman of the Group. Ms. Meng holds a bachelor of arts degree in mass communication from the Private Chinese Culture University, Taiwan. She has over 19 years of experience in financial management in multinational corporations. Ms. Meng is the sister-in-law of Dr. Yang.

Independent non-executive Directors

Professor Edward S. Yang, aged 68, received his bachelor of science degree and master of science degree in electrical engineering from National Cheng-Kung University and Oklahoma State University respectively, and his doctorate degree in engineering and applied science from Yale University. Professor Yang is currently the chair professor of the department of microelectronics at the University of Hong Kong, the founder and director of the Jockey Club MRI Centre and also a director of the e-Business Technology Institute. Specialising in semiconductor devices, Professor Yang has published over 180 papers and 2 books.

Mr. Chan Ting-Fung Tim, aged 57, holds a bachelor of science degree in Chemistry from Loyola University and received his master of science degree in Management from Massachusetts Institute of Technology Sloan School in 1975. He is at present a director of Chase Consulting Company Limited with focus on venture capital investment and sales and marketing management consultancy in the high-tech industry.

Mr. Lo I-Wang, aged 51, was appointed as independent non-executive director in September 2004.
