The accumulated losses of the Group include accumulated losses of HK\$34,379,000 (2003: HK\$85,582,000) attributable to associates of the Group.

Capital reserve of the Group consists primarily capital reserve of the Company amounting to HK\$1,800,000,000 which was created through the reduction of the Company's share premium account on 29 November 1993, as approved by the Supreme Court of Hong Kong.

Enterprise expansion fund and statutory reserve fund, which are non-distributable, are appropriated from the profit after taxation of the Company's subsidiaries and associates under the applicable laws and regulations in the People's Republic of China (other than Hong Kong).
