## **EXECUTIVE DIRECTORS**

**Mr. XU, Lian Guo**, aged 43, is the chairman and the founder of the Group. Mr. Xu has more than 20 years 'experience in the automobile maintenance and repair industry and has established Zhongda Machinery in 1993. Mr. Xu was appointed as a consultant in the professional service centre of the Ministry of Personnel (國家人事部專家服務中心) and the academic society. Mr. Xu is responsible for the management of the board as well as the formulation of the Group's strategic objectives and corresponding policies. Mr. Xu is the brother of Mr. Xu Lian Kuan.
