



28 February	The first 50MW thermal power co-generation unit of China Resources (Luoyang) Thermal Power Co., Ltd. ("CR Luoyang") commenced commercial operation. CR Luoyang is 51% held by CR Power.
29 April	The second 50MW thermal power co-generation unit of CR Luoyang commenced commercial operation.
11 June	The first 300MW unit of China Resources (Xuzhou) Electric Power Co., Ltd., Phase II ("CR Xuzhou Phase II") commenced commercial operation. CR Xuzhou Phase II is 35% held by CR Power.
17 July	The first 300MW unit of China Resources Power Dengfeng Co., Ltd. ("CR Dengfeng") commenced commercial operation. CR Dengfeng is 85% held by CR Power.
27 July	The first 300MW unit of China Resources Power Hubei Co., Ltd. ("CR Hubei") commenced commercial operation. CR Hubei is 100% held by CR Power.
16 September	The feasibility studies for the two 600MW super-critical coal-fired generation units of China Resources Power Henan Shouyangshan Co., Ltd. ("CR Shouyangshan") was approved by the State Council. CR Shouyangshan is 80% held by CR Power.
28 September	The second 300MW unit of CR Dengfeng commenced commercial operation.
30 September	The second 300MW unit of CR Xuzhou Phase II commenced commercial operation.
16 November	CR Power signed a medium-to-long term coal supply agreement with Shaanxi Coal Group Company ("Shaanxi Coal"), whereby Shaanxi Coal will supply CR Power with high-quality thermal coal amounting to 4.5 million tonnes, 5 million tonnes and 8.33 million tonnes for a 3-year period from 2005 to 2007.
17 November	The second 300MW unit of CR Hubei commenced commercial operation.
26 November	CR Power completed the transaction in relation to the acquisition of a 29% equity interest in Phase I and the right to develop and own 51% equity interest in Phase II of Guangdong Xingning Xinda Power Co., Ltd. ("Xingning Power Plant"). Xingning Power Plant Phase I consists of two 135 MW coal-fired generation units, while two 300MW coal-fired generation units are planned for Phase II.
16 December	CR Power signed a medium-to-long term coal supply agreement with Gansu Huating Coal Co., Ltd. ("Huating Coal"), whereby Huating Coal will supply CR Power with high-quality thermal coal amounting to 2 million tonnes, 3 million tonnes and 4 million tonnes for a three-year period from 2005 to 2007.
29 December	The first 60MW unit of Yixing China Resources Thermal Power Co., Ltd. ("CR Yixing") commenced commercial operation. CR Power invested in CR Yixing in March 2004, which is 55% held by CR Power.
