2. Remuneration of directors, supervisors and senior management

The remuneration paid to the directors and supervisors for the Reporting Period was approved at the 2003 Annual General Meeting of the Company in accordance with the working plan of the board of the Company for the year approved by the general meeting of shareholders. The remuneration paid to the senior management was approved by the board meeting of the Company in accordance with the working plan for the year approved by the board.
