The directors (the "Directors") of VST Holdings Limited (the "Company") are pleased to present their annual report together with the audited accounts of the Company and its subsidiaries (collectively referred to as the "Group") for the year ended 31st March 2005.

PRINCIPAL ACTIVITIES

The Company is an investment holding company. Its subsidiaries are principally engaged in the distribution of information technology ("IT") products.

The Group is operating in a single business segment of distribution of IT products and all of the sales of the Group's inventories are concluded in Hong Kong. Therefore, no analysis on turnover and contributions to profit before taxation by principal activity and by geographical location for the year ended 31st March 2005 of the Group is presented in this report.

MAJOR CUSTOMERS AND SUPPLIERS

The largest customer for the year ended 31st March 2005 represented approximately 25% (2004: 23%) of the Group's total turnover, and the combined total of the five largest customers accounted for approximately 60% (2004: 42%) of the Group's total turnover for the year.

In addition, the largest supplier for the year ended 31st March 2005 represented approximately 79% (2004: 76%) of the Group's total purchases, and the combined total of the five largest suppliers accounted for approximately 99% (2004: 99%) of the Group's total purchases for the year.

None of the directors, their associates or any shareholder (which to the knowledge of the directors owns more than 5% of the company's share capital) had an interest in the major suppliers or customers noted above.

RESULTS AND APPROPRIATIONS

The results of the Group for the year are set out in the consolidated profit and loss account on page 33.

The directors declared an interim dividend of HK0.5 cents per ordinary share, totalling HK\$3,500,000, which was paid on 21st December 2004.

The directors recommend the payment of a final dividend of HK0.7 cents per ordinary share totalling HK\$5,880,000 for the year under review (2004: HK\$4,200,000) to be declared at the forthcoming annual general meeting. Subject to the approval at the annual general meeting, the final dividend will be payable on or about 18th August 2005 to shareholders whose names appear on the register of members of the Company at the close of business on 8th August 2005. The register of members of the Company will be closed from 9th August 2005 to 12th August 2005, both days inclusive during which no transfer of shares will be effected.

RESERVES

Movements in the reserves of the Group and of the Company during the year are set out in note 13 to the accounts.

DONATIONS

Charitable and other donations made by the Group during the year amounted to approximately HK\$2,000.

FIXED ASSETS

Details of the movements in fixed assets of the Group are set out in note 3 to the accounts.

SUBSIDIARIES

Particulars of the Company's subsidiaries are set out in note 6 to the accounts.

BANK LOANS

Particulars of the Group's bank loans as at 31st March 2005 are set out in note 8 to the accounts.

SHARE CAPITAL

Details of the movements in share capital of the Company are set out in note 11 to the accounts.

DISTRIBUTABLE RESERVES

At 31st March 2005, the Company's reserves available for distribution amounted to approximately HK\$29,138,000 (2004: HK\$442,000). In addition, the Company's share premium account, in the amount of HK\$32,094,000 (2004: HK\$26,926,000), may be distributed in the form of fully paid bonus shares in accordance with the Companies Law (revised) of the Cayman Islands.

PRE-EMPTIVE RIGHTS

There is no provision for pre-emptive rights under the Company's Articles of Association and there is no restriction against such rights under the laws of the Cayman Islands.

PURCHASE, SALE OR REDEMPTION OF SECURITIES

The Company has not redeemed any of its shares during the year. Neither the Company nor any of its subsidiaries has purchased or sold any of the Company's shares during the year.

SHARE OPTIONS

Under the terms of the Company's share option scheme approved by the shareholders on 17th April 2002 (the "Share Option Scheme"), the Board of Directors may, at their discretion, invite employees (including both full time and part time employees, and executive Directors), non-executive Directors, suppliers, customers and other corporations or individuals that provide support to the Group (as defined in the Share Option Scheme) to take up options to subscribe for shares in the Company. The maximum number of shares in respect of which options may be granted under the Share Option Scheme may not exceed 10% of the issued share capital of the Company. The scheme became effective upon the listing of the Company's shares on 9th May 2002. No options have been granted to the Directors up to the date of this report.

Save as disclosed above, at no time during the year was the Company or any of the companies comprising the group, a party to any arrangements to enable the Directors of the Company to acquire benefits by means of the acquisition of shares in, or debenture of, the Company or any other body corporate and none of the Directors, their spouses or their children under the age of 18, had any right to subscribe for the securities of the Company, or had exercised any such right during the year.

Each of the executive Directors has entered into a service contract with the Company for a term of two years commencing from 9th May 2002 and expiring on 8th May 2004, renewable automatically for successive years of one year each commencing from the day immediately after the expiry of the then current term of the directors' appointment, unless terminated by not less than 6 months' notice in writing served by either party on the other. Under the service contracts, the initial annual emoluments of each executive Director is fixed and the remuneration payable to each of them will be reviewed by the Board of Directors each year.

Under the service contracts, each of the executive Director is subject to a restrictive covenant not to engage in business similar to or the same as that carried by the Group within one year after the termination of the service contract. However, the Company shall compensate the executive Director by payment of a maximum sum equals to the remuneration payable to the executive Director for that restrictive period if the Company terminates the service contract other than, among others, by reason of any default of the executive Director.

Non-executive Directors

Madam Sun Ali's appointment as a non-executive Director has been extended by one year commencing from 9th May 2005 to 8th May 2006, whereas Mr. Ni Zhenwei's appointment as an independent non-executive Director has been extended by one year commencing from 1st June 2005 to 31st May 2006. Dr. Chan Po Fun Peter and Mr. Hu Yebi were appointed as independent non-executive Directors of the Company effective from 16th April 2005 and 9th May 2005 respectively for a fixed period of 1 year. Dr. Chan Po Fun Peter and Mr. Hu Yebi shall hold office until the next following annual general meeting of the Company and shall be eligible for re-election.

Save as disclosed above, no Director has an unexpired service contract which is not terminable by the Company or any of its subsidiaries within one year without payment of compensation, other than normal statutory obligations.

On 29th March 2004, the Group entered into a rental agreement with Mr. Li Jialin, the Chairman and an executive Director of the Company, in respect of a director quarter. Pursuant to the agreement, the Group paid a monthly rental of HK\$80,000 to Mr. Li Jialin for a term of 12 months from 1st April 2004 to 31st March 2005.

The above constituted a connected transaction under the Listing Rules. The Company's audited results for the year ended 31st March, 2005 have been reviewed by the audited committee who was of the opinion that the preparation of such results complied with the applicable accounting standards and requirements and that adequate disclosures have been made.

AUDITORS

The accounts of the Group for the year ended 31st March 2005 have been audited by PricewaterhouseCoopers who retire and, being eligible, offer themselves for re-appointment.
