1. RESULTS

For the period from 1st January to 31st December 2004 (the "Year"), the Group recorded revenue from principal activities of RMB35,312,000 and loss after taxation and minority interests of RMB194,995,000, representing a decrease of approximately RMB133,804,000 and a decrease of approximately RMB212,828,000 respectively when compared with the results for 2003 (the "Previous Year"). Main reasons for the deteriorated results are set out in "Chairman's Statement" and "Management Discussion and Analysis".
