#### EXECUTIVE DIRECTORS

**Mr. Li Tung Lok**, aged 53, is the founder and Chairman of the Group. He has a B. Sc. degree in Chemical Engineering and over 25 years of experience in servicing the semiconductor industry.

**Mr. Cheng Hoi Tao, Henry**, aged 59, is the Vice President of Operations. He has 25 plus years of experience in Accounting and Finance. He had overseas accounting experience in Indonesia and Nigeria while he was with other companies. He has been with the Group since 1985.

#### INDEPENDENT NON-EXECUTIVE DIRECTORS

**Mr. Robert Charles Nicholson**, aged 49, was appointed as an independent non-executive director of the Company in October 1994.

He qualified as a solicitor in England and Wales in 1980 and in Hong Kong in 1982. He was a senior partner of Richards Butler from 1985 to 2001 where he established the corporate and commercial department. He has had wide experience in corporate finance and cross-border transactions, including mergers and acquisitions, regional telecommunications, debt and equity capital markets, corporate reorganizations and privatization of state-owned enterprises in the PRC.

He was a senior advisor to the Board of Directors of PCCW Limited between August 2001 and September 2003. He is an independent non-executive director of Pacific Basin Shipping Limited and an executive director of First Pacific Company Limited, a Hong Kong-based and Hong Kong-listed and investment management company with principal business interests related to telecommunications and consumer food products. He also serves as a Commissioner of First Pacific's subsidiary in Indonesia, PT Indofood Sukses Makmur Tbk.
