As at 31 December 2005, the Group employed over 1,500 staff around the globe. - 357,813,876 shares and 66,054,182 warrants were held by Lawnside International Limited ("Lawnside"). Lawnside is beneficially wholly owned by Mr. Paul Kan Man Lok. As at 31 December 2005, Lawnside had interests in approximately 28.00% of the entire interest of the Company. Mr. Paul Kan Man Lok was deemed to have corporate interest in the shares which were owned by the Company and Lawnside. The warrants were issued by the Company pursuant to a bonus issue effected in February 2005, all of which expired on 16 February 2006.

2. 1,419,690,962 shares were held by the Company and 407,779,752 shares were held by Lawnside.
3. 117,300,000 shares were held by the Company and 2,669,171 shares were held by Lawnside.
