Mr. Liu Chen Wei, Jerry, aged 56, is the Chief Executive Officer and a former Chairman and executive director of the Company with 25 years experience in the Scania distribution and service business. Mr. Liu cofounded Forefront International Limited in 1980, and successfully developed the Scania distributorship business initially in Taiwan, subsequently expanding into Hong Kong, Macau and the Peoples Republic of China. As former Chairman of the Company, Mr. Liu was responsible for the group business strategy and planning activities, as well as liaising with Scania senior management. Mr. Liu graduated from Fu Jen Catholic University majoring in business administration and marketing. Mr. Liu spent 3 years as General Manager of two Taiwanese electronic component export companies - Bona Enterprise and CS&L International before joining Forefront in 1980. Mr. Liu was instrumental in developing the Scania franchise in Taiwan, and subsequently into the Greater China region. Mr. Liu resigned as Chairman of the Company in 4 July 2003, and as a director in 25 February 2004. Since 2003, Mr. Liu has been advising Scania on strategic planning and business development in China as a member of the Scania China Council.
