EXECUTIVE DIRECTORS

Mr. CHENG Chi Tai, aged 62, Chairman of the Company. Mr. Cheng has been in the knitwear business since the 1960's and is the founder of the Group. Mr. Cheng is responsible for strategic planning and formulating the Group's overall business development strategy and corporate policies.
