### **Directors of the Company**

The Board comprises the following persons:

#### **Executive Director**

Mr. Wang Chun Lin, aged 54, is presently the Chairman of the Board of Directors of the Company. He is responsible for formulating company's policies, supervising the daily operation, identifying target companies for investment and coordinating portfolio management and investor communication tasks of the Group. Mr. Wang graduated from Fudan University (復旦大學). He has extensive experience in the trading and production of electronic products, research and development on computer software and marketing in the PRC. He was the Managing Director of Beijing Hwa Meng Enterprises Company (北京華盟實業公司), a property investment and development company in the PRC.

#### **Non-executive Directors**

Mr. Luk Cheong, aged 42, was appointed as a non-executive director of the Company on 29 October 2002. Mr. Luk holds a bachelor's degree in Civil and Construction Engineering from South China University of Technology Civil Engineering in China in July 1986. He had been the Director, the President Assistant and other positions during that period of time. His main duties include administrative management, coordinating governmental department relationships, assisting president in decision making and operations. #### **Independent Non-executive Directors**
