REMUNERATION COMMITTEE

According to the Code on Corporate Governance Practices, the Group shall set up a Remuneration Committee with a majority of the members being Independent Non-executive Directors. The Remuneration Committee shall consult the Chairman and/or the General Manager of the Group about their proposals relating to remuneration package and other human resources issues of the directors of the Company and senior management of the Group. The emoluments of directors of the Company are based on each director's skill, knowledge and involvement in the Group's affairs, with reference to the Group's performance and profitability, remuneration benchmark in the industry and the prevailing market conditions.
