### **EXECUTIVE DIRECTORS**

Mr. Chiu Yeung, aged 33, was appointed as an executive director of the Company on 25 February 2002 and currently he is also a director of certain subsidiaries of the Group. ### INDEPENDENT NON-EXECUTIVE DIRECTORS
