Board of Directors

Executive Directors Mr. KONG Qingping Chairman and Chief Executive

Mr. QU Yonghai

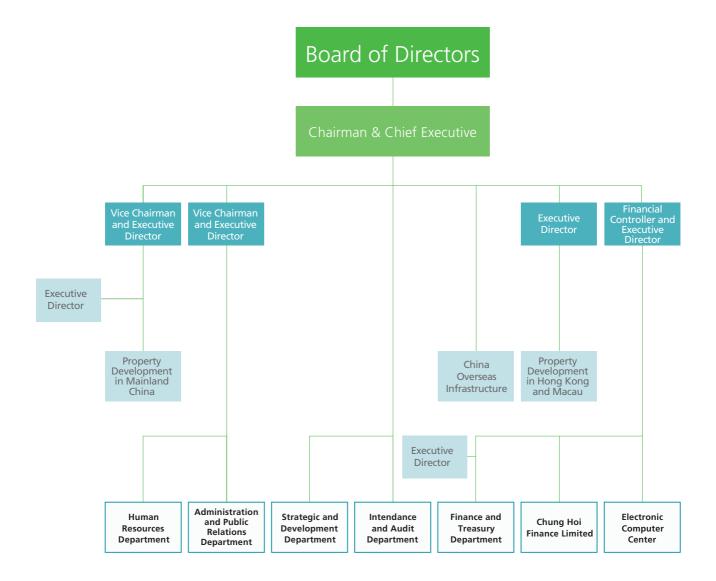
