### *Chief Executive*

Mr. Cheung, aged 49, has been Chief Executive and an Executive Director of Titan since July 2004. He is also a director of certain subsidiaries of the Company. Prior to joining the Company, he was the Chief Executive Officer of Camelot Asset Management Limited (1999–2004) and Chief Executive Officer of Fortune Oil Plc (1994–1999). He is currently a non-executive director of Hong Kong's Urban Renewal Authority and chairman of its Finance Committee, member of the Independent Police Complaints Council and member of the Standing Committee on Disciplined Services Salaries & Condition of Service.

His other public services have included chairmanship of the Corruption Prevention Advisory Committee of Hong Kong's Independent Commission Against Corruption and full-time membership in the Hong Kong Government's Central Policy Unit (1993–1994) on secondment from McKinsey & Company.

While with McKinsey & Company in Los Angeles and Hong Kong from 1987 to 1994, Mr Cheung advised major financial institutions in the United States and Asia.
