Mr. WANG Guanghao, aged 68, has been the Chairman and Executive Director of the Company since June 1997. He is also the chairman of Tsinlien Group Company Limited ("Tsinlien"). He is the non-executive director of Dynasty Fine Wines Group Limited ("Dynasty") (stock code 828), the listed associated company of the Company and also the chairman and non-executive director of Tianjin Port Development Holdings Limited ("TPD") (stock code 3382), the listed subsidiary of the Company, both companies are listed on The Stock Exchange of Hong Kong Limited (the "Stock Exchange"). Mr. Wang graduated from Tianjin Mechanical Engineering Institute in 1962. He is a senior engineer.
