EXECUTIVE DIRECTORS

Mr. Wang An Kang, aged 44, has been engaging in the phosphorus industry through the import and export of phosphorus products since 1990. Mr. Wang became an executive director of the Company in July 2005. In 1999, he restructured several state-owned enterprises on the verge of bankruptcy into Yunnan Phosphorous Group Co. Ltd. ("Yunphos") and is currently the controlling shareholder holding over 51% equity interest in Yunphos. The remaining two shareholders of Yunphos are two of its directors. Over the last 14 years, Yunphos (including its predecessors) has evolved into a vertically integrated company engaged in the development, manufacturing, import and export of phosphorus products. With Mr. Wang's continuous efforts in exploring the international market. Yunphos has built strong relationships with numerous long-term international customers in Europe, America, Australia, Japan and South East Asia. He is currently the vice chairman of the Federation of Industry & Commerce of Yunnan Province, the vice chairman of the Yunnan Overseas Association and the vice chairman of the Chamber of Commerce for Import and Export of Yunnan Province.
