A. FURTHER INFORMATION ABOUT OUR GROUP

1. Incorporation

Our Company was incorporated in the Cayman Islands as an exempted company with limited liability on October 3, 2007 under the Cayman Companies Law. Our registered address is at the offices of M&C Corporate Services Limited, PO Box 309GT, Ugland House, South Church Street, George Town, Cayman Islands. We have registered a place of business in Hong Kong at Unit 918, Miramar Tower, No.132 Nathan Road, Kowloon, Hong Kong and have been registered as a non-Hong Kong company under Part XI of the Hong Kong Companies Ordinance. Mr. Tsai Ming Hui has been appointed as our agent for the acceptance of service of process and notices in Hong Kong. The address for service of process on the Company in Hong Kong is the same as its registered place of business in Hong Kong set out above. As we are incorporated in the Cayman Islands, our corporate structure, our Memorandum of Association and Articles of Association are subject to the relevant laws of the Cayman Islands. A summary of the relevant provisions of our Memorandum of Association and Articles of Association and certain relevant aspects of Cayman Islands company law are set out in Appendix V to this prospectus.

2. Changes in share capital of our Group

The Company

As at the date of our incorporation, the authorized share capital of the Company was US\$600,000,000 divided into 3,000,000,000 Shares of par value of US\$0.20 each. The following sets out the changes in the Company's issued share capital since the date of its incorporation:

- (e) on October 31, 2007, 10,000,000 ordinary shares of US\$0.20 each were allotted and issued, credited as fully paid to Twitcher Limited;
- (f) on October 31, 2007, 10,000,000 ordinary shares of US\$0.20 each were allotted and issued credited as fully paid to ThemePark Dome Limited;
- (g) on October 31, 2007, 10,000,000 ordinary shares of US\$0.20 each were allotted and issued, credited as fully paid to Finance Plus Limited;
- (h) on October 31, 2007, 10,000,000 ordinary shares of US\$0.20 each were allotted and issued, credited as fully paid to Sealand Logistics Solution Limited;

- (q) on October 31, 2007, 556,114 ordinary shares of US\$0.20 each were allotted and issued, credited as fully paid to Chen Daniel, which were transferred to Wealth Harvest Services International Ltd on the same date;
- (r) on November 6, 2007, 2,248,575 ordinary shares of US\$0.20 each were allotted and issued, credited as fully paid to Norwares Overseas Inc;
- (s) on December 12, 2007, 39,889,942 and 46,384,528 ordinary shares of US\$0.20 each were transferred by Norwares Overseas Inc. to Nidaro Group Limited and Jairren Holdings Limited respectively;
- (t) on December 12, 2007, 6,494,586 ordinary shares of US\$0.20 each were transferred by Peng Yu-Man to Nidaro Group Limited;
- (u) on January 11, 2008, 5,922,949 ordinary shares of US\$0.20 each were transferred by Norwares Overseas Inc. to Jairren Holdings Limited; and
- (v) on February 4, 2008, each share in the capital of the Company of US\$0.20 each were subdivided into 10 shares of par value US\$0.02 each, such that the authorised share capital of the Company is US\$600,000,000 divided into 30,000,000,000 shares of US\$0.02 each.

Assuming that Global Offering becomes unconditional and the Shares are issued our authorized share capital upon completion of the Global Offering will be US\$600,000,000 divided into 30,000,000 shares of US\$0.02 each.

Save as disclosed in this Appendix, there has been no alteration in the Company's share capital since the date of our incorporation.

Our subsidiaries

The list of our subsidiaries is set out in the section headed "Appendix I — Accountant's Report" to this prospectus. The following alterations in the share capital (or registered capital, as the case might be) of our subsidiaries have taken place within two years preceding the date of this prospectus:

Tongchuan Rimalt Foods Ltd

— On 31 August 2007, the registered capital of Tongchuan Rimalt Foods Ltd (銅川瑞麥食品有限公司) was increased from US\$1,750,000 to US\$3,250,000. The registered capital of Tongchuan Rimalt Foods Ltd was fully paid up.

Tongchuan Want-Want Foods Ltd

— On June 12, 2007, the registered capital of Huaian Want Want Foods Ltd (淮安旺旺食品有限公司) was increased from US\$2,100,000 to US\$10,100,000. The registered capital of Huaian Want Want Foods Ltd was fully paid up.

Chengdu Ming-Want Dairy Ltd

— On May 12, 2006, the registered capital of Chengdu Ming-Want Dairy Ltd (成都明旺乳業有限公司) was increased from US\$7,000,000 to US\$9,700,000. The registered capital of Chengdu Ming-Want Dairy Ltd was fully paid up.

Save as described above, there has been no other alteration in the share capital of the subsidiaries of the Company in the two years preceding the date of this prospectus.

3. Resolutions of our shareholders

Pursuant to the extraordinary general meeting held on February 4, 2008, our shareholders resolved that:

- (a) each share in the capital of the Company of US\$0.20 each were sub-divided into 10 shares of par value US\$0.02 each, such that the authorized share capital of the Company is US\$600,000,000 divided in 30,000,000,000 shares of US\$0.02 each;
- (b) conditional upon the conditions for completion of the Global Offering being fulfilled, our Company approved and adopted its new Memorandum and Articles of Association, the terms of which are summarized in Appendix V to this prospectus;
- (c) conditional upon the conditions for completion of the Global Offering being fulfilled:
 - (i) that conditional upon (i) the Listing Committee of the Hong Kong Stock Exchange granting the listing of, and permission to deal in, the Shares in issue and to be issued as mentioned in this prospectus, and (ii) the obligations of the Underwriters under the Hong Kong Underwriting Agreement and the International Placing Agreement becoming unconditional and not being terminated in accordance with the terms of the Hong Kong Underwriting Agreement and the International Placing Agreement or otherwise, in each case on or before the date falling 30 days after the date of this prospectus:
 - (1) the Global Offering and the directors were authorized to allot and issue, and to approve the transfer of, such number of Shares in connection with the Global Offering and any exercise of the Over-allotment Option as they are fit, on and subject to the terms and conditions stated in this prospectus and in the relevant Application Forms;
 - (2) conditional further on the Listing Committee of the Hong Kong Stock Exchange granting approval of our Share Option Schemes, the rules of our Share Option Schemes were approved and adopted, and the directors or any committee thereof established by the board were authorized, at their sole discretion, to make such further changes to our Share Option Schemes as requested by the Hong Kong Stock Exchange and which they deem necessary and/or desirable and

at their absolute discretion to grant options to subscribe for Shares thereunder up to the limits referred to in our Share Option Schemes and or allot, issue and deal with Shares pursuant to the exercise of any option which may be granted under our Share Option Schemes and to take all such action as they consider necessary, desirable or expedient to implement or give effect to our Share Option Schemes, subject to the conditions therein;

- (3) a general unconditional mandate was given to the directors to allot, issue and deal with Shares (otherwise than pursuant to, or in consequence of, the Global Offering, a rights issue or pursuant to the exercise of any subscription rights which may be granted under our Share Option Schemes or any scrip dividend scheme or similar arrangements, any adjustment of rights to subscribe for shares under options and warrants or a special authority granted by our shareholders) with an aggregate nominal value of not more than the sum of:
 - 20% of the aggregate nominal value of our share capital in issue immediately following completion of the Global Offering before any exercise of the Over-allotment Option; and
 - the aggregate nominal value of the share capital of our Company repurchased by us (if any);
- (4) a general unconditional mandate was given to the directors to exercise all the powers of the Company to repurchase Shares to be listed on the Hong Kong Stock Exchange with a total nominal value of not more than 10% of the aggregate nominal value of the Company's Share capital in issue immediately following completion of the Global Offering before any exercise of the Overallotment Option; and
- (5) the general unconditional mandate as mentioned in paragraph (3) above was extended by the addition to the aggregate nominal value of the Shares which may be allotted and issued or agreed to be allotted and issued by the directors pursuant to such general mandate of an amount representing the aggregate nominal value of the Shares purchased by the Company pursuant to the mandate to repurchases Shares referred to in paragraph (4) above.

Each of the general mandates referred to in paragraphs (3), (4) and (5) above will remain in effect until whichever is the earliest of (i) the conclusion of the next annual general meeting of the Company; (ii) the expiration of the period within which the next annual general meeting of the Company is required to be held by any applicable law or the Articles of Association of the Company; or (iii) the time when such mandate is revoked or varied by an ordinary resolution of the shareholders of the Company in a general meeting.

4. Repurchases of our own Shares

This section includes information relating to the repurchase of our Shares, including information required by the Hong Kong Stock Exchange to be included in this prospectus concerning such repurchase.

(a) Relevant Legal and Regulatory Requirements
The Listing Rules permit our shareholders to grant to our directors a general mandate to repurchase our Shares that are listed on the Hong Kong Stock Exchange. Such mandate is required to be given by way of an ordinary resolution passed by our shareholders in a general meeting.

(b) Shareholders' Approval

All proposed repurchases of Shares (which must be fully paid up) must be approved in advance by ordinary resolutions of our shareholders in a general meeting, either by way of general mandate or by specific approval of a particular transaction.

On February 4, our Directors were granted a general unconditional mandate to repurchase up to 10% of the aggregate nominal value of the share capital of our Company in issue immediately following completion of the Global Offering on the Hong Kong Stock Exchange or on any other stock exchange on which our securities may be listed and which is recognized by the SFC and the Hong Kong Stock Exchange for this purpose before any exercise of the Over-allotment Option. This mandate will expire at the earliest of (i) the conclusion of our next annual shareholders' general meeting, (ii) the date by which our next shareholders' general meeting is required by applicable laws and our Articles of Association to be held, or (iii) such mandate being revoked or varied by ordinary resolutions of our shareholders in a general meeting (the "Relevant Period").

(c) Source of Funds

Our repurchase of the Shares listed on the Hong Kong Stock Exchange must be funded from the funds legally available for the purpose in accordance with our Memorandum of Association and Articles of Association and the applicable laws of the Cayman Islands. We may not repurchase our Shares on the Hong Kong Stock Exchange for consideration other than cash or for settlement otherwise than in accordance with the trading rules of the Hong Kong Stock Exchange. Subject to the foregoing, we may make repurchases with funds which would otherwise be available for dividend or distribution or out of an issue of New Shares for the purpose of the repurchase.

(d) Reasons for Repurchases

Our Directors believe that it is in the Company and our Shareholders' best interests for our directors to have general authority to execute repurchases of our Shares in the market. Such repurchases may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the net asset value per Share and/or earnings per Share and will only be made where our Directors believe that such repurchases will benefit the Company and our Shareholders.

(e) Funding of Repurchases

In repurchasing securities, we may only apply funds legally available for such purpose in accordance with our Memorandum of Association and Articles of Association, the applicable laws of the Cayman Islands and the Listing Rules.

On the basis of the current financial position of our Company as disclosed in this prospectus and taking into account the current working capital position of our Company, our directors believe that, if the repurchase mandate were to be exercised in full, it might have a material adverse effect on our working capital and/or the gearing position as compared with the position disclosed in this prospectus. However, our directors do not propose to exercise the repurchase mandate to such an extent as would, in the circumstances, have a material adverse effect on the working capital requirements of our Company or the gearing levels which in the opinion of our directors are from time to time appropriate for us.

(f) Share Capital

The exercise in full of the current repurchase mandate, on the basis of 13,252,722,750 Shares in issue immediately after completion of the Global Offering, could accordingly result in up to 1,325,272,275 Shares being repurchased by us during the Relevant Period.

(g) General

None of our directors nor, to the best of their knowledge having made all reasonable enquiries, any of their associates (as defined in the Listing Rules) currently intends to sell any of our Shares to us or our subsidiaries.

Our directors have undertaken to the Hong Kong Stock Exchange that, so far as the same may be applicable, they will exercise the repurchase mandate in accordance with the Listing Rules, our Memorandum of Association and Articles of Association, the Cayman Islands Companies Law and any other applicable laws of the Cayman Islands.

If, as a result of any repurchase of our Shares, a shareholders' proportionate interest in our voting rights is increased, such increase will be treated as an acquisition for the purposes of the Hong Kong Code on Takeovers and Mergers. Accordingly, a shareholder or a group of Shareholders acting in concert could obtain or consolidate control of us and become obliged to make a mandatory offer in accordance with rule 26 of the Hong Kong Code on Takeovers and Mergers. Our directors are not aware of any consequences of repurchases which would arise under the Hong Kong Code on Takeovers and Mergers.

No connected person as defined by the Listing Rules has notified us that he or it has a present intention to sell his or its Shares to us, or has undertaken not to do so, if the repurchase mandate is exercised.

D. PRE-IPO SHARE OPTION SCHEME

Summary of Terms

The purpose of the Pre-IPO Share Option Scheme is to provide the Company with a means of incentivising and retaining employees, and to encourage Employees to work towards enhancing the value of the Company and promote the long-term growth of the Company. This Scheme will link the value of the Company with the interests of participants, enabling participants and the Company to develop together and promoting the Company's corporate culture. The material terms of the Pre-IPO Share Option Scheme, approved by the Shareholders at an extraordinary general meeting held on February 4, 2008, are substantially the same as the terms of the Share Option Scheme except that:

- (a) the exercise price per Share under the Pre-IPO Share Option Scheme shall be at the Offer Price;
- (b) the total number of Shares which may be issued upon the exercise of all options granted under the Pre-IPO Share Option Scheme is 50,362,400 Shares representing approximately 0.38% of the enlarged issued share capital of our Company immediately after completion of the Global Offering;
- (c) each option has a 4-year exercise period with 25% vesting on each of March 26, 2009, 2010, 2011 and 2012; and
- (d) save for the options which have been granted, no further options will be granted on or after the Listing Date, as the right to do so will end upon the listing of our Shares on the Stock Exchange.

Application has been made to the Listing Committee of the Stock Exchange for the approval of the listing of and permission to deal in the 50,362,400 Shares to be issued pursuant to the exercise of the options granted under the Pre-IPO Share Option Scheme.

Outstanding Options Granted

As at the date of this prospectus, options to subscribe for an aggregate of 50,362,400 Shares (representing approximately 0.38% of the enlarged issued share capital of our Company immediately after completion of the Global Offering) at an exercise price equal to the Offer Price have been conditionally granted to 1,637 participants by our Company at a consideration of HK\$1.00 under the Pre-IPO Share Option Scheme. All the options under the Pre-IPO Share Option Scheme were granted on February 4, 2008 and no further options will be granted under the Pre-IPO Share Option Scheme prior to the Listing Date.

Out of the 50,362,400 Shares to be issued upon the exercise of all the options granted under the Pre-IPO Share Option Scheme, options representing 322,800 Shares were granted to four Directors of the Company, options representing 757,600 Shares were granted to nine senior management of the Company and options representing 49,282,000 Shares were granted to 1,624 other employees of the Group. The 1,624 other employee grantees under the Pre-IPO Share Option Scheme did not include any connected person of the Company.

Assuming that all of the outstanding options granted under the Pre-IPO Share Option Scheme were exercised in full on the Listing Date, the shareholding interest of the public would be increased from approximately 25.38% to approximately 25.66% of the total issued share capital of our Company immediately after completion of the Global Offering, assuming that the Over-allotment Option is not exercised. All the options under the Pre-IPO Share Option Scheme will not be exercisable within the first twelve months after the Listing Date. The Directors will not exercise any options if as a result of which our Company will not be able to comply with the public float requirements of the Listing Rules.

The exercise price for the options set out in the table above is at the Offer Price. The number of options granted to each grantee under the Pre-IPO Share Option Scheme was determined by the Board at the time of grant based upon a number of factors including the length of service and performance of the grantees, the requirement that our Shares be listed on a recognized stock exchange before the options could be exercised and an estimate of the likely period before which any such listing would occur.

The options issued under the Pre-IPO Share Option Scheme represent approximately 0.38% of our enlarged share capital as at the Listing Date. If all options are exercised, this would have a dilutive effect on our Shareholders of approximately 0.38% and a dilutive effect of approximately 0.38% on earnings per Share. However, as the options are exercisable from the first to fifth anniversary of the Listing Date, any such dilution and impact on earnings per Share will be staggered over several years. No further options will be granted under the Pre-IPO Share Option Scheme after the Listing Date.

Waiver from the Stock Exchange and exemption from the SFC

Under Rule 17.02(1)(b) of the Listing Rules and item 27 of Appendix 1A and paragraph 10(d) of Part I of the Third Schedule to the Hong Kong Companies Ordinance, this prospectus is required to include details of the number, description and amount of any of our Shares which a person has, or is entitled to be given, an option to subscribe for, together with certain particulars of each option, namely the period during which it is exercisable, the price to be paid for Shares subscribed for under it, the consideration (if any) given or to be given for it or for the right to it and the names and addresses of the persons to whom it was given. We have granted options to 1,637 persons to subscribe for 50,362,400 Shares on the terms set out in the table in this section.

We have applied for (i) a waiver from the Hong Kong Stock Exchange from strict compliance with the disclosure requirements under Rule 17.02(1)(b) and paragraph 27 of Appendix IA to the Listing Rules and (ii) an exemption from the SFC from strict compliance with the disclosure requirements of paragraph 10(d) of Part I of the Third Schedule to Hong Kong Companies Ordinance on the ground that full compliance with these requirements would be irrelevant and unduly burdensome for us for the following reasons:

- (a) in light of the large number of participants involved in the Pre-IPO Share Option Scheme, disclosure of the details of each of participants will require an additional over 150 pages of this prospectus, making this prospectus unnecessarily lengthy, hence strict compliance with the disclosure requirements on an individual basis will be unduly burdensome on the Company;
- (b) the numbers of options granted to individual grantees are, individually, de minimis and therefore irrelevant to investors;
- (c) as the options granted under the Pre-IPO Share Option Scheme are considered a part of the participants' remuneration package, individual information regarding such options is highly sensitive and confidential to the employees concerned;
- (d) options granted to directors of the Company will be disclosed under the section headed "Disclosure of Interest (A) Directors and Chief Executive Officer" in this Appendix;
- (e) the grant and exercise in full of the options granted under the Pre-IPO Share Option Scheme will not cause any material adverse change in the financial position of the Company;
- (f) the non-compliance with the disclosure requirements will not hinder the Company in providing an informed assessment of the activities, assets and liabilities, financial position, management and prospects of the Company to its potential investors; and
- (g) the disclosure of a summary of the information in relation to the options granted under the Pre-IPO Share Option Scheme, as described in this section, should provide potential investors with sufficient information to make a relevant assessment of the Company in their investment decision-making process.

The Hong Kong Stock Exchange has granted the waiver and the SFC has granted the exemption to us on the conditions that:

(a) the full details on an individual basis of the options granted by the Company under the Pre-IPO Share Option Scheme to each of the grantees who is a Director of the Company or senior management of the Company, including all the particulars required under paragraph 10 of Part I of the Third Schedule to the Hong Kong Companies Ordinance (as in relation to the SFC exemption) and Rule 17.02(1)(b) and paragraph 27 of Appendix IA to the Listing Rules (as in relation to the Stock Exchange waiver), are disclosed in this prospectus;

- (b) in respect of the options granted by the Company under the Pre-IPO Share Option Scheme to employees other than those referred to in paragraph (a) above, the following details are disclosed in this prospectus:
 - (i) the aggregate number of grantees and the number of Shares subject to the options;
 - (ii) the consideration paid for the grant of the options; and
 - (iii) the exercise period and the exercise price for the options;
- (c) a full list of all the grantees (including the persons referred to in paragraph (a) above) who have been granted options to subscribe for Shares under the Pre-IPO Share Option Scheme containing all the details as required under Rule 17.02(1)(b) and paragraph 27 of Appendix IA to the Hong Kong Listing Rules (as in relation to the Stock Exchange waiver) and paragraph 10 of Part I of the Third Schedule to the Hong Kong Companies Ordinance (as in relation to the SFC exemption) will be made available for public inspection in accordance with the paragraph headed "Documents Available for Inspection" in Appendix VII to this prospectus;
- (d) a summary of the terms of the Pre-IPO Share Option Scheme are disclosed in this prospectus;
- (e) in relation to the Stock Exchange waiver only, the dilution effect and impact on earnings per Share upon full exercise of the options conditionally granted under the Pre-IPO Share Option Scheme are disclosed in this prospectus; and
- (f) in relation to the Stock Exchange waiver only, the aggregate number of Shares subject to the outstanding options granted by the Company under the Pre-IPO Share Option Scheme and the percentage of the Company's issued share capital of which such number represents are disclosed in this prospectus.

E. SHARE OPTION SCHEME

Summary of principal terms of the Share Option Scheme

The following is a summary of the principal terms of the Share Option Scheme conditionally approved and adopted by the Shareholders at an extraordinary general meeting held on February 4, 2008. The terms of the Share Option Scheme are in accordance with the provisions of Chapter 17 of the Listing Rules.

- 1. The purpose of the Share Option Scheme is to provide the Company with a means of incentivising and retaining employees, and to encourage employees to work towards enhancing the value of the Company and promote the long-term growth of the Company. This Scheme will link the value of the Company with the interests of participants, enabling participants and the Company to develop together and promoting the Company's corporate culture.
- 2. The Directors may, at their discretion, invite any directors (including executive directors, non-executive directors and independent non-executive directors),

employees and officers of any member of our Group and any advisors, consultants, distributors, contractors, contract manufacturers, agents, customers, business partners, joint venture business partners and service providers of any member of our Group who the Board considers, in its sole discretion, have contributed or will contribute to our Group to participate in the Share Option Scheme.

- 3. Initially the maximum number of Shares which may be issued upon exercise of all options to be granted under the Share Option Scheme or any other share option schemes adopted by our Company (and to which the provisions of Chapter 17 of the Listing Rules are applicable) shall not exceed 10% of the aggregate of the Shares in issue on the Listing Date (such 10% limit represents 1,325,272,275 Shares). Options which have lapsed shall not be counted in calculating the 10% limit. However (but subject to the 30% limit referred to in this paragraph below), our Company may refresh this 10% limit with Shareholders' approval provided that each such limit (as refreshed) may not exceed the 10% of the Shares in issue as at the date of the Shareholders' approval. Options previously granted under the Share Option Scheme and any other share option schemes adopted by our Company (and to which the provisions of Chapter 17 of the Listing Rules are applicable) (including those outstanding, canceled or lapsed in accordance with the relevant scheme or exercised options) will not be counted for the purpose of calculating the limit to be refreshed. Our Company may seek separate approval by Shareholders in general meeting for granting options beyond the 10% limit provided that the options in excess of the limit are granted only to participants specially identified by our Company before such approval is sought. The total number of Shares which may be issued upon exercise of all options granted and yet to be exercised under the Share Option Scheme or any other share option schemes adopted by our Company (and to which the provisions of Chapter 17 of the Listing Rules are applicable) must not exceed 30% of the Shares in issue from time to time. On the Listing Date, such 30% represents 3,975,816,825 Shares.
- 4. Unless approved by Shareholders in the manner set out in this paragraph below, the total number of Shares issued and to be issued upon exercise of the options granted to each participant (including both exercised, canceled and outstanding options) under the Share Option Scheme or any other share option scheme adopted by our Company (and to which the provisions of Chapter 17 of the Listing Rules are applicable) in any 12 month period must not exceed 1% of the Shares in issue. Any further grant of options which would result in the number of Shares issued as aforesaid exceeding the said 1% limit must be subject to prior Shareholders' approval with the relevant participant and his associates abstaining from voting.

Each grant of options to any director, chief executive or substantial shareholder of our Company (or any of their respective associates) (as such terms are defined in rule 1.01 of the Stock Exchange Listing Rules) shall be subject to the prior approval of the independent non-executive Directors of our Company (excluding any independent non-executive Director who is a proposed grantee of the option). Where any grant of options to a substantial shareholder or an independent non-executive Director of our Company, or any of their respective associates, would result in the Shares issued and to be issued upon exercise of all options already granted and to be granted (including options exercised, canceled and outstanding) to such person in the 12 month period up to and including the date of such grant:

(a) representing in aggregate over 0.1% (or such other higher percentage as may from time to time be specified by the Stock Exchange) of the Shares in issue;

(b) having an aggregate value, based on the closing price of the Shares as stated in the daily quotations sheets issued by the Stock Exchange on the date of such grant, in excess of HK\$5 million (or such other higher amount as may from time to time be specified by the Stock Exchange), such grant of options shall be subject to prior approval by the Shareholders (voting by way of poll). All connected persons (as defined in the Listing Rules) of our Company shall abstain from voting at such general meeting, except that any connected person may vote against the relevant resolution at the general meeting provided that his intention to do so has been stated in the circular to be sent to the Shareholders in connection therewith.

No offer shall be made and no option shall be granted to any participant in circumstances prohibited by the Listing Rules at a time when the Participant would or might be prohibited from dealing in the Shares by the Listing Rules or by any applicable rules, regulations or law. In particular, during the period commencing one month immediately preceding the earlier of:

- (i) the date of the Board meeting (as such date is first notified to the Stock Exchange in accordance with rule 13.43 of the Listing Rules or such other rule or law for the time in force which applies to our Company) for the approval of our Company's interim or annual results; and
- (ii) the deadline for our Company to publish its interim or annual results announcement under the Listing Rules,

and ending on the date of the results announcement, no option may be granted.

- 5. (a) The period within which the options must be exercised will be specified by our Company at the time of grant. This period must expire no later than 10 years from the relevant date of grant (being the date of which the Board resolves to make an offer of options to the Relevant Grantee).
 - (b) In the event a grantee (being an employee, an officer or a director of any member of our Group) ceases to be an employee, an officer or a director for any reason other than (i) his or her death, (ii) his or her retirement or (iii) on one or more of the grounds of termination of employment, appointment or directorship specified in paragraph 12(f) below, the grantee may exercise the option up to his or her entitlement at the date of cessation (to the extent he or she is entitled to exercise at the date of cessation but not already exercised) on the date of such cessation which date shall be the last actual working day with our Group, whether salary is paid in lieu of notice or not (provided that such exercise is during the relevant option period), failing which it will lapse.
 - (c) In the case where the grantee is an employee, and officer or a director and where the grantee ceases to be an employee, an officer or director of our Group by reason of the termination of his or her employment, appointment or directorship on the grounds that he or she has become insolvent or has made any arrangements or compositions with his or her creditors generally or by reason of actual financial difficulties, the grantee shall only be entitled to exercise the options during the relevant option period up to the entitlement of such grantee as at the date on which such grantee ceased to be an employee or director of our Group (to the extent not already exercised) on the date of such cessation (provided that such exercise is during the relevant option period), failing which it will lapse.

- In the case (1) where the grantee is a business associate under a fixed term contract, if the grantee ceases to be a business associate by reason of termination or expiry of the term of the relevant fixed term contract without any extension or renewal by our Group for reasons other than (i) on one or more of the grounds specified in paragraph 12(f) below, or (ii) on his or her death if the business associate is a natural person, or (2) where the grantee is a business associate not under any fixed term contract, if the grantee ceases to be a business associate by reason of the grantee ceasing to provide any further advisory or consultancy or other kind of services, support, assistance or contribution to our Group as may be determined by the Board and notified to such business associate in writing within one year after the provision of its last services, support, assistance or contribution to our Group for reasons other than (i) on one or more of the grounds specified in paragraph 12(f) below, or (ii) on his or her death if the business associate is a natural person, the grantee may exercise the option up to his or her entitlement at the date of cessation (to the extent he or she is entitled to exercise at the date of cessation but not already exercised) within the period of six months (or such longer period as the Board may determine) following the date of such cessation, which date shall, in the case of (1) above, be the date of expiry of the relevant fixed term contract; and in the case of (2) above, be the date of the aforesaid written notification to the business associate failing which it will lapse.
- (e) In the event the grantee dies before exercising the option in full and none of the events for termination of employment or engagement under paragraph 12(f) below then exists with respect to such grantee, the personal representative(s) of the grantee shall be entitled within a period of six months from the date of death (provided that such exercise is during the relevant option period) to exercise the option up to the entitlement of such grantee as at the date of death (to the extent not already exercised), failing which it will lapse.
- (f) In the event that the date of retirement as decided by the relevant member of our Group falls before the date the grantee exercises the option in full and none of the events for termination of employment or engagement under paragraph 12(f) below then exists with respect to such grantee, the grantee shall be entitled within a period of six months from the date of retirement (provided that such exercise is during the relevant option period) to exercise the option up to the entitlement of such grantee as at the date of retirement (to the extent not already exercised), failing which it will lapse.
- (g) If a general offer by way of voluntary offer, takeover or otherwise (other than by way of scheme of arrangement pursuant to paragraph 5(h) below) is made to all the holders of Shares (or all such holders other than the offeror, any person controlled by the offeror and any person acting in association or concert with the offeror) and such offer becomes or is declared unconditional prior to the expiry date of the relevant option, our Company shall forthwith give notice thereof to the grantee and the grantee shall be entitled to exercise the option to its full extent or, if our Company shall give the relevant notification, to the extent notified by our Company at any time within such period as shall be notified by our Company.
- (h) If a general offer for Shares by way of scheme of arrangement is made to all the holders of Shares and has been approved by the necessary number of holders of Shares at the requisite meetings, our Company shall forthwith give notice thereof to the grantee and the grantee may at any time thereafter (but before such time as shall be notified by our Company) exercise the option to its full extent or, if our Company shall give the relevant notification, to the extent notified by our Company.

- (i) In the event a notice is given by our Company to our Shareholders to convene a Shareholders' meeting for the purpose of considering and, if thought fit, approving a resolution to voluntarily wind-up our Company, our Company shall forthwith give notice thereof to the grantee and the grantee may at any time thereafter (but before such time as shall be notified by our Company) exercise the option to its full extent or, if our Company shall give the relevant notification, to the extent notified by our Company, and our Company shall as soon as possible and in any event no later than three days prior to the date of the proposed shareholders' meeting, allot, issue and register in the name of the grantee such number of fully paid Shares which fall to be issued on exercise of such option.
- (j) In the event of a compromise or arrangement, other than a scheme of arrangement contemplated in paragraph 5(h) above, between our Company and its members and/or creditors being proposed in connection with a scheme for the reconstruction or amalgamation of our Company, our Company shall give notice thereof to all grantees on the same day as it first gives notice of the meeting to its members and/or creditors to consider such a scheme or arrangement and the grantee may at any time thereafter but before such time as shall be notified by our Company exercise the option to its full extent or, if our Company shall give the relevant notification, to the extent notified by our Company, and our Company shall as soon as possible and in any event no later than three days prior to the date of the proposed meeting, allot, issue and register in the name of the grantee such number of fully paid Shares which fall to be issued on exercise of such option.
- (k) Upon the occurrence of any of the events referred to in paragraphs 5(g), (h), (i) and (j) above, our Company may in its discretion and notwithstanding the terms of the relevant option also give notice to a grantee that his or her option may be exercised at any time within such period as shall be notified by our Company and/or to the extent (not being less than the extent to which it could then be exercised in accordance with its terms) notified by our Company. If our Company gives such notice that any option shall be exercised in part only, the balance of the option shall lapse.
- 6. At the time of grant of the options, our Company may specify any minimum period(s) for which an option must be held before it can be exercised. The Share option Scheme does not contain any such minimum period.
- 7. At the time of the grant of the options, our Company may specify any performance target(s) which must be achieved before the options can be exercised. The Share option Scheme does not contain any performance targets.
- 8. The amount payable by a grantee on acceptance of a grant of options is HK\$1.00.
- 9. The subscription price for the Shares the subject of the options shall be no less than the higher of (i) the closing price of the Shares as stated in the daily quotation sheet issued by the Stock Exchange on the date of grant; (ii) the average closing price of the Shares as stated in the daily quotation sheets issued by the Stock Exchange for the five Stock Exchange business days immediately preceding the date of grant; and (iii) the nominal value of a Share on the date of grant.
- 10. The Shares to be allotted and issued upon the exercise of an option shall be subject to all the provisions of the memorandum and articles of association of our Company for the time being in force and will rank pari passu with the fully paid Shares in issue on the date the name of the grantee is registered on the register of members of our Company. Prior to the grantee being registered on the register of members of our

Company, the grantee shall not have any voting rights, or rights to participate in any dividends or distributions (including those arising on a liquidation of our Company), in respect of the Shares to be issued upon the exercise of the option.

- 11. No options may be granted under the Share Option Scheme after the date of the tenth anniversary of the adoption of the Share Option Scheme.
- 12. An option shall lapse automatically and not be exercisable, to the extent not already exercised, on the earliest of:
 - (a) the expiry of the option period;
 - (b) the date or the expiry of the period for exercising the option as referred to in paragraphs 5(b), (e), (f), (g) or (j) above;
 - (c) subject to the scheme of arrangement (referred to in paragraph 5(h) above) becoming effective, the expiry of the period for exercising the option as referred to in paragraph 5(h) above;
 - (d) subject to paragraph 5(i) above, the date of commencement of the winding up of our Company;
 - (e) the date on which the grantee sells, transfers, charges, mortgages, encumbers or creates any interest in favor of any other person, over or in relation to any option in breach of the Share Option Scheme;
 - (f) the date on which:
 - (i) the grantee (being an employee, an officer or a director of any member of our Group) ceases to be an employee, an officer or a director by reason of the termination of his or her employment, appointment or directorship on the grounds that he or she has been guilty of serious misconduct or has been convicted of any criminal offence involving his or her integrity or honesty or on any other ground on which an employer would be entitled to terminate his or her employment summarily;
 - (ii) the grantee being a business associate under any contract with our Group, such contract is terminated by reason of breach of contract on the part of the business associate: or
 - (iii) the grantee being a business associate, appears either to be unable to pay or have no reasonable prospect to be able to pay debts, or has become insolvent, or has made any arrangements or composition with his or her creditors generally, or ceases or threatens to cease to carry on its business, or is wound up, or has an administrator or liquidator being appointed for the whole or any part of its undertaking or assets; or has been convicted of any criminal offence involving integrity or honesty, provided that whether any one or more of the events specified in the above occur in relation to a grantee shall in the reasonable opinion of the Board be solely and conclusively determined by the Board;
 - (g) where the grantee is an employee, an officer, a director or a business associate of a member of our Group (other than our Company), the date on which such member ceases to be a member of our Group;

- (h) unless the Board otherwise determines, and other than in the circumstances referred to in paragraphs 5(b) to 5(k), the date the grantee, ceases to be a participant (as determined by a Board resolution) for any reason; and
- (i) the date on which the option is canceled by the Board.
- 13. In the event of any capitalization issue, rights issue, sub-division or consolidation of shares or reduction of share capital of our Company, but excluding, for the avoidance of doubt, any alteration in the capital structure of our Company as a result of an issue of Shares as consideration in a transaction to which our Company is a party, the Board shall determine what adjustment is required to be made to the subscription price and/or the number of Shares to be issued on exercise of the options, and the auditors or financial advisors engaged by our Company for such purpose shall certify in writing to the Board that such adjustments satisfy the requirements set out in Rule 17.03(13) of the Listing Rules and the note thereto and the supplementary guidance attached to the letter from the Stock Exchange dated September 5, 2005 to all issuers relating to share option schemes (the "Supplemental Guidance").

Any such adjustments shall give the participant the same proportion of the equity capital of our Company (as interpreted in accordance with the Supplemental Guidance) and any adjustments to the advantage of the participants to the exercise price or to the number of Shares subject to the options must be approved by the Shareholders in general meeting, and no adjustment may be made to the extent that Shares would be issued at less than their nominal value. In addition, any adjustment to be made will comply with the Listing Rules, the Supplemental Guidance and any future guidance/interpretation of the Listing Rules issued by the Stock Exchange from time to time.

- 14. Any options granted but not exercised may be canceled if the grantee so agrees and new options may be granted to the participant provided such options fall within the limits specified in paragraph 3 above and are otherwise granted in accordance with the terms of the Share Option Scheme.
- 15. The Shares issued on exercise of the options will on issue be identical shares of our Company.
- 16. Our Company, by ordinary resolution of the Shareholder, or the Board, may at any time terminate the operation of the Share Option Scheme, and in such event, no further options will be offered or granted, but in all other respects the Share Option Scheme shall remain in full force and effect. Any granted but unexercised options shall continue to be exercisable in accordance with their terms of issue after the termination of the Share Option Scheme.
- 17. The options are not transferable, except for the transmission of an option on the death of a grantee to his personal representative(s) on terms of the Share Option Scheme.
- 18. Subject to the terms set out in this paragraph below, the Board may amend any of the provisions of the Share Option Scheme (including without limitation amendments in order to comply with changes in legal or regulatory requirements and amendments in order to waive any restrictions, imposed by the provisions of the Share Option Scheme, which are not found in Chapter 17 of the Listing Rules) at any time (but not so as to affect adversely any rights which have accrued to any grantee at that date).

Those specific provisions of the Share Option Scheme which relate to the matters set out in Rule 17.03 of the Listing Rules cannot be altered to the advantage of participants, and no changes to the authority of the Directors or administrator of the

Share Option Scheme in relation to any alteration of the terms herein shall be made, without the prior approval of Shareholders in general meeting. Any alterations to the terms and conditions of the Share Option Scheme which are of a material nature, or any change to the terms of options granted, must be approved by the Shareholders in general meeting, except where the alterations take effect automatically under the existing terms of the Share Option Scheme. The Share Option Scheme so altered must comply with Chapter 17 of the Listing Rules.

Present status of the Share Option Scheme

The Share Option Scheme is conditional on:

- (i) the Listing Committee of the Hong Kong Stock Exchange granting the listing of, any permission to deal in, the Shares under the Share Option Scheme representing 10% of the issued share capital of our Company upon listing; and
- (ii) the commencement of dealings in the Shares on the Stock Exchange.

If both of the above conditions are not satisfied on or before the date following six months after the date of adoption of the Share Option Scheme (or such later date as the Board may decide), the Share Option Scheme shall forthwith be canceled and no person shall be entitled to any rights or benefits or be under any obligations under or in respect of the Share Option Scheme. As at the date of this prospectus, no option has been granted or agreed to be granted under the Share Option Scheme.

Application has been made to the Listing Committee for the listing of, and permission to deal in, the 1,325,272,275 Shares under the Share Option Scheme representing 10% of the issued share capital of our Company upon listing.

F. OTHER INFORMATION

1. Estate Duty

Our directors have been advised that no material liability for estate duty is likely to fall on our Company or any of our subsidiaries.

2. Litigation

As at the Latest Practicable Date, no member of our Group was engaged in any litigation, arbitration or claim of material importance and no litigation, arbitration or claim of material importance is known to our directors to be pending or threatened against any member of our Group.

3. Preliminary expenses

Our estimated preliminary expenses are approximately HK\$47,000 and are payable by our Company.

Save for the credit agreement and the share charge referred to in paragraphs B(1)(1) and (2) in this section, respectively, none of the experts named above has any shareholding interests in any member of our Group or the right (whether legally enforceable or not) to subscribe for or to nominate persons to subscribe for securities in any member of our Group.

6. Binding effect

This prospectus shall have the effect, if an application is made in pursuant hereof, of rendering all persons concerned bound by all the provisions (other than the penal provisions) of sections 44A and 44B of the Hong Kong Companies Ordinance so far as applicable.

7. Compliance Adviser

We have appointed KGI Capital Asia Limited as our compliance adviser pursuant to Rule 3A.19 of the Listing Rules. Pursuant to Rule 3A.23 of the Listing Rules, our compliance adviser will advise us in the following circumstances:

- before the publication of any regulatory announcement, circular or financial report;
- where a transaction, which might be a notifiable or connected transaction, is contemplated, including share issues and share repurchases;
- where we propose to use the proceeds of the Global Offering in a manner different from that detailed in this prospectus or where our business activities, developments or results deviate from any estimate or other information in this prospectus; and
- where the Hong Kong Stock Exchange makes an inquiry of us regarding unusual movements in the price or trading volume of our Shares.

The term of the appointment shall commence on the Listing Date and end on the date on which we distribute our annual report in respect of our financial results for the first full financial year commencing after the Listing Date and such appointment may be subject to extension by mutual agreement.

G. EXEMPTIONS FROM THE COMPANIES ORDINANCE AND WAIVERS FROM THE LISTING RULES

1. SEPARATE PUBLICATION OF ENGLISH AND CHINESE VERSIONS OF THIS PROSPECTUS

The English language and Chinese language versions of this prospectus are being published separately in reliance upon the exemption provided by section 4 of the Companies Ordinance (Exemption of Companies and Prospectus from Compliance with Provisions) Notice (Chapter 32L of the Laws of Hong Kong).

2. WAIVER IN RELATION TO THE VALUATION REPORT

According to the valuation report set out in Appendix IV to this prospectus, as of January 31, 2008, we held 98 parcels of land with an aggregate area of approximately 2,859,258 square meters in the PRC and 326 properties with an aggregate floor area of approximately 1,083,910 square meters in the PRC. As of January 31, 2008, we also rented approximately 493 properties with an aggregate floor area of approximately 437,347 square meters in the PRC. Owing to the substantial number of properties involved, we have applied to the SFC for an exemption and the Hong Kong Stock Exchange for a waiver from strict compliance with certain of the valuation report requirements contained in paragraph 34(2) of the Third Schedule to the Hong Kong Companies Ordinance and Rules 5.01 and 5.06 and paragraph 3(a) of Practice Note 16 of the Hong Kong Listing Rules, respectively, on the grounds that, given that is estimated by CB Richard Ellis Limited that the valuation report would run to over 400 pages of English text if the traditional format were to be adopted, it would be unduly burdensome for the Company to do so. The Company and the Joint Sponsors are of the view that:

- (a) it is not practical and unduly burdensome to the Company to list all of the properties and show their particulars and values individually in this prospectus in the traditional format as required by the Listing Rules and the Companies Ordinance; and
- (b) for a food and beverages manufacturer such as the Company, to include in the prospectus excessive details of this nature in relation to properties would not be material to potential investors' investment decisions.

The waiver has been granted by the Hong Kong Stock Exchange, and the exemption has been granted by the SFC under section 342A of the Hong Kong Companies Ordinance, subject to the following conditions:

- (i) a full valuation report complying with all relevant requirements under the Hong Kong Listing Rules and all the requirements of paragraph 34 of the Third Schedule to the Companies Ordinance in the English language will be made available for inspection in accordance with "Appendix VII Documents Delivered to the Registrar of Companies and Available for Inspection";
- (ii) the valuer's letter and the valuer's certificate containing a summary valuation of all the Group's property interests, based on the full property valuation report be included in this prospectus in the form set out in Appendix IV to this prospectus; and
- (iii) this prospectus shall set out particulars of this exemption.

The summary valuation will divide all the property interests of the Group into five groups, namely: (i) Group I: Property interests held by the Group for occupation in the PRC; (ii) Group II: Property interests held by the Group for development in the PRC; (iii) Group III: Property interests held by the Group for occupation in the Singapore; (iv) Group IV: Property interests held by the Group for occupation in the Taiwan; (v) Group V: Property interests rented by the Group in the PRC; (vi) Group VI: Property interests rented by the Group in Japan; and (vii) Group VII: Property interests rented by the Group in Taiwan. Under each group, there will be summary valuation certificates describing particulars of occupancy of the properties and their open market value.

3. WAIVER IN RELATION TO THE ACCOUNTANT'S REPORT

According to Rule 4.04(1) of the Listing Rules and paragraph 27 of the Third Schedule to the Hong Kong Companies Ordinance, we are required to include in this prospectus a statement as to the gross trading income or sales turnover (as the case may be) of our Group during each of the three financial years immediately preceding the issue of this prospectus.

According to Rule 4.04(1) of the Listing Rules and paragraph 31 of the Third Schedule to the Hong Kong Companies Ordinance, we are required to include in this prospectus a report by our auditor with respect to profits and losses and assets and liabilities of our Group in respect of each of the three financial years immediately preceding the issue of this prospectus.

The accountant's report for each of the three years ended December 31, 2006 and the nine months ended September 30, 2006 and 2007 has been prepared and is set out in Appendix I to this prospectus.

An application has been made to the SFC for a certificate of exemption from strict compliance with paragraphs 27 and 31 of the Third Schedule to the Hong Kong Companies Ordinance in relation to the inclusion of the Accountant's Report for the full year ended December 31, 2007 in this prospectus on the ground that it would be unduly burdensome for us to do so within a short period of time after December 31, 2007. A certificate of exemption has been granted by the SFC under section 342A of the Hong Kong Companies Ordinance.

4. WAIVER IN RELATION TO THE PRE-IPO SHARE OPTION SCHEME

Under Rule 17.02(1)(b) of the Listing Rules and item 27 of Appendix 1A and paragraph 10(d) of Part I of the Third Schedule to the Hong Kong Companies Ordinance, this prospectus is required to include details of the number, description and amount of any of our Shares which a person has, or is entitled to be given, an option to subscribe for, together with certain particulars of each option, namely the period during which it is exercisable, the price to be paid for Shares subscribed for under it, the consideration (if any) given or to be given for it or for

the right to it and the names and addresses of the persons to whom it was given. We have granted options to 1,637 persons to subscribe for 50,362,400 Shares on the terms set out in the table in this section.

We have applied for (i) a waiver from the Stock Exchange from strict compliance with the disclosure requirements under Rule 17.02(1)(b) and paragraph 27 of Appendix IA to the Listing Rules and (ii) an exemption from the SFC from strict compliance with the disclosure requirements of paragraph 10(d) of Part I of the Third Schedule to Hong Kong Companies Ordinance on the ground that full compliance with these requirements would be unduly burdensome for us for the following reasons:

- (a) in light of the large number of participants involved in the Pre-IPO Share Option Scheme, disclosure of the details of each of participants will require an additional over 150 pages of this prospectus, making this prospectus unnecessarily lengthy, hence strict compliance with the disclosure requirements on an individual basis will be unduly burdensome on the Company;
- (b) the numbers of options granted to individual grantees are, individually, de minimis and therefore irrelevant to investors:
- (c) as the options granted under the Pre-IPO Share Option Scheme are considered a part of the participants' remuneration package, individual information regarding such options is highly sensitive and confidential to the employees concerned;
- (d) options granted to directors of the Company will be disclosed under the section headed "C. Further Information about our Directors, Management and Staff 1. Disclosure of Interests" in this Appendix;
- (e) the grant and exercise in full of the options granted under the Pre-IPO Share Option Scheme will not cause any material adverse change in the financial position of the Company;
- (f) the non-compliance with the disclosure requirements will not hinder the Company in providing an informed assessment of the activities, assets and liabilities, financial position, management and prospects of the Company to its potential investors; and
- (g) the disclosure of a summary of the information in relation to the options granted under the Pre-IPO Share Option Scheme, as described in this section, should provide potential investors with sufficient information to make a relevant assessment of the Company in their investment decision-making process.

The Stock Exchange has granted the waiver and the SFC has granted the exemption to us on the conditions that:

 - (i) the aggregate number of grantees and the number of Shares subject to the options;
 - (ii) the consideration paid for the grant of the options; and
 - (iii) the exercise period and the exercise price for the options;
- (c) a full list of all the grantees (including the persons referred to in paragraph (a) above) who have been granted options to subscribe for Shares under the Pre-IPO Share Option Scheme containing all the details as required under Rule 17.02(1)(b) and paragraph 27 of Appendix IA to the Hong Kong Listing Rules (as in relation to the Stock Exchange waiver) and paragraph 10 of Part I of the Third Schedule to the Hong Kong Companies Ordinance (as in relation to the SFC exemption) will be made available for public inspection in accordance with the paragraph headed "Documents Available for Inspection" in Appendix VII to this prospectus;
