Letter to the Shareholders 致股東的函件

I am pleased to report that the Group has continued to achieve improvement in its results for the financial year ended 28 February 2009 (“the year”) over that achieved last financial year. Due to the global economic crisis and other factors, however, that growth has become moderate as compared to that of last year.

The improvement was mainly due to (i) an increase in both turnover and net profit of the retail business in mainland China and (ii) an income gained from the termination of a rental lease in Hong Kong. While benefiting from the less-affected economy of mainland China, the Group spent significant efforts in fighting against declining markets of other business regions.

In coping with the global financial situation, the Group took a cautious approach to the management of store and inventory portfolios of all business segments. It also took various measures to stringently control the company costs. While acting prudently to minimize the negative impact on severely affected areas such as export and non-Chinese tourism, the Group was eager to identify opportunities. We achieved the following results during this fiscal year:

- Opened 17 stores in the mainland China retail network for maximizing business opportunities in a continually growing market. In light of the global financial crisis, store expansion was slowed down in the second half of the year.
- Out of the said 17 new stores, 7 of these stores were for our second brand “SAXX” expansion, bringing the SAXX stores to a total number of 19 in mainland China.
- Opened 2 stores in Yuen Long and Sheung Shui in the New Territories for further penetration of our business into the Hong Kong local consumer market, and maximizing the cross-the-border-shopping business from Shenzhen of China.
- Refreshed the brand image of TSL, SAXX and Estrella by revamping the visuals of stores and marketing materials with the new thematic images photographed in the United States.
- Upgraded the showroom environment with the updated store design and visuals in the Hung Hom headquarters.
- Successfully launched a new seasonal product campaign that aims at bringing international jewellery and fashion trends to our customers.
- Received recognition of our well-established quality service culture from external bodies such as the service award from Hong Kong Retail Management Association and MTR Corporation.
- Won a number of international and local jewellery design awards that recognized our leadership in and dedication to innovative jewellery design.

Notwithstanding the on-going global financial turbulence and the threat of Influenza A (H1N1) outbreak, I stay positive with the future development of the Group. With the completion of various core infrastructure projects in the past few years, the Group owns a satisfactory platform for supporting its growth in the years to come. In addition, our long history in the jewellery retail industry and the prestigious TSL brand position developed in mainland China are the critical success factors in sustaining our growth. With the support of the TSL main brand, the second brand “SAXX”, which represents a stylish and energetic way of life through its metaphor of jazz music, has been gradually moving into the consumer market of young professionals in mainland China. This positioning of SAXX will secure us high-potential opportunities in the next few years. In the luxury segment, the Estrella Diamond will continue to be our major focus, which aims at bringing one-of-a-kind high-jewellery offerings to our customers. Being a brand-driven jewellery retailer who provides high quality products with state-of-the-art designs and craftsmanship has been and will continue to be the core value for the Group to move forward.

We shall, with the continuing support of our shareholders and other stakeholders, continue to work steadily and diligently in order to achieve our mission and face any challenges to come.

本人欣然報告，本集團截至2009年2月28日止財政年度(「本年度」)之業績較上一個財政年度持續改善。然而，基於全球經濟危機及其他因素，此增長率與去年比較下僅屬溫和水平。

業績有所增長主要由於以下因素所致：(i)中國大陸零售業務之營業額及純利均有上升；及(ii)因在香港終止一份租約而獲得收入。受惠於影響程度較少之中國大陸經濟之同時，本集團致力抵禦其他地區市場之收縮。

為應付全球金融局面，本集團已採取審慎方針，管理所有業務分部之店舖及存貨組合。本集團亦已採納不同措施，嚴格監控公司成本。本集團審慎行事，務求減低對出口及非華籍人士旅遊業等嚴重受影響行業造成之負面沖擊。本集團積極開拓商機，於本年內，取得以下各項成績：

- 於中國大陸零售網絡開設17家店舖，以在日益龐大之市場中盡量擴大商機。鑑於全球金融危機，本集團已於本年度下半年放慢店舖擴充計劃之步伐。
- 在上述17家新店舖當中，擴充了7家店舖屬本集團旗下副品牌「SAXX」之店舖，致令SAXX於中國大陸之店舖總數達19家。
- 於新界區之元朗及上水先後開設兩家店舖，進一步將本集團業務打入香港本地消費市場，並盡量吸納來自中國深圳之跨境購物業務。
- 在美國取景攝影，重新粉飾店舖及市場推廣物品，更新TSL、SAXX及Estrella之品牌形象。
- 提升位於紅磡總部陳列室的格局，換上時尚之店舖設計及裝潢。
- 本集團已成功推出新一季產品系列，務求將最時尚之國際珠寶潮流帶給顧客。
- 本集團鞏固之優質服務文化繼續獲得香港零售管理協會及港鐵公司等外界團體表揚服務之獎項。
- 本集團多次贏得國際及本地珠寶設計獎項，反映本集團在珠寶設計創意上之努力及領導地位獲得認同。

儘管全球金融局面持續動盪，加上受到甲型流感H1N1之威脅，本集團對未來之發展仍保持正面態度。隨著過往數年多項核心基建項目相繼完成，本集團已確立理想平台，成為本集團於未來數年增長之後盾。此外，本集團在珠寶零售業務歷史悠久，加上TSL品牌在中國大陸已建立顯赫地位，成為本集團可持續增長之關鍵成功因素。在主品牌TSL之支持下，副品牌「SAXX」藉爵士音樂所象徵既具格調又充滿活力之生活取向，已逐步打入中國大陸年輕專業一族之消費市場。SAXX在此方面之市場定位，在未來數年極具潛力，並為本集團帶來無限商機。在高級消費品方面，Estrella鑽石將繼續成為本集團之焦點，給予本集團顧客對珠寶體驗獨一無二之高度滿足感。作為以品牌為主導之珠寶零售商，本集團素來提供設計時尚、技術先進之優質產品，此精神為過去及未來推動本集團邁步向前之核心價值。

承蒙本集團各股東及其他權益人士持續對本公司之鼎力支持，本公司將繼續穩健營運及勤奮工作，為達成本公司目標全力以赴，面對挑戰。

Management's Discussion and Analysis

管理層之討論及分析

Group Results

For the financial year ended 28 February 2009, the Group achieved (i) a consolidated turnover of HK\$1,959 million (2008: HK\$1,917 million), an increase of 2.2% from last financial year and (ii) a profit attributable to equity holders of the Company of HK\$104.8 million (2008: HK\$99.2 million), an increase of 5.6%. Earnings per share were 50 HK cents (2008: 48 HK cents). The improvement in the Group's results for the year was mainly attributable to (i) the growth of turnover and contribution from our mainland China (the "Mainland") business and (ii) other income from compensation for early termination of a shop lease.

The improvement was mainly noted in the first half of the financial year. Because of the deepening of the global financial crisis in September, 2008, it was inevitably that the luxury market in which the Group operated has been affected. Excluding the effect of the compensation received in the other income, the profit attributable to equity holders decreased by 23.4% from HK\$99.2 million to HK\$76 million.

The Board has proposed a final dividend of 3 HK cents per ordinary share of the Company for the year ended 28 February 2009 (2008: 1 HK cent) to shareholders whose names appear on the Register of Members of the Company on Thursday, 27 August 2009. Together with the interim dividend paid to shareholders on Thursday, 15 January 2009, the total dividend for the year ended 28 February, 2009 will be 5 HK cents (2008: 1 HK cent). Subject to the shareholders' approval at the forthcoming annual general meeting, the final dividend will be paid on Friday, 11 September 2009.

During the year, Hong Kong and Macau Retail markets have slowed down because of the visa policy adjustment by the Mainland to prepare for the Beijing Olympic Games in the first half and the deepening of the global financial crisis in the second half.

The Group have continued the review of its retail operations in Hong Kong and progressively shifted the mix of its stores to better suit the changing shopping habits in Hong Kong. During the year, the Group opened two new stores respectively in Sun Yuen Long Centre and Landmark North in Sheung Shui. Renewal of lease for existing sites has been critically evaluated particularly in respect of the rental in light of the uncertain economic situation.

Thanks to the sales growth of tourists from the Mainland, despite the decrease in number of tourists from other overseas markets, turnover in the Group's showroom business was stable during the year.

Our business in the Mainland saw satisfactory growth which was in line with the increasing wealth of the population and the expanding the Mainland economy generally. During the year, 17 new stores were opened by the Group of which 7 are Saxx stores. This second brand has been well-received by consumers and our business partners.

Because of the uncertain and deteriorating global economy, our export business has tightened the credit policy and the business slowed down. There have also been pressures on the margin and affected the performance of this business.

The Malaysian operation was also affected by the global financial crisis and the business has slowed down in the second half of the year.

The deterioration of the world wide economy seems to have stabilized in recent months. However, the economic recovery and the aftermath of the financial crisis are yet to be certain. The outbreak of the influenza A (H1N1) also poses an additional threat to the fragile economy. The outlook of the market in the coming year is, therefore, also full of uncertainties.

In view of the global financial crisis, the Group has been taking a cautious approach to critically review the store and inventory portfolio of all business segments. The Group has also implemented stringent cost control measures and improved the internal efficiency. The continuous improvements in these core competences have been and will be an important source of growth of the Group. These efforts also enable the Group to better grasp the opportunities arising from the continued economic growth in the Mainland in which the Group has a very good presence.

集團業績

截至2009年2月28日止財政年度，本集團錄得(i)綜合營業額港幣1,959,000,000元(2008年：港幣1,917,000,000元)，較上個財政年度增加2.2%；及(ii)本公司股東應佔盈利為港幣104,800,000元(2008年：港幣99,200,000元)，增加5.6%。每股盈利為港幣50仙(2008年：港幣48仙)。本集團業績於本年度有所增長之主要原因為(i)本集團旗下中國大陸(「國內」)業務之營業額及貢獻增多及(ii)提前終止店舖租約之賠償帶來之其他收入。

有關增長主要於本財政年度上半年錄得。鑑於全球金融危機於二零零八年九月後情況每況愈下，本集團營運之高級消費品市場難免受到影響。不計及已獲取賠償之其他收入的影響，股東應佔盈利由港幣99,200,000元下跌23.4%至港幣76,000,000元。

董事會建議派發本公司截至2009年2月28日止年度末期股息每股普通股為港幣3仙(2008年：每股普通股港幣1仙)予於2009年8月27日(星期四)名列本公司股東名冊之股東。連同已於2009年1月15日(星期四)向股東派發之中期股息，截至2009年2月28日止年度之股息總額將約為港幣5仙(2008年：港幣1仙)。末期股息將於2009年9月11日(星期五)派發，須待股東於即將舉行的股東週年大會上批准後作實。

因國內於上半年籌備北京奧運會而調整簽證政策及下半年全球金融危機之影響深化，引致年內港澳兩地之零售市場放緩。

本集團繼續檢討香港之零售業務，並積極改動店舖組合，以便更能切合港人不斷轉變之購物習慣。年內，本集團分別在新元朗中心及上水廣場開設兩家新店。鑑於經濟環境不明朗，本集團已就現有店舖之續租事項(特別在租金方面)進行謹慎檢討。

儘管其他海外市場旅客人數下降，但有賴向國內旅客銷售貨物錄得增長，本集團年內陳列室業務之營業額維持穩定。

隨著國內人民財富日益豐厚及國內經濟普遍發展蓬勃，本集團之國內業務取得滿意增長。年內，本集團開設17家新店，其中7家為Saxx店。此副品牌廣受顧客及業務夥伴歡迎。

有見全球經濟不明朗及轉差，本集團已收緊出口業務之信貸政策，有關業務有所放緩。由於利潤亦受壓，故影響出口業務之表現。

馬來西亞業務亦受全球金融危機影響，該業務於本年度下半年開始放緩。

近月，全球經濟轉壞情況已趨向穩定。然而，經濟是否復甦及金融危機是否已告一段落仍屬未知之數。爆發甲型流感H1N1亦對疲弱經濟增添威脅。因此，市場來年前景亦充滿變數。

鑑於全球金融危機，本集團一直採取審慎政策，仔細檢討所有業務分部之店舖及存貨組合。本集團亦已實施嚴格成本控制措施並改善內部效率。此等主要優勢日益提升，過往一直為本集團增長之重要因素，而將來亦必如是。此等因素發揮成效，致令本集團於國內廣受歡迎，並更能把握當地經濟持續增長所帶來的商機。

Finance, Liquidity, Capital Structure and Gearing

Capital expenditure including store renovation and expansion, information technology investment and machinery made during the year amounted to approximately HK\$45 million. This was mainly financed from bank borrowings and internal resources.

At 28 February 2009, the Group's total borrowings decreased to HK\$131.8 million from HK\$171.1 million at 29 February, 2008. Our debt to equity ratio (ratio of total borrowings to total equity) has decreased from 38.2% to 22.7% because of the increase in total equity value resulting from the profit and the repayment of loan during the year. All the Group's borrowings are denominated in Hong Kong dollars. Interest is determined on the basis of inter-bank market rates or prime rate.

As at 28 February 2009, the Group had cash and bank balances and undrawn banking facilities of approximately HK\$137 million, which in the opinion of the directors, should be sufficient for the present working capital requirements.

財務、流動資金、資本結構及負債比率

年內，店舖翻新及擴充、資訊科技投資及機器等之資本開支約為港幣45,000,000元，主要由銀行貸款及內部資源提供資金。

本集團於2009年2月28日之貸款總額由2008年2月29日之港幣171,100,000元減至港幣131,800,000元。本集團負債比率(即貸款總額與權益總額之比率)由38.2%下跌至22.7%，乃因年內錄得盈利使權益總額增加及年內償還貸款所致。本集團全部貸款以港幣為單位，而利息則按銀行同業市場利率或最優惠利率釐訂。

於2009年2月28日，本集團之現金及銀行結餘及未動用銀行融資約為港幣137,000,000元，董事認為足以應付目前的營運資金需求。

Exchange Rates 匯率

During the year, the transactions of the Group were mainly denominated in local currencies and US dollars. The impact of the fluctuation of foreign exchange rates of these currencies is insignificant to the Group.

於本年度內，本集團的交易主要以本地貨幣及美元為單位，此等貨幣的匯率波動對本集團並無重大影響。

Charges on Group Assets

- (1) At 28 February 2009, debentures were executed by the Group in favour of its bankers and financial creditors charging, by way of fixed and floating charges, all of the undertakings, properties and assets of the Company and 12 of its subsidiaries as security for, inter alia, all obligations and liabilities, actual or contingent, from time to time owing by the Group to the bankers and financial creditors. Rental revenue of the Group is also charged in favour of the Group's bankers.
- (2) At 28 February 2009, the Group pledged all rights, titles and interests in 80.46% of the entire share capital of Infinite Assets Corp. and Tse Sui Luen Investment (China) Limited and all benefits accruing to the pledged equity interest to the Group's bankers and financial creditors as security for, inter alia, all obligations and liabilities, actual or contingent, from time to time owing by the Group to the bankers and financial creditors.
- (3) On 27 September 2007, the Company and its 6 subsidiaries (the "Subsidiaries") executed a second floating charge and the Company made a guarantee to the Subsidiaries and there is a cross guarantee among the Subsidiaries in favor of Rosy Blue Hong Kong Limited ("Rosy Blue HK") to pledge all of the Subsidiaries' respective rights to and title and interest from time to time in their inventories or stock-in-trade and their receivables from their overseas fellow subsidiaries in connection with the sales and supply of any inventory or stock-in-trade to such overseas fellow subsidiaries as a continuing security for the debts arising from the supply of polished diamonds and precious stones by Rosy Blue HK to the Subsidiaries (the "Debts"). At 28 February 2009, the Debts amounted to HK\$70,430,000.



集團資產抵押

- (1) 於2009年2月28日，本集團訂立債權證，以固定及浮動抵押形式將本公司及其12家附屬公司之所有業務、物業及資產質押予其往來銀行及財務債權人，以作為(其中包括)本集團不時結欠往來銀行及財務債權人之所有實際或或有負債及債務之抵押品。本集團租金收入亦已抵押予本集團之往來銀行。
- (2) 於2009年2月28日，本集團將其於Infinite Assets Corp.及謝瑞麟投資(中國)有限公司股本總額80.46%之一切權利、所有權和權益，及已抵押股本權益所累計一切利益抵押予本集團之往來銀行及財務債權人，以作為(其中包括)本集團不時結欠往來銀行及財務債權人之所有實際或或有負債及債務之抵押品。
- (3) 於2007年9月27日，本公司及其6家附屬公司(「該等附屬公司」)訂立第二浮動抵押及本公司向該等附屬公司作出擔保，而該等附屬公司之間亦有交叉擔保，以將該等附屬公司各自不時於其存貨或待銷存貨以及彼等來自就向其彼等海外同系附屬公司銷售及供應任何存貨或待銷存貨之應收該等海外同系附屬公司款項之所有權利、所有權及權益抵押予Rosy Blue Hong Kong Limited(「Rosy Blue HK」)，以作為Rosy Blue HK向該等附屬公司供應精鍊鑽石及寶石所產生之債務之持續抵押品(「該債項」)。於2009年2月28日，該債項為港幣70,430,000元。

Contingent Liabilities

- (1) As set out in the announcement of the Company dated 3 June 2008, two directors of the Company, and a controller of showroom operations of a subsidiary and a consultant to a subsidiary were convicted by the District Court of Hong Kong of various charges involving offences under the Prevention of Bribery Ordinance, the Crime Ordinance and the Theft Ordinance. The Company has been informed that the two directors who have been convicted have commenced proceedings to appeal the verdict (“the Appeal”). Under the Company’s Bye-Laws, the Company may be required to indemnify its directors from and against all actions, costs, charges, losses, damages and expenses which they or any of them may incur in execution of their duty, provided that such indemnity shall not be extended to any matter in respect of, among other things, fraud and dishonesty. The Directors are of the view that they are not in a position to conclude that whether and/or to what extent the Company may be required to indemnify the two directors involved in relation to the Appeal.
- (2) As at the balance sheet date, the disputes of certain subsidiaries with Inland Revenue Department (“IRD”) regarding the tax treatment of certain offshore income, agents commission payments and promoter fees for prior years are still undetermined. During the year, a subsidiary received additional assessments and proposed adjustments in relation to the dispute on the tax treatment of agent commission payments and promoter fees for prior years. The Group has established a total provision of approximately HK\$94 million for all the additional assessments issued and proposed by IRD in respect of such disputes. In the event that the Group is not successful in defending the tax treatments adopted, the Group may be subject to significant additional tax liabilities and possibly penalties which, under the provisions of the current tax legislation, may be up to three times any tax under-reported as assessed by the IRD.

Furthermore, the verdict of the District Court of Hong Kong mentioned in (1) above may or may not have impact on the IRD’s challenges on the tax treatments adopted by the Group relating to agents commission payments and promoter fees arising in prior years. The directors consider that it is impractical to estimate the potential amount of additional tax liabilities arising if the IRD’s challenge in respect of the offshore income, agent commission payments and promoter fees is successful.

- (1) 誠如本公司日期為2008年6月3日之公佈所載，本公司兩名董事以及一家附屬公司陳列室業務之主管及一名顧問被香港區域法院裁定觸犯防止賄賂條例、刑事罪行條例及盜竊罪條例中多項控罪。本公司已得悉該兩名被定罪的董事已就裁決提出上訴(「上訴」)。根據本公司之公司細則，本公司可能須就其董事因履行職務而產生之所有訴訟、成本、支出、損失、賠償及開支向彼等或彼等當中任何人士作出彌償，惟有關彌償並不包括(其中包括)欺詐及不誠實行為。董事認為，彼等未能就是否需要向涉及上訴之兩名董事作出彌償及／或本公司作出彌償之程度作出定論。
- (2) 截至結算日，若干附屬公司與香港稅務局(「稅務局」)就以往年度之若干離岸收入、代理佣金支出與業務推廣費用所採納稅務處理方法之爭議尚未得出結論。於年度內，一家附屬公司就以往年度之代理佣金支出與業務推廣費用之稅務處理方法之爭議接獲額外評稅及建議調整。本集團已就有關爭議涉及之所有由稅務局發出及建議之額外評稅作出約港幣94,000,000元之撥備。倘本集團未能就所採納稅務處理方法成功抗辯，本集團或須承擔額外稅務責任，且可能須繳交罰款。根據現行稅法，罰款或會多達稅務局評估任何漏報稅項之三倍。

此外，於上文第(1)項所述香港區域法院之裁決可能對稅務局就本集團有關以往年度代理佣金支出與業務推廣費用所採納稅務處理方法之質疑構成影響。董事認為，倘稅務局就本集團有關以往年度離岸收入、代理佣金支出與業務推廣費用所採納稅務處理方法之質疑落實，評估所產生之潛在額外稅務負債並不切實可行。

Human Resources

As at 28 February 2009, the total number of employees of the Group was approximately 3,200 (2008: 3,200).

Employees are rewarded on a performance basis with reference to market rates. Other employee benefits include medical cover and subsidies for job-related continuing education. The Group also has an employee share option scheme. No options were granted pursuant to the scheme during the year. Retail front line staff is provided with formal on-the-job training by internal seniors and external professional trainers. Experience sharing with seniors at in-house seminars and discussion groups enhance intra-departmental communications.

Report of the Directors 董事會報告書

The directors have pleasure in presenting their annual report together with the audited financial statements for the year ended 28 February 2009.

董事會欣然提呈截至2009年2月28日止年度的年報及經審核財務報表。

Principal Activities 主要業務

The principal activity of the Company is investment holding. The principal activities and other particulars of the subsidiaries are set out in note 13 to the financial statements.

The analysis of the geographical locations of the operations of the Company and its subsidiaries (the “Group”) during the financial year is set out in note 11 to the financial statements.

本公司的主要業務是投資控股。各附屬公司的主要業務及其他詳情載列於財務報表附註13。

本公司及各附屬公司(「本集團」)於本財政年度的經營地區分析載列於財務報表附註11。

Major Customers and Suppliers 主要客戶及供應商

For the year ended 28 February 2009, the five largest customers in aggregate accounted for less than 30% of the Group’s turnover. The five largest suppliers in aggregate and the largest supplier of the Group accounted for approximately 65% and 20% respectively by value of the Group’s total purchases.

As set out in note 31 on the financial statements, Rosy Blue Hong Kong Ltd. is a fellow subsidiary of Prime Investments S.A., a preference shareholder of Partner Logistics Limited which is the Company’s controlling shareholder.

Except for the above, at no time during the year have the directors, their associates or any shareholder of the Company (which, to the knowledge of the directors, owns more than 5% of the Company’s issued share capital) had any interest (as defined in the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “Stock Exchange”) (“Listing Rules”) in these major customers and suppliers.

The profit of the Group for the year ended 28 February 2009 and the state of the Company's and the Group's affairs as at that date are set out in the financial statements on pages 87 to 176.

A final dividend for the year ended 28 February 2009, of 3 HK cents per ordinary share, amounting to a total final dividend of approximately HK\$6,264,000 (2008: HK\$2,088,000) is to be proposed at the forthcoming annual general meeting of the Company. This, together with the interim dividend of 2 HK cents per ordinary share paid on Thursday, 15 January 2009, will amount to a total dividend of 5 HK cents per ordinary share for the year (2008: 1 HK cent per ordinary share). Subject to shareholders' approval, the proposed final dividend will be paid on or about Friday, 11 September 2009 to shareholders whose names appear on the Register of Members on Thursday, 27 August 2009.

- any non-executive director (including independent non-executive directors) of the Company, any of its subsidiaries or any Invested Entity;
- any supplier of goods or services to any member of the Group or any Invested Entity;
- any customer of the Group or any Invested Entity;
- any person or entity that provides research, development or technological support or other services to the Group or any Invested Entity; and
- any shareholder or any member of the Group or any Invested Entity or any holder of any securities issued by any member of the Group or any Invested Entity.

The exercise price of options is the highest of the nominal value of the shares, the closing price of the shares on the Stock Exchange on the date of offer of the grant and the average closing price of the shares on the Stock Exchange for the five business days immediately preceding the date of offer of the grant. An offer of an option shall be deemed to have been accepted within 28 days from the date of offer upon acceptance of the option duly signed by the grantee together with a remittance of HK\$1. The maximum number of securities available for issue under the 2003 Share Option Scheme shall not exceed 10% of the issued share capital of the Company. The maximum entitlement of each grantee in any 12-month period is limited to 1% of the ordinary shares in issue of the Company. The option period will not be more than ten years from the date of grant of the option and the Company's board of directors may at its discretion determine the minimum period for which the option has to be held or other restriction before the exercise of the subscription right attaching thereon.

Retirement Schemes 退休計劃

The Group participates in the Mandatory Provident Fund Scheme (the “MPF Scheme”) under the Hong Kong Mandatory Provident Fund Schemes Ordinance for employees employed under the jurisdiction of the Hong Kong Employment Ordinance. The MPF Scheme is a defined contribution retirement scheme administered by independent trustees. Under the MPF Scheme, the employer and its employees are each required to make contributions to the scheme at 5% of the employees’ relevant income, subject to a cap of monthly relevant income of HK\$20,000.

The Group also participates in defined contribution retirement benefits schemes for all qualifying employees in the People’s Republic of China (“PRC”) and Malaysia. The assets of the schemes are held separately from those of the Group in funds under the control of independent trustees.

The Group’s total contributions to these schemes charged to the consolidated income statement during the year ended 28 February 2009 amounted to HK\$5,050,000 representing contributions payable by the Group to the schemes at the appropriate rates set by the local government of the subsidiaries.

The Board, through the Audit Committee, is responsible for ensuring that adequate internal controls are in place to safeguard the Company's assets and manage risks. The executive management has been delegated the responsibility of identifying and evaluating the risks faced by the Group and of designing, operating and monitoring an effective control system.

The internal control system is designed to provide reasonable, but not absolute, assurance on the effectiveness and efficiency of operations in achieving the established corporate objectives, safeguarding the Group's assets, providing reliable financial reporting and complying with the applicable laws and regulations. Systems and procedures are also established to identify, measure, manage and control, rather than eliminate, different risks arising from different business and functional activities.

The Group's Internal Audit Department plays an important role in the internal control function. It provides objective assurance to the Board that a sound internal control system is maintained and operated in compliance with the established processes and standards by performing periodic audits over all major operations of the Group, typically over a three-year cycle. An annual audit plan (comprising annual audit focus and audit frequencies) is prepared based on the development's independent risk assessment. Such work plan is discussed and agreed with the Audit Committee at the beginning of each financial year. Major internal audit findings will be submitted to the Audit Committee for review and all recommendations from the Internal Audit Department will be properly followed up to ensure that they are implemented within a reasonable period of time. The Directors have received the report from the Internal Audit Department which conducted a review of the effectiveness of the system of internal control of the Group.

The scope of work performed by the internal audit function during the year included financial and operational reviews, recurring/surprise inventory counts and audits, and special reviews.

In March 2008, an independent international professional accounting firm was appointed by the Board to assist in conducting a review on the Group's system of internal controls and to provide recommendations on areas for improvement. The review covered the material controls on the Group's operations in Hong Kong and Shenzhen including the financial, operational, compliance and risk management functions of the Group. The report of the review by the independent international professional accounting firm ("June 2008 Report") has been discussed and adopted at the Audit Committee Meeting held on 16 June 2008.

Another review on the Group's internal control system was conducted in March and April 2009 by the independent international professional accounting firm. The aim is to obtain the views of an independent international professional accounting firm on the adequacy and effectiveness of the Company's internal controls in specific areas of the Group's operation which included the commission system of showroom and the bonus system of Hong Kong employees and the follow up on the six high priority issues identified in June 2008 Report.

The management believes that such a review is educational to the colleagues of the Group and raises their internal control awareness positively. The management is committed to continuous improvements and since the issuance of June 2008 Report, an Internal Control Review Committee ("ICRC") comprising the Chairman, Chief Executive Officer, Chief Financial Officer and the Internal Audit Manager, has been set up to oversee the implementation of the recommendations raised in the June 2008 Report and the continuity of internal control focus within the Group.

All recommendations for rooms for improvement identified in June 2008 Report have been adopted in accordance with the schedule. Another 4 recommendations which are targeted to be completed in the financial year ended 28 February 2010 and the recommendations identified in the second review report will also be followed up accordingly.

The second report of the review by the independent international professional accounting firm has been reviewed and adopted by the Board on 9 June 2009.

The Board considers that the internal control system of the Group is effective and will continue to review and update the system to ensure that shareholder's investments and the Group's assets are safeguarded.

Notes to the Financial Statements 財務報表附註

1 Significant accounting policies

(a) Statement of compliance

These financial statements have been prepared in accordance with Hong Kong Financial Reporting Standards (“HKFRSs”), which include all applicable individual HKFRSs, Hong Kong Accounting Standards (“HKASs”) and Interpretations issued by the Hong Kong Institute of Certified Public Accountants (“HKICPA”) and the disclosure requirements of the Hong Kong Companies Ordinance. These financial statements also comply with the applicable disclosure provisions of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (“Listing Rules”).

(b) Basis of preparation of financial statements

The measurement basis used in the preparation of the financial statements is historical cost.

The principal accounting policies and methods of computation used in the preparation of the financial statements for the year ended 28 February 2009 are consistent with those adopted in the financial statements for the year ended 29 February 2008, except for the adoption of the new and revised HKFRSs as explained in (c) below.

These financial statements are presented in Hong Kong dollars, which is the Company’s functional currency.

A summary of the significant accounting policies adopted by the Group is set out below.

本財務報表是按照香港會計師公會(「香港會計師公會」)頒布的香港財務報告準則(「香港財務報告準則」，其包括所有適用個別香港財務報告準則、香港會計準則(「香港會計準則」)及詮釋)以及香港公司條例的披露規定編製。此等財務報表亦符合香港聯合交易所有限公司證券上市規則(「上市規則」)的適用披露規定。

(b) 財務報表的編製基準

編製本財務報表時是採用歷史成本法為計量基準。

除採納下文(c)項所述新訂及經修訂香港財務報告準則外，編製截至2009年2月28日止年度財務報表時所採用主要會計政策及計算方法與截至2008年2月29日止年度財務報表所採納者一致。

本財務報表乃是以本公司之功能及呈報貨幣港幣列報。

下文載列本集團所採納主要會計政策的概要。

(d) Judgments and estimates

The preparation of financial statements in conformity with HKFRSs requires the directors to make judgments, estimates and assumptions that affect the application of policies and reported amounts of assets, liabilities, income and expenses. The estimates and associated assumptions are based on historical experience and various other factors that are believed to be reasonable under the circumstances, the results of which form the basis of making the judgments about carrying values of assets and liabilities that are not readily apparent from other sources. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

The directors have considered the development, selection and disclosure of the Group's critical accounting policies and estimates. The estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets or liabilities are as follows:—

(d) 判斷及估計

按照香港財務報告準則編製財務報表時，董事必須作出影響政策應用及所呈報資產、負債、收入及開支數額之判斷、估計及假設。在沒有其他明顯可參考的渠道下，其資產及負債的價值有關結果將由乃以過往經驗及多項其他於有關情況下視作合理的因素為基準的估計及相關假設組成。實際業績可能有別於此等估計數字。

估計及相關假設按持續基準予以檢討。僅影響該期間的會計估計修訂於修訂估計期間確認，或倘修訂均影響現時及日後期間，則於修訂的期間及日後期間確認。

董事已考慮本集團主要會計政策及估計的發展、選擇及披露。導致需對資產及負債賬面值作出重大調整的主要風險相關估計及假設如下：

(d) Judgments and estimates (continued)

(i) Useful lives and depreciation of property, plant and equipment

The Group determines the estimated useful lives and related depreciation charges of its property, plant and equipment. These estimates are based on the historical experience of the actual useful lives of property, plant and equipment of similar nature and functions. The Group will increase the depreciation charge where useful lives are less than previously estimated lives, and will write off or write down technically obsolete or non-strategic assets that have been abandoned or sold. Actual economic lives may differ from estimated useful lives. Periodic review could result in a change in depreciable lives and therefore depreciation charge in the future periods.

(ii) Net realisable value of inventories

Net realisable value of inventories is the estimated selling price in the ordinary course of business, less estimated costs of completion and variable selling expenses. These estimates are based on the current market condition and the historical experience of manufacturing and selling products of similar nature. It could change significantly as a result of changes in customer taste and competitor actions in response to severe industry cycle. The directors reassess the estimations at each balance sheet date.

(d) 判斷及估計(續)

(i) 物業、廠房及設備的可使用年期及折舊

本集團釐定物業、廠房及設備的估計可使用年期以及相關折舊開支。該等估計乃根據性質及功能相近的物業、機器及設備實際可使用年期的過往經驗而作出。倘可使用年期較先前所估計為短，則本集團將會提高折舊開支，並會將已報廢或出售的技術上過時或非策略資產撇銷或撇減。實際經濟年期可能與所估計可使用年期不同。定期檢討可使上述資產可折舊年期出現變動，繼而引致對未來期間的折舊開支作出變動。

(ii) 存貨之可變現淨值

存貨的可變現淨值乃於日常業務過程中作出的估計售價減估計完成成本及可變出售開支。此等估計乃根據現時市況及製造及出售性質類似產品的過往經驗而作出，並會因應客戶品味及競爭對手就劇烈行業週期所作行動而有重大變化。董事於各結算日重新評估有關估計。

(d) Judgments and estimates (continued)

(iii) Allowance for bad and doubtful trade and other receivables

The Group determines the allowance for bad and doubtful trade and other receivables based on an assessment of the recoverability of the receivables. This assessment is based on the credit history of the customers and other debtors and the current market condition. The directors reassess the allowance at each balance sheet date.

(iv) Share-based payments

The Group measures the cost of equity-settled transactions with employees by reference to the fair value of the equity instruments at the date at which they are granted. Estimating fair value for share-based payments requires determining the most appropriate valuation model for a grant of equity instruments, which is dependent on the terms and conditions of the grant. This also requires determining the most appropriate inputs to the valuation model including the expected life of the option, volatility and dividend yield and making assumptions about them. The assumptions and models used for estimating fair value for share-based payments are disclosed in note 28.

(v) Deferred tax assets

Deferred tax assets are recognised for all unused tax losses and temporary difference to the extent that it is probable that taxable profit will be available against which the losses and temporary difference can be utilised. Significant judgment is required to determine the amount of deferred tax assets that can be recognised, based upon the likely timing and the level of future taxable profits.

(iii) 呆壞賬及其他應收款之撥備

本集團按照應收賬款的可收回情況評估對呆壞應收賬款及其他應收款的撥備。此項評估乃根據客戶及其他應收款的過往記賬記錄以及現行市況釐定。董事於各結算日重新評估撥備。

(iv) 以股份償付

本集團與僱員之股份結算交易之成本，是參考授予該股份日期之公平值計算。估計以股份償付的公平值時須釐定就授出權益工具最適當的估計模型，而此公平值受授出條款及條件所影響。此估計亦須釐定進行估值的最適合輸入數據，包括購股權預計年期、波幅及收益率，並對其作出假設。估計以股份償付的公平值時所用的假設及模型於附註28中披露。

(v) 遞延稅項資產

所有未被動用稅項虧損及暫時差異乃被確認為遞延稅項資產，惟以應課稅盈利可用作抵扣可動用之虧損及暫時差異為限。董事須根據未來應課稅盈利之可能時間及數額作出重大判斷，以釐定可予確認之遞延稅項資產金額。

(e) Basis of consolidation

The consolidated financial statements incorporate the financial statements of the Company and its subsidiaries made up to 28 February 2009. Where necessary, adjustments are made to the financial statements of subsidiaries to bring the accounting policies used into line with those used by other members of the Group.

A subsidiary, in accordance with the Hong Kong Companies Ordinance, is a company in which the Company, directly or indirectly, holds more than half of the issued share capital or controls more than half the voting power or controls the composition of the board of directors or over which the Company has a contractual right to exercise a dominant influence with respect to that entity's financial and operating policies. Subsidiaries are considered to be controlled if the Company has the power, directly or indirectly, to govern the financial and operating policies, so as to obtain benefits from their activities.

The results of subsidiaries are consolidated from the date of acquisition, being the date on which the Group obtains control, and continue to be consolidated until the date that such control ceases. Intra-group balances and transactions, and any unrealised profits arising from intra-group transactions, are eliminated in full on consolidation. Unrealised losses resulting from intra-group transactions are eliminated in the same way as unrealised gains, but only to the extent that there is no evidence of impairment.

(e) 綜合基準

綜合財務報表綜合計入本公司及其附屬公司截至2009年2月28日止之財務報表。本公司會於必要時調整附屬公司財務報表，致使所用會計政策與本集團其他成員公司所用者一致。

按照香港《公司條例》，附屬公司為本公司直接或間接持有過半數已發行股本或控制過半數投票權或控制董事會的組成的公司或本公司擁有合約權利可對該實體的財務及營運政策行使壓倒性影響力。倘本公司有權直接或間接監控附屬公司的財務及經營政策以自其業務中獲益，有關附屬公司即被視為受到控制。

附屬公司的業績自收購日期(即本集團取得控制權之日)起至有關控制權終止當日止期間內綜合入賬。集團內部間的結餘及交易與任何因集團內部間交易產生的未變現盈餘於綜合賬目時悉數對銷。集團內部間交易產生的未變現虧損按與未變現收益相同方式對銷，惟有證據顯示出現減值者除外。

(e) Basis of consolidation (continued)

The acquisition of subsidiaries during the year has been accounted for using the purchase method of accounting. This method involves allocating the cost of the business combinations to fair values of the assets acquired, and liabilities and contingent liabilities assumed at the date of acquisition. The cost of the acquisition is measured at the aggregate of the fair values of the assets given, equity instruments issued and liabilities incurred or assumed at the date of exchange, plus costs directly attributable to the acquisition.

Any excess of the cost of the acquisition over the fair values of the identifiable net assets acquired is recognised as goodwill. Goodwill is stated at cost less accumulated impairment losses. Goodwill is allocated to cash-generating units and is tested annually for impairment. Any excess of the Group's interest in fair values of the acquiree's identifiable assets, liabilities and contingent liabilities over the cost of a business combination is recognised immediately in the income statement.

Minority interests at the balance sheet date, being the portion of the net assets of subsidiaries attributable to equity interests that are not owned by the Company, whether directly or indirectly through subsidiaries, are presented in the consolidated balance sheet and statement of changes in equity within equity, separately from equity attributable to the equity shareholders of the Company. Minority interests in the results of the Group are presented on the face of the consolidated income statement as an allocation of the total profit or loss for the year between minority interests and the equity shareholders of the Company.

年內所收購附屬公司已按收購會計法入賬。此方法涉及將業務合併成本分配至於收購日期所收購資產以及所承擔負債及或然負債的公允價值。收購成本按於交易日期所給予資產、所發行股本工具及所產生或承擔負債的公允值總額，另加收購直接應佔成本計算。

收購成本超出所收購可識別資產淨值公允值的任何差額確認為商譽。商譽按成本減累計減值虧損列賬。商譽會分配至現金產生單位，並每年進行減值測試。本集團應佔被收購方可識別資產、負債及或然負債公允值的權益超出業務合併成本的任何差額即時於收益表確認。

於結算日的少數股東權益(即並非由本公司直接或透過附屬公司間接擁有的股本權益應佔附屬公司資產淨值的部分)於綜合資產負債表及權益變動表呈列為權益，與本公司股東應佔權益分開呈列。於本集團業績之少數股東權益於綜合收益表呈列為少數股東權益與本公司股東間之年內盈利或虧損總額的分配。

Where losses applicable to the minority exceed the minority's interest in the equity of a subsidiary, the excess, and any further losses applicable to the minority, are charged against the Group's interest except to the extent that the minority has a binding obligation to, and is able to, make good the losses. If the subsidiary subsequently reports profits, the Group's interest is allocated all such profits until the minority's share of losses previously absorbed by the Group has been recovered.

(f) Impairment of non-financial assets

Where an indication of impairment exists, or when annual impairment testing for an asset is required (other than inventories, deferred tax assets and financial assets), the recoverable amount of the asset is estimated. An asset's recoverable amount is the higher of the value in use of the asset or cash-generating unit to which it belongs and its fair value less costs to sell, and is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets, in which case the recoverable amount is determined for the cash-generating unit to which the asset belongs.

An impairment loss is recognised only if the carrying amount of an asset exceeds its recoverable amount. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. An impairment loss is charged to the income statement in the period in which it arises.

倘適用於少數股東權益的虧損超出附屬公司權益的少數股東權益，則該超出數額及任何適用於少數股東權益的進一步虧損均自本集團權益扣除，惟少數股東權益具有約束性責任並可補償虧損者除外。倘附屬公司其後錄得盈利，則本集團之權益將分配至所有該等盈利，直至收回本集團先前承擔的少數股東權益應佔虧損為止。

(f) 非財務資產減值

倘有跡象顯示出現減值或須就資產(存貨、遞延稅項資產及財務資產除外)進行年度減值檢測，則會估計該資產之可收回金額。資產之可收回金額為該資產或其所屬現金產生單位之使用價值及其公允價值減出售成後之較高者，且按個別資產釐定，除非該資產主要依靠其他資產或組別資產而本身並無產生現金流入，在此情況下，可收回金額乃就資產所屬現金產生單位釐定。

減值虧損僅於資產賬面值超逾其可收回金額時確認。評估使用價值時，估計日後現金流量按可反映現時市場評估之貨幣時間價值及資產特定風險之稅前貼現率貼現至現值。減值虧損於產生期間自收益表扣除。

(f) Impairment of non-financial assets (continued)

An assessment is made at each reporting date as to whether there is any indication that previously recognised impairment losses may no longer exist or may have decreased. If such indication exists, the recoverable amount is estimated. A previously recognised impairment loss of an asset is reversed only if there has been a change in the estimates used to determine the recoverable amount of that asset, but not to an amount higher than the carrying amount that would have been determined (net of any depreciation/amortisation), had no impairment loss been recognised for the asset in prior years. A reversal of such impairment loss is credited to the income statement in the period in which it arises.

(g) Property, plant and equipment and depreciation

Property, plant and equipment are stated at cost, less provisions for depreciation and any impairment losses. Details are set out in note 12. The cost of an item of property, plant and equipment comprises its purchase price and any directly attributable cost of bringing the asset to its working condition and location for its intended use. Expenditure incurred after the item has been put into operation, such as repairs and maintenance and overhaul costs, is normally charged to the income statement in the year in which it is incurred. In situations where it can be clearly demonstrated that the expenditure has resulted in an increase in the future economic benefits expected to be obtained from the use of the item, the expenditure is capitalised as an additional cost of the item. When an item of property, plant and equipment is sold, its cost and accumulated depreciation are removed from the financial statements and any gain or loss resulting from the disposal, being the difference between the net disposal proceeds and the carrying amount of the asset, is included in the income statement.

(f) 非財務資產減值(續)

資產乃於各報告日期進行評估，以決定先前已確認之減值虧損是否有不再存在或已減少之跡象。倘出現該等跡象，則估計可收回金額。先前已確認之資產減值虧損僅會於用以釐定該資產可收回金額之估計改變時撥回，惟撥回後之數額不得高於假設過往年度並無就資產確認減值虧損而應有之賬面值(扣除任何折舊／攤銷)。該減值虧損之撥回於產生期間計入收益表。

(g) 物業、廠房及設備與折舊

物業、廠房及設備按成本值減折舊撥備及任何減值虧損入賬。詳情載於附註12。物業、廠房及設備項目之成本包括其購入價及將資產達至其運作狀況及地點作擬定用途之直接應佔成本。該項目投產後之開支(例如維修保養及大修費用)一般自產生年度之收益表扣除。倘能明確顯示該開支導致預期因使用該項目而產生之日後經濟利益增加，則該項目會予以資本化，列為該項目之額外成本。當物業、廠房及設備出售時，其成本及累計折舊則自財務報表中撇除，而出售產生之損益(即該資產出售所得款項淨額與賬面值之差額)將計入收益表內。

Depreciation is provided on the straight-line method, based on the estimated economic useful lives of the individual assets, as follows:—

(h) Leased assets

(i) Classification of assets leased to the Group

Assets that are held by the Group under leases which transfer to the Group substantially all the risks and rewards of ownership are classified as being held under finance leases. Leases which do not transfer substantially all the risks and rewards of ownership to the Group are classified as operating leases.

The leasehold interest in the land held for own use is accounted for as being held under an operating lease where the fair value of the interest in any buildings situated on the leasehold land could be separately identified from the fair value of the leasehold interest in the land at the time the lease was first entered into by the Group, or taken over from the previous lessee, or at the date of construction of those buildings, if later. In case the two elements cannot be allocated reliably, the entire lease is classified as a finance lease and carried at cost less accumulated depreciation and accumulated impairment losses.

(h) 租賃資產

(i) 本集團租賃資產之分類

本集團持有的租賃資產，如大部分相關風險及回報已轉讓至本集團，該租賃資產歸類為按融資租賃持有。並無轉讓所有權全部相關風險及回報的租賃，則歸類為經營租賃。

位於租賃土地之任何樓宇權益之公允值，可與本集團首次訂立租賃時，或從前度承租人接收時，或有關樓宇興建之日(以較遲者為準)之土地租賃權益之公允值分開確定，則持作自用之土地之租賃權益，乃作為根據一項營運租約而持有之權益處理。如未能可靠地分配上述兩個部分，則整項租賃列作融資租約處理，並按成本減累積折舊及累計減值虧損列賬。

(h) Leased assets (continued)

(ii) Assets acquired under finance leases

Where the Group acquires the use of assets under finance leases, the amounts representing the fair value of the leased assets, or, if lower, the present value of the minimum lease payments of such assets, are included in property, plant and equipment and the corresponding liabilities, net of finance charges, are recorded as obligations under finance leases. Depreciation is provided at rates which write off the cost or valuation of assets over the term of the relevant leases or, where it is likely the Group or the Company will obtain ownership of the assets, the life of the assets, as set out in note 1 (g) above. Impairment losses are accounted for in accordance with the accounting policy as set out in note 1 (f) above. Finance charges implicit in the lease payments are charged to income statement over the period of the leases so as to produce an approximately constant periodic rate of charge on the remaining balance of the obligations for each accounting period. Contingent rentals, if any, are charged to income statement in the accounting period in which they are incurred.

(iii) Operating lease charges

Where the Group has the use of assets held under operating leases, payments made under the leases are charged to income statement in equal instalments over the accounting periods covered by the lease term, except where an alternative basis is more representative of the pattern of benefits to be derived from the leased assets. Lease incentives received are recognised in income statement as an integral part of the aggregate net lease payments made. Contingent rentals, if any, are charged to income statement in the accounting period in which they are incurred.

(ii) 以融資租賃購入的資產

倘本集團按融資租賃獲得資產的使用權，則將相當於租賃資產公允值或最低租賃付款額的現值(如為較低數額)記入物業、廠房及設備，而扣除融資費用後的相應負債則列為融資租賃承擔。折舊是在相關的租賃期或資產的可用年限(如本公司或本集團很可能取得資產的所有權)內，以沖銷資產成本或估值的比率計提；有關可用年限載列於上文附註1(g)。減值虧損按照上文附註1(f)所列會計政策入賬。租賃付款內含的融資費用會計入租賃期內的收益表，致使每個會計期間的融資費用佔承擔餘額的比率大致相同。或有租金(如有)在其產生的會計期間計入收益表。

(iii) 經營租賃費用

如本集團透過經營租賃使用資產，則根據租賃作出的付款會在租賃期所涵蓋會計期間內，以等額在收益表扣除；但如有其他基準能更清楚地反映租賃資產所產生收益模式則除外。經營租賃協議所涉及優惠措施均在收益表中確認為租賃淨付款總額的組成部分。或有租金(如有)在其產生的會計期間內在收益表扣除。

(i) Investments in subsidiaries

Investments in subsidiaries are stated in the Company's balance sheet at cost less any identified impairment losses. Results of the subsidiaries are accounted for by the Company on the basis of dividends received and receivable.

(j) Inventories

Inventories are stated at the lower of cost and net realisable value. Cost is determined using the weighted average cost formula and comprises all costs of purchase, costs of conversion and other costs incurred in bringing the inventories to their present location and condition.

Net realisable value is the estimated selling price in the ordinary course of business less the estimated costs of completion and the estimated costs necessary to make the sale.

When inventories are sold, the carrying amount of those inventories is recognised as an expense in the period in which the related revenue is recognised. The amount of any write-down of inventories to net realisable value and all losses of inventories are recognised as an expense in the period the write-down or loss occurs. The amount of any reversal of any write-down of inventories is recognised as a reduction in the amount of inventories recognised as an expense in the period in which the reversal occurs.

於附屬公司之投資乃按成本減任何已識別減值虧損於本公司資產負債表入賬。附屬公司業績按已收及應收股息為基準計入本公司賬目。

(j) 存貨

存貨以成本及可變現淨值兩者中的較低數額列賬。成本以加權平均成本公式釐定，其中包括所有採購成本、加工成本及將存貨達至目前地點和現狀的成本。

可變現淨值是以日常業務過程中的估計售價減去完成生產及銷售所需估計成本後所得之數。

存貨出售時，該等存貨賬面金額在相關收入獲確認的期間內確認為支出。存貨數額撇減至可變現淨值及存貨的所有虧損，均在出現減值或虧損的期間內確認為支出。存貨的任何減值轉回之數，均在出現轉回的期間內確認為已列作支出的存貨數額減少。

(k) Financial instruments

Financial assets and financial liabilities are recognised in the balance sheet when a group entity becomes a party to the contractual provisions of the instrument. Financial assets and financial liabilities are initially measured at fair value. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities (other than financial assets and financial liabilities at fair value through profit or loss) are added to or deducted from the fair value of the financial assets or financial liabilities, as appropriate, on initial recognition. Transaction costs directly attributable to the acquisition of financial assets or financial liabilities at fair value through profit or loss are recognised immediately in the income statement.

Financial assets

The Group's financial assets include trade and other receivables and are classified and accounted for as loans and receivables. Financial assets are recognised on the trade date.

Loans and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market. Loans and receivables are initially recognised at fair value and subsequently measured at amortised cost using the effective interest method, less any impairment losses. Any changes in their value are recognised in the income statement.

Derecognition of financial assets occurs when the rights to receive cash flows from the financial assets expire or are transferred and substantially all of the risks and rewards of ownership have been transferred.

財務資產

本集團之財務資產(包括應收賬款及其他應收款)分類及入賬為貸款及應收款。財務資產於交易日確認。

貸款及應收款指並非於活躍市場報價而具備固定或可釐定款項之非衍生財務資產。貸款及應收款初步按公允值確認，其後採用實際利率法計算之已攤銷成本減任何減值虧損計量。其價值之任何變動會於收益表確認。

當自財務資產收取現金流量之權利屆滿或獲轉讓，且其所有權之絕大部分風險及回報已獲轉讓時，將終止確認財務資產。

Financial assets (continued)

An assessment for impairment is undertaken at least at each balance sheet date whether or not there is objective evidence that a financial asset or a group of financial assets is impaired. Impairment loss on loans and receivables is recognised when there is objective evidence that the Group will not be able to collect all the amounts due to it in accordance with the original terms of the receivables. The amount of the impairment loss is determined as the difference between the asset's carrying amount and the present value of estimated future cash flows.

Financial liabilities

The Group's financial liabilities include bank and other borrowings, and trade and other payables. Financial liabilities are recognised when the Group becomes a party to the contractual provisions of the instrument.

Financial liabilities are initially recognised at fair value, net of transactions costs incurred and subsequently measured at amortised cost using the effective interest method. Financial liabilities are derecognised when the obligation specified in the contract is discharged or cancelled, or expired.

(l) Dividends

Dividend distributions to the Company's shareholders are recognised as a liability in the Group's consolidated financial statements in the period in which the dividends are approved by the Company's shareholders.

財務負債

(m) Foreign currency translation

These financial statements are presented in Hong Kong dollars, which is the Company's functional currency. Each entity in the Group determines its own functional currency and items included in the financial statements of each entity are measured using that functional currency. Foreign currency transactions are initially recorded using the functional currency rates ruling at the date of the transactions. Monetary assets and liabilities denominated in foreign currencies are retranslated at the functional currency rates of exchange ruling at the balance sheet date. All differences are taken to the income statement. Non-monetary items that are measured in terms of historical cost in a foreign currency are translated using the exchange rates at the dates of the initial transactions. Non-monetary items measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value was determined.

The functional currencies of certain overseas subsidiaries are currencies other than the Hong Kong dollars. As at the balance sheet date, the assets and liabilities of these entities are translated into the presentation currency of the Company at the exchange rates ruling at the balance sheet date, and their income statements are translated into Hong Kong dollars at the weighted average exchange rates for the year. The resulting exchange differences are included in the exchange reserve. On disposal of a foreign entity, the deferred cumulative amount recognised in equity relating to that particular foreign operation is recognised in the income statement.

此等財務報表乃以本公司功能貨幣港元呈報。本集團各實體決定其本身功能貨幣，而計入各實體財務報表之項目乃採用該功能貨幣計量。外幣交易初步採用交易日期適用功能貨幣匯率記錄。以外幣為單位之貨幣資產及負債會按結算日適用之功能貨幣匯率重新換算。所有換算差額會於收益表處理。以外幣歷史成本計量之非貨幣項目，乃採用初始交易日期之匯率進行換算。以外幣公允值計量之非貨幣項目，則於公允值得以釐定當日之匯率進行換算。

若干海外附屬公司之功能貨幣為港元以外之貨幣。於結算日，該等實體之資產及負債會按結算日適用之匯率換算為本公司之呈報貨幣，而其收益表乃按年內加權平均匯率換算為港元。換算得出之兌匯差額計入匯兌儲備。出售海外實體時，與該海外業務有關並於權益確認之遞延累計金額會於收益表確認。

For the purpose of the consolidated cash flow statement, the cash flows of overseas subsidiaries are translated into Hong Kong dollars at the exchange rates ruling at the dates of the cash flows. Frequently recurring cash flows of overseas subsidiaries which arises throughout the year are translated into Hong Kong dollars at the weighted average exchange rates for the year.

(n) Provisions

Provisions are recognised for liabilities of uncertain timing or amount when the Company or Group has a legal or constructive obligation arising as a result of a past event, it is probable that an outflow of economic benefits will be required to settle the obligation and a reliable estimate can be made. Where the time value of money is material, provisions are stated at the present value of the expenditures expected to settle the obligation.

When the effect of discounting is material, the amount recognised for a provision is the present value at the balance sheet date of the future expenditures expected to be required to settle the obligation. The increase in the discounted present value amount arising from the passage of time is included in finance costs in the income statement.

Where it is not probable that an outflow of economic benefits will be required, or the amount cannot be estimated reliably, the obligation is disclosed as a contingent liability, unless the probability of outflow of economic benefits is remote. Possible obligations, whose existence will only be confirmed by the occurrence or non-occurrence of one or more future events are also disclosed as contingent liabilities unless the probability of outflow of economic benefits is remote.

倘貼現之影響重大，就撥備而確認之金額為於結算日預期履行義務所需未來開支之現值。因時間過去而引致之貼現現值增加將計入收益表內之財務費用。

(o) Employee benefits

- (i) Salaries, annual bonuses, paid annual leave, leave passage and the cost to the Group of non-monetary benefits are accrued in the year in which the associated services are rendered by employees of the Group. Where payment or settlement is deferred and the effect would be material, these amounts are stated at their present values.
- (ii) Contributions to Mandatory Provident Funds as required under the Hong Kong Mandatory Provident Fund Schemes Ordinance and contributions to the retirement schemes operated by the relevant authorities for employees of the subsidiaries in the People's Republic of China ("PRC") and Malaysia are recognised as an expense in the income statement as incurred, except to the extent that they are included in the cost of inventories not yet recognised as an expense.
- (iii) The Group's net obligation in respect of lump sum long service amounts payable on cessation of employment in certain circumstances under the Hong Kong Employment Ordinance is the amount of future benefit that employees have earned in return for their service in the current and prior periods. The obligation is calculated using the projected unit credit method by a qualified actuary, discounted to its present value, and the fair value of any related plan assets is deducted. The discount rate is the yield at balance sheet date on Exchange Fund Notes that have maturity dates approximating the terms of the Group's obligations.

- (i) Taxation for the year comprises current tax and movements in deferred tax assets and liabilities. Current tax and movements in deferred tax assets and liabilities are recognised in the income statement except to the extent that they relate to items recognised directly in equity, in which case they are recognised in equity.
- (ii) Current tax is the expected tax payable on the taxable income for the year, using tax rates enacted or substantively enacted at the balance sheet date, and any adjustment to tax payable in respect of previous years.
- (iii) Deferred tax assets and liabilities arise from deductible and taxable temporary differences respectively, being the differences between the carrying amounts of assets and liabilities for financial reporting purposes and their tax bases. Deferred tax assets also arise from unused tax losses and unused tax credits.

Apart from certain limited exceptions, all deferred tax liabilities, and all deferred tax assets to the extent that it is probable that future taxable profits will be available against which the asset can be utilised, are recognised. Future taxable profits that may support the recognition of deferred tax assets arising from deductible temporary differences include those that will arise from the reversal of existing taxable temporary differences, provided those differences relate to the same taxation authority and the same taxable entity, and are expected to reverse either in the same period as the expected reversal of the deductible temporary differences or in periods into which a tax loss arising from the deferred tax asset can be carried back or forward. The same criteria are adopted when determining whether existing taxable temporary differences support the recognition of deferred tax assets arising from unused tax losses and credits, that is, those differences are taken into account if they relate to the same taxation authority and the same taxable entity, and are expected to reverse in a period, or periods, in which the tax loss or credit can be utilised.

The limited exceptions to recognition of deferred tax assets and liabilities are those temporary differences arising from goodwill and the initial recognition of assets or liabilities that affect neither accounting nor taxable profit (provided they are not part of a business combination). In respect of taxable temporary differences arising on investments in subsidiaries, deferred tax liabilities are recognised except where the Group is able to control the reversal of the temporary differences and it is probable that the temporary differences will not reverse in the foreseeable future.

The amount of deferred tax recognised is measured based on the expected manner of realisation or settlement of the carrying amount of the assets and liabilities, using tax rates enacted or substantively enacted at the balance sheet date. Deferred tax assets and liabilities are not discounted.

The carrying amount of a deferred tax asset is reviewed at each balance sheet date and is reduced to the extent that it is no longer probable that sufficient taxable profit will be available to allow the related tax benefit to be utilised. Any such reduction is reversed to the extent that it becomes probable that sufficient taxable profit will be available.

(iv) Current tax balances and deferred tax balances, and movements therein, are presented separately from each other and are not offset. Current tax assets are offset against current tax liabilities, and deferred tax assets against deferred tax liabilities if, and only if, the Company or the Group has the legally enforceable right to set off current tax assets against current tax liabilities and the following additional conditions are met:—

- in the case of current tax assets and liabilities, the Company or the Group intends either to settle on a net basis, or to realise the asset and settle the liability simultaneously; or
- in the case of deferred tax assets and liabilities, if they relate to income taxes levied by the same taxation authority on either:—
 - the same taxable entity; or
 - different taxable entities, which, in each future period in which significant amounts of deferred tax liabilities or assets are expected to be settled or recovered, intend to realise the current tax assets and settle the current tax liabilities on a net basis or realise and settle simultaneously.

Provided it is probable that the economic benefits will flow to the Group and the revenue and costs, if applicable, can be measured reliably, revenue is recognised in the income statement as follows:–

(i) Sale of goods

Revenue is recognised when the customer has accepted the goods and the related risks and rewards of ownership. Revenue excludes value added tax or other sales taxes and is after deduction of any trade discounts and returns.

(ii) Rental income from operating leases

Rental income receivable under operating leases is recognised in the income statement in equal instalments over the accounting periods covered by the lease term, except where an alternative basis is more representative of the pattern of benefits to be derived from the leased asset. Lease incentives granted are recognised in the income statement as an integral part of the aggregate net lease payments receivable. Contingent rental are recognised as income in the accounting period in which they are earned.

(iii) Interest income

Interest income from bank deposits is accrued using the effective interest method by applying the rate that discounts the estimated future cash receipts through the expected life of the financial instrument to the net carrying amount of the financial asset.

(r) Borrowing costs

Borrowing costs are expensed as incurred except where they relate to the financing of major capital projects where they are capitalised up to the date that the assets are brought into a working condition for their intended use.

(s) Cash and cash equivalents

For the purpose of the consolidated cash flow statement, cash and cash equivalents comprise cash at bank and on hand, demand deposits with banks and other financial institutions, and short term highly liquid investments that are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value, having been within three months of maturity at acquisition, less advances from banks repayable within three months from the date of the advance. Bank overdrafts that are repayable on demand and form an integral part of the Group's cash management are also included as a component of cash and cash equivalents.

(t) Related parties

A party is considered to be related to the Group if:–

- (i) the party has the ability, directly or indirectly through one or more intermediaries, to control the Group or exercise significant influence over the Group in making financial and operating decisions, or vice versa, or where the Group and the party are subject to common control or common significant influence;

(u) Segment reporting

A segment is a distinguishable component of the Group that is engaged either in providing products or services (business segment), or in providing products or services within a particular economic environment (geographical segment), which is subject to risks and rewards that are different from those of other segments.

In accordance with the Group's internal financial reporting, the Group has chosen geographical segment information as the primary reporting format. No business segments analysis of the Group is presented as all the Group's turnover and trading result are generated from the manufacture, sale and marketing of jewellery products.

Segment revenue, expenses, results, assets and liabilities include items directly attributable to a segment as well as those that can be allocated on a reasonable basis to that segment. For example, segment assets may include inventories, trade receivables and fixed assets. Segment revenue, expenses, assets and liabilities are determined before intra-group balances and intra-group transactions are eliminated as part of the consolidation process, except to the extent that such intra-group balances and transactions are between group enterprises within a single segment.

Segment capital expenditure is the total cost incurred during the year to acquire segment assets that are expected to be used for more than one year.

Unallocated items mainly comprise financial and corporate assets, interest-bearing loans, borrowings, corporate and financing expenses.

分部資本開支指年內購入預計可使用超過一年的分部資產所產生成本總額。

未分配項目主要包括財務及企業資產、計息貸款、借款、企業和融資支出。

The Group participates in the Mandatory Provident Fund Scheme (the “MPF Scheme”) under the Hong Kong Mandatory Provident Fund Schemes Ordinance for employees employed under the jurisdiction of the Hong Kong Employment Ordinance. The MPF Scheme is a defined contribution retirement scheme administered by independent trustees. Under the MPF Scheme, the employer and its employees are each required to make contributions to the scheme at 5% of the employees’ relevant income, subject to a cap of monthly relevant income of HK\$20,000.

The Group also participates in defined contribution retirement benefits schemes for all qualifying employees in the People’s Republic of China (“PRC”) and Malaysia. The assets of the schemes are held separately from those of the Group in funds under the control of independent trustees.

The Group’s total contributions to these schemes charged to the consolidated income statement during the year ended 28 February 2009 amounted to HK\$5,050,000 representing contributions payable by the Group to the schemes at the appropriate rates set by the local government of the subsidiaries.

The primary objective of the Group's capital management is to safeguard the Group's ability to continue as a going concern and to maintain healthy capital ratios in order to support its business and maximise shareholder value.

The Group manages its capital structure and makes adjustments to it, in light of changes in economic conditions and the risk characteristics of the underlying assets. To maintain or adjust the capital structure, the Group may adjust the dividend payment to shareholders, return capital to shareholders or issue new shares. The Group has been imposed a capital requirement from the financial and bank creditors that the Group's equity to total assets ratio (consolidated tangible net worth plus minority interest divided by total tangible assets) is not less than 30%. As of 28 February 2009 and 29 February 2008, the Group has complied with this capital requirement. No changes were made in the objectives, policies or processes during the years ended 28 February 2009 and 29 February 2008.

The Group monitors capital using a debt to equity ratio, which is total borrowings divided by total equity of the Group. The Group's policy is to maintain the debt to equity ratio not greater than 100%.

The Company has been informed that the two directors who have been convicted have commenced proceedings to appeal the verdict (“the Appeal”).

Under the Company’s Bye-Laws, the Company may be required to indemnify its directors from and against all actions, costs, charges, losses, damages and expenses which they or any of them may incur in execution of their duty, provided that such indemnity shall not be extended to any matter in respect of, among other things, fraud and dishonesty.

The Directors are of the view that they are not in a position to conclude that whether and/or to what extent the Company may be required to indemnify the two directors involved in relation to the Appeal.

- (c) As at the balance sheet date, the disputes of certain subsidiaries with Inland Revenue Department (“IRD”) regarding the tax treatment of certain offshore income and agents commission payments and promoter fees for prior years are still undetermined. During the year, a subsidiary received additional assessment and proposed adjustments in relation to the dispute on the tax treatment of agent commission payments and promoter fees for prior years. The Group has established a total provision of approximately HK\$94 million for all the additional assessments issued and proposed by IRD in respect of such disputes. In the event that the Group is not successful in defending the tax treatments adopted, the Group may be subject to significant additional tax liabilities and possibly penalties which, under the provisions of the current tax legislation, may be up to three times any tax under-reported as assessed by the IRD. Furthermore, the verdict of the District Court of Hong Kong as mentioned in (b) above may or may not have impact on the IRD’s challenges on the tax treatments adopted by the Group relating to agents commission payments and promoter fees arising in prior years. The directors consider that it is impractical to estimate the potential amount of additional tax liabilities arising if the IRD’s challenge in respect of the offshore income, agent commission payments and promoter fees is successful.

The Group is exposed to a variety of risks including foreign currency risk, credit risk, liquidity risk and cash flow interest rate risk arising in the normal course of the Group's business activities.

The Group does not have any written risk management policies and guidelines. The directors monitor the financial risk management of the Group and take such measures as considered necessary from time to time to minimise such financial risks.

The Group mitigates this risk by conducting the sales and purchases transactions in the same currency, whenever possible.

In the opinion of the directors, the United States dollars is reasonably stable under the Linked Exchange Rate System with the Hong Kong dollars and accordingly, the Company does not have any significant foreign exchange risk.

At the balance sheet date, there were no major concentrations of credit risk.

The maximum exposure to credit risk is therefore represented by the carrying amount of each financial asset as stated in the balance sheet.

Cash is held with financial institutions of good standing.

Liquidity risk is the risk that an enterprise will encounter difficulty in raising funds to meet commitments associated with financial instruments. Liquidity risk may result from an inability to sell a financial asset quickly at close to its fair value.

Prudent liquidity risk management implies maintaining sufficient cash. The Group monitors and maintains a level of bank balances deemed adequate to finance the Group's operations.

The Group employs projected cash flow analysis to manage liquidity risk by forecasting the amount of cash required and monitoring the working capital of the Group to ensure that all liabilities due and known funding requirements could be met. In addition, banking facilities have been put in place for contingency purposes. (iv) Cash flow and fair value interest rate risk

Cash flow interest rate risk is the risk that future cash flows of a financial instrument will fluctuate because of changes in market interest rates. Fair value interest rate risk is the risk that the value of a financial instrument will fluctuate due to changes in market interest rates.

The Group's interest rate risk arises primarily from floating rate borrowings. The sensitivity analysis below have been determined assuming that change in interest rates had occurred at the balance sheet date and had been applied to the exposure to interest rates for financial instruments in existence at that date. A 1% increase or decrease is used when reporting interest rate risk internally to key management personnel and represents management's assessment of the reasonably possible change in interest rates.

If interest rates had been 1% higher/lower and all other variables were held constant, the Group's profit for the year ended 28 February 2009 and the retained profits as of 28 February 2009 would decrease/increase by HK\$265,000 (2008: decrease/increase by HK\$1,382,000).
