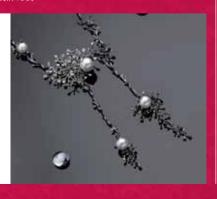

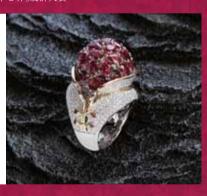

CHIEF EXECUTIVE'S STATEMENT 行政總裁報告

Dear Shareholders,

On behalf of Luk Fook Holdings (International) Limited ("Luk Fook" or "the Group"), I am pleased to present to you the Group's annual results for the year ended 31st March 2009.

Year 2008 was an exciting and challenging year. The Beijing Olympics offered opportunities for the expansion of our retail business in the PRC. However, in the fourth quarter, the world was hit and shocked by a financial crisis that posed a lot of uncertainties and adversities to the global economic environment. Thanks to our established brand name, our quality service and our exquisite product craftsmanship, we could maintain a satisfactory performance during the year under review. We could say that our business experienced an uninterrupted growth, especially in the PRC market as the PRC economy continued to stay strong amidst the global financial crisis.

Moving on to year 2009 we will continue to dedicate unceasing effort in promoting our business. We know that 2009 will be a challenging year for the retail industry. In such a challenging market environment, we believe that only the strongest brands win, and even gaining more in market share. Our long-term strategy is anchored on maximizing the earnings potential of our brand. Our growth objectives are clear: to develop our brand mainly in the PRC and Hong Kong and extend them into global platform.

各位股東:

本人謹代表六福集團(國際)有限公司(「六福」或「本集團」)欣然提呈本集團截至2009年3月31日止年度之全年業績。

2008年為充滿刺激及挑戰的一年。北京奧運為本 集團於中國的零售業務帶來擴展機會。然而, 踏入第四季,金融危機突然爆發,令全球經濟環 境增添不少不明朗因素及衝擊。全賴本集團建立 多年之品牌、優質服務及精細手工,本集團於回 顧年度仍能維持理想業績。本集團之業務繼續錄 得增長,特別是中國市場,在爆發環球金融危機 下,中國經濟仍維持強勁發展。

踏入2009年,本集團將繼續全力拓展業務。2009 年對零售業而言無疑將具相當挑戰,而在此充滿 挑戰之市況,本集團相信市場趨於優勝劣汰,強 者更可乘勢爭佔更大市場佔有率。本集團之長遠 策略以盡量擴大品牌盈利潛力為重心,並維持清 晰增長目標一集中於中國及香港發展品牌,及擴 展至世界級平台。



Our retail stores are well positioned given the recent economic shifts. Our presence in China became more successful in 2008, and that has motivated us to expand further. With more than 470 stores globally, scattering in the PRC, Hong Kong, Macau, Canada and the United States, we are offering customers the products at exceptional value.

The Group acquired the whole block of commercial building in Jordan district, Hong Kong in June 2009 with consideration of HK\$254,350,000. The Group intends to use part of the property as its head office, and it will also use the remaining portion of the property to provide office, show room and other related facilities for business partners. In addition, the Group opened a retail outlet in Nathan Road, Tsim Sha Tsui, Hong Kong in June 2009, bringing the total number of retail outlets in Hong Kong to 31 at present. The Group will also open another retail outlet in Star House, Tsim Sha Tsui, in September 2009, in the hope of expanding its sales network in local tourist district.

近期經濟波動不定,本集團之零售店已作好準 備。本集團於中國之發展於2008年更趨成功,為 本集團進一步擴展業務增添信心。本集團於全 球設有超過470間零售店,遍佈中國、香港、澳 門、加拿大及美國,故能以超值價格向客戶提供 優質產品。

本集團於2009年6月以254,350,000港元購入一幢 位於香港佐敦之商業大廈全幢,並計劃將部分作 為集團總部,餘下之部分則用作提供辦公室、展 銷廳及其他有關設施予商業夥伴。此外,本集團 亦於同月於香港尖沙咀彌敦道開設1間零售店, 使本集團於香港經營之店舖數目增至31間。並計 劃於今年9月份,於尖沙咀星光行再增設新店, 擴大集團於本港遊客區的銷售網絡。

I am also glad to announce the Group's wholly owned subsidiary, "China Gems Laboratory Limited", is being accredited the ISO17025 accreditation on diamond testing by the Hong Kong Accreditation Services in April 2009. Laboratories passing assessment procedures can issue reports of diamond authentication bearing the Hong Kong Laboratory Accreditation Scheme (HOKLAS) logo. It is a proof of authority for the authentication reports of diamonds that the laboratory tests, and also strengthens the confidence of consumers, jewellery traders and manufacturers in Hong Kong diamond products. Together with the ISO17025 accreditation on jadeite testing obtained in 2005, the laboratory is the only jewellery authentication laboratory obtaining both accreditations in Hong Kong, signifying authentication professionals, authentication facilities and management systems of "China Gems Laboratory" reach first class international standards.

本人亦欣然宣佈,集團旗下之全資附屬公司「中華珠寶鑑定中心」於2009年4月獲香港認可處頒發ISO17025鑽石測試評級認證。凡成功通過考核的鑑定所,日後可發出具有香港實驗所認可計劃(HOKLAS)標誌的鑽石測試證書,為其所測試的鑽石提供具公信力的證明,從而加強消費者及珠寶貿易和製造商對本港鑽石產品的信心。加上早於2005年已獲取的ISO17025翡翠鑑定認證,該中心成為現時全港唯一同時擁有此兩項認證之珠寶鑑定中心,並表示「中華珠寶鑑定中心」的鑑定師、鑑定設備及管理制度皆達國際一級水平。

OUTLOOK

Looking ahead, the Group shall concentrate its effort on developing the PRC market. The new policy of "one issuance, multiple entries" for Shenzhen residents and the promotion of domestic consumption by the PRC government provided favourable factors to the Group's business. In addition, economic growth was sustained in the PRC economy despite the financial crisis. The Group sees great potential in the development of the PRC market and is determined to further increase its market share in the PRC.

前景

MANAGEMENT DISCUSSION AND ANALYSIS 管理層討論及分析

FINANCIAL PERFORMANCE

Results

For the year ended 31st March 2009, the Group's total turnover was approximately HK\$3,856,984,000, which represented a 14.5% growth as compared to HK\$3,367,182,000 in the previous year. Profit attributable to shareholders dropped 12.4% to approximately HK\$275,160,000 from HK\$313,989,000 of last year. Operating profit margin decreased from 11.1% to 8.3%. Basic earnings per share were HK 55.9 cents (2008: HK 63.8 cents).

Dividend

The Directors proposed a final dividend of HK 12 cents per share (2008: HK 15.5 cents per share) for the year ended 31st March 2009. In addition to the interim dividend of HK 5 cents per share already paid, the dividend for the full year amounted to HK 17 cents per share (2008: HK 25.5 cents per share). The proposed dividend will be paid on 11th September 2009 following the approval at the Annual General Meeting.

Overview

The overall performance in the financial year 2008/09 was satisfactory. The Group's total turnover maintained a growth in face of the slowing down of the economy. The economy of the PRC stayed strong in spite of the global financial crisis. Appreciation of Renminbi and the continued influx of the PRC tourists benefited the Group's retail business.

The Group's turnover from the retail business accounted for 79.7% of the total turnover, registering a 23% growth compared to the previous year, amounting to HK\$3,075,565,000. Sales for gemstone jewellery products increased by 6.3% while sales for gold products excluding trade-in transactions surged by 42.2% because customers see gold as a more reliable investment product than currencies and the stock market. Turnover from wholesale business reached HK\$777,870,000, which accounted for 20.2% of the total turnover. For the year ended 31st March 2009, the Group's turnover in gold products and gemstone jewellery products, excluding trade-in transactions, accounted for 54% and 46% respectively.

From the figures of the Hong Kong Tourism Board, tourists arrivals from the PRC in 2008 increased by 11.9% as compared to that of 2007. The increase in the number of the PRC tourists visiting Hong Kong offset the negative effect that the financial crisis caused on their spending habits. The Group therefore could still benefit from the growing number of the PRC tourists who demanded for luxury and quality jewellery items in Hong Kong.

財務表現

業績

截至2009年3月31日止年度,本集團總營業額約為3,856,984,000港元,較去年3,367,182,000港元增長14.5%。股東應佔溢利由去年313,989,000港元下跌12.4%至約275,160,000港元。經營溢利率由11.1%減少至8.3%。每股基本盈利為55.9港仙(2008年:63.8港仙)。

股息

董事建議就截至2009年3月31日止年度派發末期股息每股12港仙(2008年:每股15.5港仙),連同已派發的中期股息每股5港仙,全年股息合共為每股17港仙(2008年:每股25.5港仙)。擬派股息於股東週年大會獲批准後,將於2009年9月11日支付。

概覽

2008/09財政年度整體表現令人滿意。儘管經濟放緩,本集團總營業額仍能維持增長。即使面對環球金融海嘯,中國經濟仍保持強勁。本集團的零售業務受惠於人民幣升值及訪港中國旅客人數持續上升。

本集團來自零售業務的營業額佔總營業額79.7%,較去年增長23%,為3,075,565,000港元。珠寶首飾產品的零售額增加6.3%,黃金產品的零售額(扣除回購交易)則飆升42.2%,原因為客戶認為相對貨幣及股市而言,黃金為較可靠的投資產品。來自批發業務的營業額達777,870,000港元,佔總營業額20.2%。於截至2009年3月31日止年度,黃金產品及珠寶首飾產品(扣除回購交易)分別佔本集團營業額54%及46%。

從香港旅遊發展局的數字顯示,來自中國的訪港旅客於2008年較2007年增加11.9%。中國訪港旅客人數增加,抵銷了金融海嘯對旅客消費習慣的負面影響。因此,令本集團繼續受惠於與日俱增來港購買高價優質珠寶的中國旅客人數。

BUSINESS PERFORMANCE

Hong Kong Market

The Hong Kong market remained the key market of the Group, taking up 80.7% of the Group's total turnover. As at 31st March 2009, the Group operated a total of 30 retail outlets in Hong Kong. During the year under review, the Group opened two self-operated shops in Tseung Kwan O and Causeway Bay, Hong Kong. The Group has mostly finished reimaging all retail outlets in Hong Kong during the year under review.

Over 50% of Hong Kong sales were contributed by the PRC tourists. The appreciation of Renminbi and the opening up of second and third tier cities in the PRC for Individual Visiting Scheme benefited the Group. In the year under review, the global financial crisis weakened the purchasing desire of local customers, but the increasing demand for gold products for marriage and investment purposes from the PRC tourists sustained the Group's business.

PRC Market

The Group's business benefited greatly from the strong growth of the PRC economy as well as the Beijing Olympic Games. The Group will focus its efforts on developing the PRC market as the major market contributor. During the year under review, turnover from the PRC market accounted for 11.7% of the Group's total turnover, amounting to HK\$449,472,000 (2008: HK\$263,064,000), representing a 71% increase as compared to the previous year.

As at 31st March 2009, the Group operated a total of 400 licensee shops. The Group has also opened up 8 self-operated shops in first tier cities in the PRC including Beijing, Wuhan, Hangzhou and Nanjing in the year under review, bringing the total number of self-operated shops in the PRC to 19. The Group shall further expand in the PRC market by opening self-operated shops in second and third tier cities.

業務表現

香港市場

香港市場繼續為本集團的主要市場,佔本集 團總營業額80.7%。截至2009年3月31日,本 集團於香港經營合共30間零售店。於回顧年 度,本集團於香港將軍澳及銅鑼灣開設2間 自營店。於回顧年度,本集團已完成大部分 香港零售店翻新。

香港業務的營業額逾50%來自中國旅客。人 民幣升值及個人遊計劃伸展至中國二綫及三 綫城市,亦令本集團從中受惠。於回顧年 度,環球金融海嘯減弱了本地消費者的購買 意欲,中國旅客購買黃金產品作婚嫁及投資 目的之需求增多,有助維持本集團的業務發 展。

中國市場

本集團業務大大受惠於中國經濟強勁增長 及北京奧運。本集團將集中發展中國市場 為主要市場。於回顧年度內,中國內地市 場佔總營業額11.7%,與去年同期相比, 上升71%,為449,472,000港元(2008年: 263,064,000港元)。

迄2009年3月31日止,本集團經營合共400間 品牌店,亦於回顧年度在北京、武漢、杭州 及南京等中國一綫城市開設8間自營店,將 中國自營店總數增加至19間。本集團將於二 綫及三綫城市開設自營店, 進一步擴展中國 市場。

Macau Market

For the Macau market, the Group held an optimistic view in the retail industry of Macau. The business performance of the Macau shops was satisfactory during the year under review. The Group opened its fourth retail outlet in Macau in December 2008. Turnover from the Macau shops amounted to HK\$268,411,000 (2008: HK\$151,415,000), representing a 77% increase as compared to the previous year.

Overseas Market

The Group will continue to work according to the corporate motto of "Brand of Hong Kong, Sparkling the World", to expand our retail network in local, Macau and the PRC markets, and to look for suitable opportunities to broaden our network internationally.

對於澳門市場,本集團對澳門零售業抱樂觀態度。於回顧年度,澳門零售店的業務表現理想。本集團於2008年12月開設澳門第4間零售店。來自澳門零售店的營業額為268,411,000港元(2008年:151,415,000港元),較去年增加77%。

海外市場

本集團將秉持「香港名牌 國際演繹」的企業宗旨,繼續擴展本集團於本地、澳門及中國市場的 零售網絡,並抓緊適當機會進一步擴展國際網絡。

Sales Network

As at 31st March 2009, the Group had 55 wholly owned retail outlets under the brand name of "Luk Fook Jewellery" in the PRC, Hong Kong, Macau, the United States and Canada. Besides, the Group operated a retail outlet namely "Luvina Jewelers" in San Jose, California of the United States. 2 new shops were opened in Hong Kong during the year: they are located at Tseung Kwan O and Causeway Bay respectively, bringing the number of shops in Hong Kong to a total of 30. The Group also opened its fourth retail outlet in Macau located at Avenida Do Infante D.Henrique, to cater for the growing demand of customers.

During the year, the Group operated a total of 19 self-operated shops in Guangzhou, Beijing, Nanjing, Shanghai, Hangzhou, Lanzhou, Ningbo, Wuhan and Jinan in the PRC. Nine of them are located in Beijing, taking the advantages of domestic retail industry brought about by the Beijing Olympics. Moreover, majority of the self-operated shops were opened in large-scale department stores to accommodate the consumption behavior of the PRC customers. The Group's licensee shops in the PRC were also increased to 400.

Marketing and Promotion

To further strengthen Luk Fook's corporate brand image and operate consistently with the corporate motto of "Brand of Hong Kong, Sparkling the World", the Group actively participated in a wide range of marketing activities and publicity campaigns in order to further consolidate its brand positioning, increase its popularity and facilitate the expansion of its global retail network. Meanwhile, the Group also adopted both long-term and creative marketing strategies in its key markets to publicize its revamped brand image to more customer segments and also boost sales.

During the year, the Group continued to actively design and execute various initiatives including TV, print, outdoor and internet advertising, direct marketing, public relations activities, and events such as jewellery sponsorship and exhibitions. Below are some highlights:

年內,本集團於中國廣州、北京、南京、上海、杭州、蘭州、寧波、武漢及濟南共經營19間自營店,其中9間位於北京,以抓緊北京奧運為當地零售市場帶來的有利商機。此外,大部分自營店均開設於大型百貨公司內,以配合中國顧客的消費模式。本集團於中國的品牌店亦增至400間。

Production

In order to enhance cost effectiveness and production efficiency, the Group has adopted a certain degree of vertical integration and utilized its production facilities in Hong Kong and the PRC to operate a portion of the gold and gemset jewellery's production processes.

Portal Operation

The Group's website "www.jewellworld.com" or "www.jw28.com" is an electronic gateway for the global jewellery industry. It aims to serve as a business-to-business trading platform among manufacturers, wholesalers and retailers all over the world.

The portal also acts as an additional promotion channel for the Group. It is regarded as a long-term plan for the Group to penetrate into the PRC as well as global market, and paves the way for exploring jewellery markets worldwide. The Group believes that every internet user is their potential customer; and jewelers will use website more frequently to view product samples and to order jewellery as to streamline their operation procedures. It will enhance business potential.

Design

The Group is famous for its stylish designs of jewellery products. With the Group's outstanding and award-winning design team, the Group has designed a wide range of products for customers' selections. Those creative, attractive and fashionable new products were well received by the markets all these years. On top of that, with the Group's experienced management team, the Group has proved to be capable of anticipating changes in the consumers' tastes and preferences, this has helped to ensure a promising future for the Group.

The Group was also keen on participating in various local and international jewellery design competitions during the year. A number of awards were gained in these competitions, which included:

設計

Quality Assurance

The Group is committed to maintain the highest levels of product quality. To ensure the best quality of products, the Group set up its wholly owned subsidiary gems laboratory "China Gems Laboratory Limited" in 1996. Its scope of services includes authentication, grading of diamonds, and authentication of jades and colored gemstones and quality assessment of jewellery. The Laboratory is operated by a group of certified gemologists who specialize in the authentication of gemstones and jade. With the ISO 17025 accreditation on both diamond and jadeite testing from the Hong Kong Accreditation Service, the Laboratory has also successfully met the principles of ISO 9001:2000 Quality Management Systems – Requirements, demonstrating the professional quality assurance system of the Group. China Gems Laboratory is the only jewellery authentication laboratory obtaining both accreditions in Hong Kong.

Environmental Protection

In response to the growing corporate awareness in environmental protection and to show the determination to save our planet, the Group joined the Earth Hour 2009. It is initiated by WWF in 2007, had 2.2 million people and 2,100 businesses in Sydney, Australia turned off their lights for one hour. On 28th March 2009, as one of the participants representing Hong Kong, part of the Group's retail outlets turned off the lights for one hour from 8:30pm to 9:30pm to show our support.

FINANCIAL REVIEW

Liquidity and Financial Resources

The Group's core business is gold and jewellery retailing. As at 31st March 2009, the Group's cash on hand reached approximately HK\$280 million (2008: HK\$185 million). The Group's bank borrowings-to-equity ratio at the year-end, being the proportion of total bank borrowings of approximately HK\$169 million (2008: HK\$273 million) against total shareholders' equity of approximately HK\$1,256 million (2008: HK\$1,082 million), was 13.5% (2008: 25.2%).

The Group's income and expenditure streams are mainly denominated in Hong Kong dollars.

質量保證

本集團致力維持產品優秀品質。為確保產品的最佳質素,本集團於1996年成立全資附屬公司一中華珠寶鑑定中心。中華珠寶鑑定中心的服務範圍包括鑽石鑑定、評級,以及翡翠及有色寶石鑑定及珠寶質量評估。該中心由一班專門鑑定寶石及翡翠的認可寶石鑑定師運作。除獲香港認可處頒發ISO 17025鑽石測試評級及翡翠鑑定認證外,該中心亦成功符合ISO 9001:2000品質管理系統的準則,足證本集團的品質保證系統達致專業水平。中華珠寶鑑定中心為全港唯一同時獲得此兩項認證的珠寶鑑定中心。

環境保護

因應企業日益提高環境保護的意識,以及為表救地球的決心,本集團參加「地球一小時2009」。該活動由世界自然基金會於2007年在澳洲悉尼發起,有2,200,000人及2,100家企業參與關燈一小時。於2009年3月28日,作為香港其中一個代表,本集團一部分的零售店由下午8:30至下午9:30關燈一小時,以表達對此活動的支持。

流動資金及財務資源

Capital Expenditure

During the year under review, the Group incurred capital expenditures of approximately HK\$30 million (2008: HK\$52 million), including the costs of properties, leasehold improvement, furniture, fixture and equipment.

Capital Commitments

As at 31st March 2009, the Group had total capital commitments in respect of acquisition of property, plant and equipment of approximately HK\$1 million (2008: HK\$4 million).

Contingent Liabilities

The Group did not have any significant contingent liabilities at 31st March 2009 and 31st March 2008.

Employment, Training, Development and Recruitment Remuneration Policy

As at 31st March 2009, the number of employees of the Group was approximately 2,445 (2008: 2,377). Remuneration policies are reviewed and approved by the management on a regular basis. Remuneration packages are structured to take into account the comparable level of the market. Bonus and other merit payments are linked to the success of the Group and the performance of individual employee. The policy is to encourage employees to optimize business performance by providing them with financial incentives.

For the year ended 31st March 2009, the Company had properly applied the principles of the Code on Corporate Governance Practices contained in Appendix 14 (the "Code") included in the Rules governing the listing of securities on The Stock Exchange of Hong Kong Limited (the "Listing Rules") as follows:

A. Directors

- A.1 The Company is supervised by a Board of Directors who assumes responsibility for leadership and control of the Company and is collectively responsible for promoting the success of the Company by directing and strategising the Company's affairs. They make decisions objectively in the interests of the Company.
- A.2 An independent non-executive director acts as the Board Chairman while an executive director acts as the Chief Executive. There is a clear division of responsibilities for the management of the Board and the day-to-day management of the Company's business to ensure a balance of power and authority.
- A.3 The Board comprises 6 executive directors, 5 non-executive directors and 3 independent non-executive directors. They include persons with a wealth of practical experiences in the jewellery industry, accountancy profession, legal profession, general trading and the securities industry. It has a balance of skills and experiences appropriate for the requirements of the Company's business. The directors' respective roles and biographies are set out on pages 40 to 44.
- A.4 All directors are subject to retirement by rotation and re-election at the Company's annual general meeting in accordance with the Company's Bye-laws.
- A.5 Every director is continuously-reminded of the requirement to keep abreast of his responsibility as a director of the Company, with reference to the Listing Rules and the Company Laws inclusive, and of the conduct, business activities and development of the Company. Every independent non-executive director also confirms annually his independence status to the Company pursuant to the Listing Rules.
- A.6 Directors are provided with appropriate information to enable them to make an informed decision and to discharge their duties and responsibilities as directors of the Company.

B. Remuneration of Directors and Senior Management

B.1 Information relating to the Company's directors' remuneration policy and other remuneration related matters are disclosed in the Company's annual report. The Remuneration Committee is responsible for setting policy on the remuneration of executive directors and senior management and for fixing the remuneration packages. The level of remuneration is sufficient to attract and retain the directors needed to run the Company successfully. No director is involved in deciding his own remuneration.

C. Accountability and Audit

- C.1 The directors are responsible for preparing the financial statements of each financial period, which give a true and fair view of the state of affairs of the Company and of the Group as at the financial period end and of the result and cash flows of the Group for the year. In the Company's interim and annual reports which are issued within the time limits stipulated by the Listing Rules, the Board presents a balanced, clear and comprehensive assessment of the Company's performance, position and prospects. The published financial statements adopt, and consistently apply, suitable accounting policies complying with Hong Kong Financial Reporting Standards.
- C.2 The Board ensures the Company maintains sound and effective internal control to safeguard the shareholders' interest and the Company's assets. The Audit Committee, with the assistance of the Internal Audit Team, regularly reviews the effectiveness of the Company's internal control system. The Head of the Internal Audit Team directly reports to the Audit Committee.
- C.3 The Board establishes monitoring and procedural guidelines for considering how it will apply the financial reporting and internal control principles and for maintaining an appropriate relationship with the Company's external auditors. The Audit Committee established by the Company pursuant to the Listing Rules has clear terms of reference.

D. Delegation by the Board

- D.1 The Company has a formal schedule of matters specifically reserved to the Board for its decision. The Board gives clear directions to management as to the matters that must be approved by the Board before decisions are made on behalf of the Company.
- D.2 The Audit Committee and Remuneration Committee were formed with specific written terms of reference that deal clearly with the committees' authority and duties. Such terms of reference are made available to the public.

- E.1 The Board maintains an on-going dialogue with shareholders and in particular, endeavors to provide transparency and uses the annual general meetings to communicate with shareholders and invites their participation in certain marketing events. Besides, the Company's official website serves as a handy communication channel for the shareholders. Press releases and announcements about the Company's business affairs are made from time to time.
- E.2 The Company informs shareholders of the procedure for voting by poll in the circular to shareholders, and ensures compliance with the requirements about voting by poll contained in the Listing Rules and the Company's Bye-laws.

None of the directors is aware of any information that would reasonably indicate that the Company is not, or was not for any part of the year ended 31st March 2009, in compliance with the Code.

DIRECTORS' SECURITIES TRANSACTIONS

The Company adopts the Model Code set out in Appendix 10 of the Listing Rules as a code of conduct regarding directors' securities transactions. Having made specific enquiry of all directors, it is confirmed that they have complied with the required standard set out in the Model Code and its code of conduct regarding directors' securities transactions in relation to the year ended 31st March 2009.

The Board's role is to provide entrepreneurial leadership of the Company within a framework of prudent and effective controls which enables risk to be assessed and managed. The Board controls the business but delegates day-to-day responsibility to the executive management. The Board sets the Company's strategic aims, values and standards and ensures that its obligations to its shareholders and others are understood and met. In the interests of the Company, a number of matters are reserved by the Board. Certain matters are the subject of recommendations by the Audit Committee or Remuneration Committee. The Company Secretary, referring to the list of reserved matters for the Board, assists the Chairman in establishing the agenda of Board meetings. Each director may also request inclusion of items in the agenda. Minutes of the Board/Committee meetings are open for inspection by the directors.

The Company confirms that it has received from each of the independent non-executive directors, namely, Mr. LO Man Lam, Raymond, Mr. HUI Chiu Chung, JP and Mr. TAI Kwok Leung, Alexander, an annual confirmation of his independence pursuant to Rule 3.13 of the Listing Rules, and that it still considers each independent non-executive director to be independent.

CHAIRMAN AND CHIEF EXECUTIVE

Mr. LO Mun Lam, Raymond, an independent non-executive director, acts as Chairman of the Board, while Mr. WONG Wai Sheung, an executive director, acts as the Chief Executive. Their roles are segregated and therefore are not exercised by the same individual. The Chairman is responsible for the leadership and effective running of the Board. The Chief Executive is delegated with the authority and responsible for running the Company's business, implementing the Company's strategies in achieving business objectives.

INTERNAL CONTROL

The Board is responsible for the Company's system of internal control and for reviewing its effectiveness through the Audit Committee.

The internal control system is designed to provide assurance on the effectiveness and efficiency of operations, reliability of business record, and the compliance with Company's policies and procedures.

The system aims to provide reasonable, but not absolute, assurance against material misstatement or loss rather than eliminate risks of failure in operational systems, and to ensure achievement of the Company's objectives.

The Audit Committee has received the internal control evaluation report submitted by the Internal Audit Team. The report summarised information relating to the work carried out in the following areas:

- The results of selective testing of internal control procedures, assets, and financial records of the Company;
- A general evaluation of internal control system installed by the Company; and
- An outline of major control issues, if any noticed during the year.

The Audit Committee has reviewed the report and discussed with the management.

The internal audit is an independent function undertaken by the Internal Audit Team reporting administratively to the Company's management and functionally to the Audit Committee. The Internal Audit Team is authorized to obtain all information necessary to accomplish internal audit work.

A risk based audit approach has been adopted by the Internal Audit Team. Internal control reviews are arranged regularly while paying close attention to business or operation changes. Regular audit tests are carried out to ensure key controls are operational. The Internal Audit Team conducts other projects and investigating work as may be required.

1 **GENERAL INFORMATION**

Luk Fook Holdings (International) Limited (the "Company") was incorporated in Bermuda on 3rd September 1996 as a company with limited liability under the Companies Act of Bermuda. The address of its registered office is Canon's Court, 22 Victoria Street Hamilton HM 12 Bermuda.

The Company and its subsidiaries (collectively referred to as the "Group") are principally engaged in the retailing and wholesaling of gold jewellery and gold ornaments, gem-set jewellery and gemstones and other accessory items.

The Company's shares are listed on the main board of The Stock Exchange of Hong Kong Limited (the "Stock Exchange").

These consolidated financial statements are presented in Hong Kong dollars ("HK\$"), unless otherwise stated, and have been approved for issue by the board of directors on 22nd July 2009.

2 **BASIS OF PREPARATION**

The consolidated financial statements of the Company have been prepared in accordance with Hong Kong Financial Reporting Standards ("HKFRS"). The consolidated financial statements have been prepared under the historical cost convention except that certain financial assets and financial liabilities are measured at fair value, as appropriate.

The preparation of financial statements in conformity with HKFRS requires the use of certain critical accounting estimates. It also requires management to exercise its judgment in the process of applying the Group's accounting policies. The areas involving a higher degree of judgment or complexity, or areas where assumptions and estimates are significant to the consolidated financial statements, are disclosed in Note 5.

HKFRS 8 replaces HKAS 14 and aligns segment reporting with the requirements of the US standard SFAS 131, "Disclosures about segments of an enterprise and related information". The new standard requires a "management approach", under which segment information is presented on the same basis as that used for internal reporting purposes. The Group will apply HKFRS 8 from 1st April 2009. The expected impact is still being assessed in detail by management, but it appears likely that the number of reportable segments, as well as the manner in which the segments are reported, will change in a manner that is consistent with the internal reporting provided to the chief operating decision-maker.

The effect that the adoption of HKFRS 3 (Revised), HKAS 27 (Revised) and HK(IFRIC)-Int 17 will have on the results and financial position of the Group will depend on the incidence and timing of business combinations occurring on or after 1st April 2010. The directors anticipate that the adoption of other new standards, amendments and interpretations to standards will not result in a significant impact on the results and financial position of the Group.

In addition, the Hong Kong Institute of Certified Public Accountants also published a number of amendments for the existing standards under its annual improvement project. These amendments are not expected to have a significant financial impact on the results and financial position of the Group.

3 SUMMARY OF SIGNIFICANT ACCOUNTING **POLICIES**

The principal accounting policies applied in the preparation of these consolidated financial statements are set out below. These policies have been consistently applied to all the years presented, unless otherwise stated.

Consolidation (a)

The consolidated financial statements include the financial statements of the Company and its subsidiaries made up to 31st March.

(*i*) Subsidiaries

Subsidiaries are entities over which the Group has the power to govern the financial and operating policies generally accompanying a shareholding of more than one half of the voting rights. The existence and effect of potential voting rights that are currently exercisable or convertible are considered when assessing whether the Group controls another entity. Subsidiaries are fully consolidated from the date on which control is transferred to the Group. They are de-consolidated from the date that control ceases.

The purchase method of accounting is used to account for the acquisition of subsidiaries by the Group. The cost of an acquisition is measured as the fair value of the assets given, equity instruments issued and liabilities incurred or assumed at the date of exchange, plus costs directly attributable to the acquisition. Identifiable assets acquired and liabilities and contingent liabilities assumed in a business combination are measured initially at their fair values at the acquisition date, irrespective of the extent of any minority interests. The excess of the cost of acquisition over the fair value of the Group's share of the identifiable net assets acquired is recorded as goodwill. If the cost of acquisition is less than the fair value of the net assets of the subsidiary acquired, including any contingent liabilities assumed, the difference is recognised directly in the consolidated income statement.

Inter-company transactions, balances and unrealised gains on transactions between group companies are eliminated. Unrealised losses are also eliminated unless the transaction provides evidence of an impairment of the asset transferred. Accounting policies of subsidiaries have been changed where necessary to ensure consistency with the policies adopted by the Group.

In the Company's balance sheet, the investments in subsidiaries are stated at cost less provision for impairment losses. The results of subsidiaries are accounted for by the Company on the basis of dividend received and receivable.

(ii) Transactions with minority interests

The Group applies a policy of treating transactions of equity interest in a subsidiary with minority interests as transactions with parties external to the Group. Disposals of equity interest in a subsidiary owned by the Group to minority interests result in gains or losses for the Group are recorded in the income statement. Purchases of equity interest in a subsidiary not already owned by the Group from minority interests result in goodwill, being the difference between any consideration paid and the relevant share acquired of the carrying value of net assets of the subsidiary.

(iii) Associates

Associates are entities over which the Group has significant influence but not control, generally accompanying a shareholding of between 20% and 50% of the voting rights. Investments in associates are accounted for using the equity method of accounting and are initially recognised at cost. The Group's investment in associates includes goodwill (net of any accumulated impairment loss) identified on acquisition.

(c) Foreign currency translation

- Items included in the financial statements of each of the Group's entities are measured using the currency of the primary economic environment in which the entity operates (the "functional currency"). The consolidated financial statements are presented in HK\$, which is the Company's functional and presentation currency.
- (ii) Transactions and balances

 Foreign currency transactions are translated into the functional currency using the exchange rates prevailing at the dates of the transactions.

 Foreign exchange gains and losses resulting from the settlement of such transactions and from the translation at year-end exchange rates of monetary assets and liabilities denominated in foreign currencies are recognised in the income statement.

(iii) Group companies

The results and financial position of all the group entities (none of which has the currency of a hyperinflationary economy) that have a functional currency different from the presentation currency are translated into the presentation currency as follows:

- assets and liabilities for each balance sheet presented are translated at the closing rate at the date of that balance sheet;
- (2) income and expenses for each income statement are translated at average exchange rates (unless this average is not a reasonable approximation of the cumulative effect of the rates prevailing on the transaction dates, in which case income and expenses are translated at the rate on the dates of the transactions); and
- (3) all resulting exchange differences are recognised as a separate component of equity.

(d) Property, plant and equipment

Buildings comprise retail shops and other properties such as office premises. Retail shops are stated at cost less accumulated depreciation and accumulated impairment losses. Properties other than retail shops ("Properties") are stated at valuation less subsequent accumulated depreciation. The valuation, being fair value at the date of valuation, is determined by the directors based on independent valuations which are performed at least every three years. In the intervening years, the directors review the carrying value of the buildings and adjustment is made where there has been a material change. Increases in valuation are credited to the revaluation reserve in shareholders' equity. Decreases in valuation are first offset against previous increases of the same property and are thereafter expensed in the income statement. Each year the difference between depreciation based on the revaluated carrying amount of the asset expensed in the income statement and depreciation based on the asset's original cost is transferred from revaluation reserve to retained earnings.

Buildings are depreciated on a straight-line basis over the unexpired period of leases or the expected useful lives of the buildings to the Group, whichever is shorter.

Other tangible fixed assets are stated at cost less accumulated depreciation and accumulated impairment losses. Cost includes the purchase price of the asset and any directly attributable costs of bringing the asset to its working condition and location for its intended use.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. All other repairs and maintenance are expensed in the income statement during the financial period in which they are incurred.

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at each balance sheet date.

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount (Note 3 (g)).

Gains and losses on disposals are determined by comparing net proceeds with carrying amount of the relevant assets and are included in the income statement.

(e) Leasehold land and land use rights

Leasehold land and land use rights are stated at cost less accumulated amortisation and accumulated impairment losses, (if any). Cost represents consideration paid for the rights to use the land on which various plants and buildings are generally situated for a period from 30 to 70 years. Amortisation of leasehold land and land use rights is calculated on a straight-line basis over the period of the lease.

(f) Trading licence

Trading licence with indefinite useful life represents a membership in Chinese Gold and Silver Exchange Society and is carried at cost less accumulated impairment losses, if any.

(g) Impairment of investments in subsidiaries. investment in an associate and non-financial assets

Assets that have an indefinite useful life or have not yet been available for use are not subject to amortisation/depreciation and are at least tested annually for impairment. Assets are reviewed for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount. The recoverable amount is the higher of an asset's fair value less costs to sell and value in use. For the purposes of assessing impairment, assets are grouped at the lowest levels for which there are separately identifiable cash flows (cash-generating units).

Non-financial assets other than goodwill that suffered an impairment are reviewed for possible reversal of the impairment at each reporting date. Where an impairment loss subsequently reverses, the carrying amount of the asset (cashgenerating unit) is increased to the revised estimate of its recoverable amount to the extent that the increased carrying amount does not exceed the carrying amount that would have been determined had no impairment loss been recognised for the asset (cash-generating unit) in prior years. A reversal of an impairment loss is recognised immediately in the income statement.

(h) **Inventories**

Inventories represent merchandises and are stated at the lower of cost and net realisable value. Cost is determined on the first-in, first-out basis. The cost of merchandise comprises raw materials, direct labour and other direct costs. It excludes borrowing costs. Net realisable value is the estimated selling price in the ordinary course of business, less applicable variable selling expenses.

(i) Financial assets

The Group classifies its financial assets in the following categories: at fair value through profit or loss and loans and receivables. The classification depends on the purpose for which the financial assets were acquired. Management determines the classification of the Group's financial assets at initial recognition and re-evaluates this designation at every reporting date.

(i) Financial assets at fair value through profit or loss

Financial assets at fair value through profit or loss are financial assets held for trading. A financial asset is classified in this category if acquired principally for the purpose of selling in the short term. Derivatives are classified as held for trading unless they are designated as hedges. Assets in this category are classified as current assets.

(ii) Loans and receivables

Loans and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market. They are included in current assets, except for those with maturities greater than 12 months after the balance sheet date which are classified as non-current assets. Loans and receivables include trade receivables, other receivables, deposits, amount due from an associate, amounts due from subsidiaries and cash and cash equivalents.

(i) Financial assets (Continued)

Regular purchases and sales of financial assets are recognised on the trade-date - the date on which the Group commits to purchase or sell the asset. Investments are initially recognised at fair value plus transaction costs for all financial assets not carried at fair value through profit or loss. Financial assets carried at fair value through profit or loss are initially recognised at fair value, and transaction costs are expensed in the income statement. Financial assets are derecognised when the rights to receive cash flows from the investments have expired or have been transferred and the Group has transferred substantially all risks and rewards of ownership. Financial assets at fair value through profit or loss are subsequently carried at fair value. Loans and receivables are initially recognised at fair value and subsequently carried at amortised cost using the effective interest method, less any provision for impairment.

Gains or losses arising from changes in the fair value of the "financial assets at fair value through profit or loss" category are presented in the income statement within other gains/ losses, in the period in which they arise. Dividend income from financial assets at fair value through profit or loss is recognised in the income statement as part of other income when the Group's right to receive payments is established.

The fair values of quoted investments are based on current bid prices. If the market for a financial asset is not active (and for unlisted securities), the Group established fair value by using valuation techniques. These include the use of recent arm's length transactions, reference to other instruments that are substantially the same, discounted cash flow analysis and option pricing models, making maximum use of market inputs and relying as little as possible on entity-specific inputs.

(j) Receivables

Receivables are recognised initially at fair value and subsequently measured at amortised cost using the effective interest method, less provision for impairment. A provision for impairment of receivables is established when there is objective evidence that the Group will not be able to collect all amounts due according to the original term of receivables. The amount of the provision is the difference between the asset's carrying amount and the present value of estimated future cash flows, discounted at the original effective interest rate. The carrying amount of the assets is reduced through the use of an allowance account, and the amount of the loss is recognised in the income statement within administrative expenses. When a receivable is uncollectible, it is written off against the allowance account for receivables. Subsequent recoveries of amounts previously written off are credited against administrative expenses in the income statement.

(k) Cash and cash equivalents

Cash and cash equivalents include cash in hand, deposits held at call with banks, other short-term highly liquid investments with original maturities of three months or less, and bank overdrafts, if any.

Bank overdrafts, if any, are shown within borrowings in current liabilities on the balance sheet.

(1) Derivative financial instruments

Derivatives are initially recognised at fair value on the date a derivative contract is entered into and are subsequently remeasured at their fair values. The method of recognising the resulting gains or losses depends on whether the derivative is designated and qualified as a hedging instrument, and if so, the nature of the item being hedged. Since the derivative financial instruments entered into by the Group do not qualify for hedge accounting, changes in fair value of any derivative financial instruments are recognised immediately in the income statement.

Financial liabilities and equity

Financial liabilities and equity instruments issued by the Group are classified according to the substance of the contractual arrangements entered into and the definitions of a financial liability and an equity instrument. Financial liabilities (including trade payables) are initially measured at fair value, and are subsequently measured at amortised cost, using the effective interest method. An equity instrument is any contract that does not meet the definition of financial liability and evidences a residual interest in the assets of the Group after deducting all of its liabilities.

Ordinary shares are classified as equity. Incremental costs, net of tax, directly attributable to the issue of new shares are shown in equity as a deduction from the proceeds.

(n) Financial guarantee contract liabilities

Financial guarantee contract liabilities are measured initially at their fair values and are subsequently measured at the higher of (i) the amount initially recognised less, where appropriate, cumulative amortisation recognised in the income statement over the period of the relevant liabilities and (ii) the amount of which the Group is obliged to reimburse the recipient under the financial guarantee contracts.

(0)**Borrowings**

Borrowings are recognised initially at fair value, net of transaction costs incurred. Borrowings are subsequently stated at amortised cost; any difference between the proceeds (net of transaction costs) and the redemption value is recognised in the income statement over the period of the borrowings using the effective interest method.

Borrowings are classified as current liabilities unless the Group has an unconditional right to defer settlement of the liability for at least 12 months after the balance sheet date.

(p) Borrowing costs

Borrowing costs incurred for the construction of any qualifying assets are capitalised during the period of time that is required to complete and prepare the asset for its intended use. All other borrowing costs are charged to the income statement in the period in which they are incurred.

(q) Current and deferred income tax

The current income tax charge is calculated on the basis of the tax laws enacted or substantively enacted at the balance sheet date in the countries where the Group operates and generates taxable income. Management periodically evaluates positions taken in tax returns with respect to situations in which applicable tax regulation is subject to interpretation and establishes provisions where appropriate on the basis of amounts expected to be paid to the relevant tax authorities.

Deferred income tax is provided in full, using the liability method, on temporary differences arising between the tax bases of assets and liabilities and their carrying amounts for financial reporting purposes. However, the deferred income tax is not accounted for if it arises from initial recognition of an asset or a liability in a transaction other than a business combination that at the time of the transaction affects neither accounting nor taxable profit or loss. Deferred income tax is determined using rates (and laws) that have been enacted or substantively enacted by the balance sheet date and are expected to apply when the related deferred income tax asset is realised or the deferred income tax liability is settled.

Deferred income tax assets are recognised to the extent that it is probable that future taxable profit will be available against which the temporary differences can be utilised.

Deferred income tax is provided on temporary differences arising on investments in subsidiaries and associates except where the timing of the reversal of the temporary difference is controlled by the Group and it is probable that the temporary difference will not reverse in the foreseeable future.

(r) Employee benefits

(i) Employee leave entitlements

Employee entitlements to annual leave are recognised when they accrue to employees. A provision is made for the estimated liability for annual leave as a result of services rendered by employees up to the balance sheet date.

Employee entitlements to sick leave and maternity leave are not recognised until the time of leave.

(ii) Profit sharing and bonus plans Provisions for profit sharing and bonus plans are recognised when the Group has a present legal or constructive obligation as a result of services rendered by employees and a reliable estimate of the obligation can be made.

(iii) Pension obligations Hong Kong

The Group operates a defined contribution Mandatory Provident Fund Scheme (the "MPF Scheme") which is registered under the Mandatory Provident Fund Schemes Ordinance in Hong Kong. The assets of the MPF Scheme are held in a separately administered fund. The MPF Scheme is generally funded by payments from employees and by the Group.

The Group's contributions to the MPF Scheme are expensed as incurred and are reduced by the employer's voluntary contribution forfeited from the MPF Scheme by those employees who leave the scheme prior to vesting fully in the contributions.

The People's Republic of China ("PRC") As stipulated by rules and regulations in the PRC, the Group contributes to state-sponsored retirement schemes for its relevant employees in the PRC. The Group's relevant employees make monthly contributions to the schemes at 10% to 13% of the relevant income (comprising wages, salaries, allowances and bonuses), while the Group contributes 24% to 37% of such income and has no further obligations for the actual payment of post-retirement benefits beyond the contributions. The statesponsored retirement schemes are responsible for the entire post-retirement benefit obligations payable to the retired employees.

The Group's contributions to the state-sponsored retirement schemes are expensed as incurred and are fully and immediately vested in the employees.

(iv) Long service payment

The Group's net obligation in respect of lump sum long service amounts payable on cessation of employment in certain circumstances under the Hong Kong Employment Ordinance is the amount of future benefit that employees have earned in return for their service in the current and prior periods. The obligation is calculated using the projected unit credit method by a qualified actuary, discounted to its present value, and the fair value of any related plan assets is deducted. The discount rate is the yield at balance sheet date on Exchange Fund Notes that have maturity dates approximating the terms of the Group's obligations.

(s) Revenue and income recognition

Revenue comprises the fair value of the consideration received or receivable for the sales of goods and services in the ordinary course of the Group's activities. Revenue is shown net of value-added tax, sales returns and discounts, after eliminated sales within the Group.

The Group recognises revenue when the amount of revenue can be reliably measured and it is probable that future economic benefits will flow to the Group. The amount of revenue is not considered to be reliably measurable until all contingencies relating to the sale have been resolved. The Group bases its estimates on historical results, taking into consideration the type of customer, the type of transaction and the specifics of each arrangement. Turnover represents revenues recognised on sales of goods, and are recognised as follows:

(*i*) Sales of goods – wholesales

Sales of goods are recognised when a group entity has delivered products to the wholesaler, the wholesaler has full discretion over the channel and price to sell the products, and there is no unfulfilled obligation that could affect the wholesaler's acceptance of the products. Delivery does not occur until the products have been delivered to the specified location, the risks of obsolescence and loss have been transferred to the wholesaler, and either the wholesaler has accepted the products in accordance with sales contract, the acceptance provisions have lapsed, or the Group has objective evidence that all criteria for acceptance have been satisfied.

(ii) Sales of goods - retail

Sales of goods are recognised when a group entity sells a product to the customer. Retail sales are usually in cash or by credit card. It is the Group's policy to sell its jewellery products to the end customers with a right of return within one year at a certain discount on the original selling price. Accumulated experience is used to estimate and provide for such returns at the time of sale.

Royalty income in respect of the use of the Group's trademarks is recognised on an accrual basis in accordance with the substance of the relevant agreements.

Consultancy fee income and service income in respect of technical support and consultancy services are recognised in the period the services are provided.

Rebate from import agents is recognised when there is reasonable assurance that the rebate will be received and all attaching conditions will be complied with.

Value-added tax refunds are recognised at their fair values in the income statement when there is reasonable assurance that the refund will be received and all the attaching conditions will be complied with.

Interest income from bank deposits is recognised on a time proportion basis using the effective interest method.

Dividend income is recognised when the right to receive payment is established.

(t) Operating leases (as a leasee)

Leases in which a significant portion of the risks and rewards of ownership are retained by the lessor are classified as operating leases. Payments made under operating leases (net of any incentives received from the lessor) are charged to the income statement on a straight-line basis over the period of the lease. When a component of the lease payment which is not fixed but is based on future amount of a factor, other than with the passage of time, such as percentage of sales or concessionaire fees, the amount is recognised as expenses as it arises.

(u) Dividend distribution

Dividend distribution to the Company's shareholders is recognised as a liability in the Group's financial statements in the period in which the dividends are approved by the Company's shareholders or directors, where appropriate.

- In previous year, the balance of employee benefit obligations was included in trade payables, other payables and accruals line item under the current liabilities in the balance sheet because of its materiality. During the year, management has revisited the presentation of employee benefit obligations and consider that the liability should be separately disclosed in the balance sheet of current year's financial statements under non-current liabilities as it is non-current in nature. Consequently, the amount of HK\$8.710.000 as at 31st March 2008 was reclassified from current to non-current liabilities to conform with current year's presentation.
- (ii) In previous year, gain/loss on derivative financial instruments – trading of gold was recognised as part of selling and distribution costs. In preparing the 31st March 2009 financial statements, management has determined that such gains and losses should be included in other gains or losses line item in the current year's income statement as they represent inflow or outflow of economic benefit to/from the Group. To conform with current year's presentation, the loss of HK\$31,815,000 incurred on trading of gold for the year ended 31st March 2008 was reclassified from selling and distribution costs to other gains/(losses) line item.

The Group's activities expose it to a variety of financial risks, including foreign exchange risk, cash flow and fair value interest rate risks, credit risk, liquidity risk and commodity price risk.

The Group's overall risk management programme focuses on the unpredictability of financial markets and seeks to minimise potential adverse effects on the Group's financial performance. The Group uses derivative financial instruments to manage certain risk exposures. The use of financial derivatives to hedge certain risk exposures is governed by the Group's policies approved by the Board of Directors of the Company.

(i) Foreign exchange risk

The Group mainly operates in Hong Kong with most of the transactions settled in HK\$. The Group also has retail and wholesale operations in the PRC, Macau, Canada and the United States, of which foreign exchange risk is considered insignificant. Foreign exchange risk arises when future commercial transactions or recognised assets or liabilities are denominated in a currency that is not the entity's functional currency. The Group is exposed to foreign exchange risk from various currency exposures, primarily with respect to Renminbi ("RMB") and the United States Dollars ("US\$").

The Group manages its foreign exchange risk by performing regular reviews of the Group's net foreign exchange exposures. The Group has not entered into any forward foreign exchange contracts to hedge its foreign exchange exposure as the directors are of the view that the potential foreign exchange exposures are not significant.

The Group's assets and liabilities, and transactions arising from its operations primarily do not expose the Group to material foreign exchange risk. The Group's assets and liabilities are primarily denominated in the respective group companies' functional currency.

At 31st March 2009 and 2008, if RMB and US\$ had weakened/strengthened by 5% against HK\$, with all other variables held constant, profit for the year would have been approximately HK\$473,000 and HK\$1,202,000 higher/lower respectively.

(ii) Cash flow and fair value interest rate risk

> The Group's income and operating cash flows are substantially independent of changes in market interest rates and the Group has no significant interest-bearing assets and liabilities except for the cash at bank and bank borrowings, details of which have been disclosed in Notes 31 and 26. The Group's exposure to changes in interest rates is mainly attributable to its borrowings. Borrowings carry at floating rates expose the Group to cash flow interest-rate risk. The Group has not used any interest rate swaps to hedge its exposure to interest rate risks as management considers that the Group's borrowings are relatively short-term and insignificant to the Group; any reasonable changes in interest rate would not result in a significant change in the Group's results. Accordingly, no sensitivity analysis is presented for interest rate risk.

(iii) Credit risk

The Group has no significant concentrations of credit risk. The carrying amounts of trade and other receivables, deposits, amount due from an associate and cash and cash equivalents included in the consolidated balance sheet represent the Group's maximum exposure to credit risk in relation to its financial assets.

The Group has policies in place to ensure that sales of products on credit terms are made to customers with an appropriate credit history and the Group performs periodic credit evaluations of its customers. The Group's concessionaire sales through department stores are generally collectible within 30 days from the invoice date while credit sales are generally on credit terms within 90 days. Normally the Group does not require collaterals from trade debtors. The existing debtors have no significant defaults in the past. The Group's historical experience in collection of trade and other receivables falls within the recorded allowances and the directors are of the opinion that adequate provision for uncollectible receivables, if any, has been made.

The deposits, other receivables and amount due from an associate are from counterparties with good credit history. There is no history of defaults from these counterparties.

As at 31st March 2009 and 2008, substantially all the bank balances as detailed in Note 31 are held in major financial institutions located in Hong Kong and the PRC, which management believes are of high credit quality. The Group has a policy to limit the amount of credit exposure to any financial institution and management does not expect any losses arising from non-performance by these counterparties.

(iv) Liquidity risk

> Prudent liquidity risk management implies maintaining sufficient cash and cash equivalents and the availability of funding through an adequate amount of committed credit facilities.

The Group's primary cash requirements have been for additions of and upgrades on property, plant and equipment, payment on related debts and payment for purchases and operating expenses. The Group finances its working capital requirements through a combination of internal resources and bank borrowings, as necessary.

The Group's policy is to regularly monitor current and expected liquidity requirements to ensure it maintains sufficient cash and cash equivalents and has available funding through adequate amount of committed credit facilities to meet its working capital requirements.

The table below analyses the Group's and the Company's financial liabilities into relevant maturity groupings based on the remaining period at the balance sheet date to the contractual maturity date. The amounts disclosed in the table are the contractual undiscounted cash flows based on the earliest date on which the Group and the Company can be required to pay.

(v) Commodity price risk

The Group is engaged in the sale of gold and platinum ornaments. The gold and platinum markets are influenced by global as well as regional supply and demand conditions. A significant decline in prices of gold and platinum could adversely affect the Group's financial performance. The Group uses certain derivative financial instrument-trading of gold contracts to reduce its exposure to fluctuations in the price of gold. The derivative contracts are settled every day end and the difference between the contract price and market price is immediately recognised in the income statement. As at 31st March 2009, the notional value of the outstanding contracts amounted to HK\$106,785,000 (2008: HK\$109,494,000).

At 31st March 2009, if the purchase price of gold and platinum had increased or decreased by 5%, profit for the year ended 31st March 2009 would have been approximately HK\$5,314,000 or HK\$9,014,000 lower, respectively.

At 31st March 2008, if the purchase price of gold and platinum had increased or decreased by 5%, profit for the year ended 31st March 2008 would have been approximately HK\$ 4,880,000 or HK\$5,118,000 lower, respectively.

(b) Fair value estimation

The carrying amounts of the Group's financial assets, including cash and cash equivalents, trade receivables, other receivables, deposits and amount due from an associate, the Group's financial liabilities, including trade and other payables, accruals and short-term bank loans, approximate their fair values due to their short maturities.

The fair value of financial instruments traded in active markets (such as derivative financial instruments-trading of gold) is based on quoted market prices at the balance sheet date. The quoted market price used for financial assets held by the Group is the current bid price.

The nominal values less any estimated credit adjustments for financial assets and liabilities with a maturity of less than one year are assumed to approximate their fair values. The fair value of financial liabilities for disclosure purposes is estimated by discounting the future contractual cash flows at the current market interest rate that is available to the Group for similar financial instruments.

(c) Capital risk management

The Group's objectives when managing capital are to safeguard the Group's ability to continue as a going concern in order to provide returns for shareholders and benefits for other stakeholders and to maintain an optimal capital structure to reduce the cost of capital.

The Group manages the capital structure and make adjustments to it in the light of changes in economic conditions. In order to maintain or adjust the capital structure, the Group may adjust the dividend payments to shareholders or obtain new bank borrowings.

The Group also monitors capital on the basis of gearing ratio and the compliance of covenants of its borrowings. The gearing ratio is calculated as net (cash)/ debt divided by total capital. Net (cash)/debt is calculated as total borrowings (including current and non-current borrowings as shown in the consolidated balance sheet) less cash and cash equivalents. Total capital is calculated as "equity", as shown in the consolidated balance sheet, plus net (cash)/debt.

5 CRITICAL ACCOUNTING ESTIMATES AND **JUDGEMENTS**

Estimates and judgments used in preparing the financial statements are continually evaluated and are based on historical experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances. The resulting accounting estimates will, by definition, seldom equal the related actual results. The estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year are discussed below.

(a) Useful lives, residual values and depreciation charges of property, plant and equipment/useful lives and amortisation of leasehold land and land use rights

The Group's management determines the estimated useful lives, residual values and related depreciation/amortisation charges for the Group's property, plant and equipment and leasehold land and land use rights with reference to the estimated periods that the Group intends to derive future economic benefits from the use of these assets. Management will revise the depreciation and amortisation charges where useful lives are different to previously estimated, or it will write-off or write-down technically obsolete or non-strategic assets that have been abandoned or sold. Actual economic lives may differ from estimated useful lives and actual residual values may differ from estimated residual values. Periodic review could result in a change in depreciable lives and residual values and therefore depreciation/amortisation expense in future periods.

(b) Inventories

Net realisable value of inventories is the estimated selling price in the ordinary course of business, less estimated costs of completion and selling expenses. These estimates are based on the current market condition and the historical experience of manufacturing and selling products of similar nature. It could change significantly as a result of changes in customer taste and competitor actions in response to severe industry cycle. Management reassesses these estimates at each balance sheet date.

(c) Impairment of non-financial assets

Non-financial assets including property, plant and equipment, leasehold land and land use rights, investments in subsidiaries and investment in an associate are reviewed for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. The recoverable amounts have been determined based on value-in-use calculations or fair value less costs to sell. These calculations require the use of judgments and estimates.

(a) 物業、廠房及設備之使用年期、剩餘價值及折舊費用/ 租賃土地及土地使用權之使 用年期及攤銷

本集團管理層參考本集團計劃自 使用該等資產而獲得未來經濟效 益之估計期限,釐定本集團物 業、廠房及設備以及租賃土地及 土地使用權之估計可使用年期、 剩餘價值及相關折舊/攤銷費 用。倘可使用年期與先前估計者 不同,管理層將修訂折舊及攤銷 費用,或將技術上過時或已報廢 或出售之非策略資產撇銷或撇 減。實際經濟年期可能有異於估 計可使用年期,而實際剩餘價值 亦可能有異於估計剩餘價值。定 期檢討可能會使折舊年期及剩餘 價值以致未來期間之折舊/攤銷 開支有變。

(b) 存貨

存貨的可變現淨值為日常業務中的估計售價扣除估計完工成本及銷售開支後的數額。該等估計乃根據現時市況及生產與出售類似性質產品的過往經驗而作出,並會因顧客口味的轉變及競爭對而有重大差異。管理層於各結算日重新評估該等估計。

(c) 非金融資產的減值

倘出現事件或情況變動顯示非 金融資產(包括物業、廠房及設 備、租賃土地及土地使用權、於 附屬公司之投資及於聯營公司之 投資) 賬面值可能無法收回,則 須檢討減值。可收回數額乃根據 使用值計算或按公平值減銷售成 本而釐定。該等計算須運用判斷 及估計。

(c) Impairment of non-financial assets (Continued)

Management judgment is required in the area of asset impairment particularly in assessing: (i) whether an event has occurred that may indicate that the related asset values may not be recoverable; (ii) whether the carrying value of asset can be supported by the recoverable amount, being the higher of fair value less costs to sell and net present value of future cash flows which are estimated based upon the continued use of the asset in the business; and (iii) the appropriate key assumptions to be applied in preparing cash flow projections including whether these cash flow projections are discounted using an appropriate rate. Changing the assumptions selected by management in assessing impairment, including the discount rates or the growth rate assumptions in the cash flow projections, could materially affect the net present value used in the impairment test and as a result affect the Group's financial condition and results of operations. If there is a significant adverse change in the projected performance and resulting future cash flow projections, it may be necessary to take an impairment charge to the income statement.

(d) Current and deferred income taxes

The Group is subject to income taxes in the PRC and other jurisdictions. Judgement is required in determining the provision for income taxes in each of these jurisdictions. There are transactions and calculations during the ordinary course of business for which the ultimate tax determination is uncertain. Where the final tax outcome of these matters is different from the amounts that were initially recorded, such as differences will impact the income tax and deferred income tax provisions in the period in which such determination in made.

Deferred income tax assets relating to certain temporary differences and tax losses are recognised when management considers it is probable that future taxable profits will be available against which the temporary differences or tax losses can be utilised. When the expectation is different from the original estimate, such differences will impact the recognition of deferred income tax assets and taxation charges in the period in which such estimate is changed.

(c) 非金融資產的減值(續)

(d) 即期及遞延所得税

本集團須繳納中國及其他司法權 區的所得税。釐定各司法權區的 所得税撥備時,需作出判斷。在 日常業務中有若干未能確定最終 税項的交易及計算。倘該等事宜 的最終税務結果有異於最初記錄 的數額,則有關差額會影響釐定 有關數額期間的所得税及遞延所 得税撥備。

與若干暫時差異及税項虧損有關 之遞延所得税資產,按管理層認 為未來有可能出現應課税溢利可 用作抵銷該等暫時差異或税項虧 損而確認。當預期之金額與原定 估計有差異時,則該差異將會於 估計改變之期間內,影響遞延所 得税資產之確認及所得税費用。

(e) Provision for long service payment

The Group's provision for long service payment is determined with reference to statutory requirements, the employees' remuneration, their year of services and age profile, and demographic assumptions including, pre-retirement termination, involuntary termination, early retirement, normal retirement, death and disability. The basis of estimation is reviewed on an on-going basis and revised where appropriate. Any changes in these assumptions will impact the carrying amount of provision for long service payments and as a result affect the results and financial position of the Group.

6 TURNOVER AND SEGMENT INFORMATION

The Group is principally engaged in the retailing and wholesaling of gold jewellery and gold ornaments, gem-set jewellery and gemstones, and other accessory items.

Turnover represents invoiced sales of goods and includes an amount of HK\$480,158,000 (2008: HK\$625,268,000) which was settled by gold bullion and the gold bullion was in turn used for settlement of trade payables.

Primary reporting format – business segments

The Group is organised mainly in Hong Kong and the PRC into two major business segments:

- Retailing of jewellery
- Manufacturing and wholesaling of jewellery, including the provision of technical support and consultancy services, and quality control of jewellery products to certain licensees

Other operations of the Group mainly represent investments and services relating to internet and software development.

Operating expenses of a functional unit are allocated to the relevant segment which is the predominant user of the services provided by the unit. Operating expenses of other shared services which cannot be allocated to a specific segment and corporate expenses are included as unallocated expenses.

Segment assets consist primarily of property, plant and equipment, leasehold land and land use rights, inventories, trade receivables, deposits, prepayments and other receivables, and operating cash. They exclude deferred tax assets and corporate assets.

(e) 長期服務金撥備

本集團其他業務主要指投資以及有關互 聯網及軟件開發之服務。

Pursuant to the new PRC corporate income tax rules promulgated in 2007, these subsidiaries are subjected to tax rate gradually increased to 25% towards year 2012.

The remaining shares of Luk Fook Control are widely held.

- (a) A subsidiary of the Company entered into a tenancy agreement with Mr WONG Kwai Sang (deceased), Mr. WONG Wai Sheung's father, for the lease of a retail shop of the Group for a period of 1 year (2008: 1 year), expiring on 31st December 2009. The beneficial interest of the tenancy agreement was transferred to Mr. WONG Wai Chung in the capacity as Estate Administrator, after the death of Mr. WONG Kwai Sang on 23rd April 2008.
