3. WHO CAN APPLY FOR PUBLIC OFFER SHARES

- (a) You, the applicant(s), and any person(s) for whose benefit you are applying, must be 18 years of age or older and must have a Hong Kong address.
- (b) If you are a **firm**, the application must be in the names of the individual members, not in the name of the firm. The number of joint applicants may not exceed 4.
- (c) If your are a **body corporate**, the application must be signed by a duly authorized officer, who must state his or her representative capacity.
- (d) Save under the circumstances permitted by the Listing Rules, you **cannot** apply for any Public Offer Shares if you are or any person(s) for whose benefit you are applying are/is:

- agrees that once the application of HKSCC Nominees is accepted, neither that
 application nor that person's electronic application instructions can be
 revoked and that acceptance of that application will be evidenced by the
 announcement on results of the Public Offer published by the Company;
