A conditional placing agreement (the “Placing Agreement”) was entered into between the Company and a placing agent, Kingston Securities Limited, on 3 February 2010 for placing of a maximum of 2,300,000,000 shares of HK\$0.01 each (the “Shares”) of the Company, on a best effort basis, at a placing price of HK\$0.05 per Share under a specific mandate (the “Placing”).

Upon completion of first tranche of the Placing (as detailed in the Company’s announcement dated 22 April 2010), 1,200,000,000 Shares were issued and allotted on 22 April 2010. The remaining 1,100,000,000 Shares may be issued and allotted subject to fulfilment of condition(s) set out in the Placing Agreement.
