Even if you have chosen (or are deemed to have consented) to read the website version of the Current Corporate Communication posted on the Bank's website but for any reason you have difficulty in receiving or gaining access to such website version, the Bank will promptly upon your request send the Current Corporate Communication in printed form to you free of charge.

For those Shareholders who would like to appoint proxies to attend and vote in their stead at the Second Extraordinary General Meeting of 2010 of the Bank to be held on 15 September 2010, please download the Supplemental Proxy Form from the Bank's website, and complete, sign and deposit the Supplemental Proxy Form at the H Share Registrar following the instructions as provided in the Notes to the Supplemental Proxy Form. Please note that the Supplemental Proxy Form is for the purpose of the supplemental resolution set out in the Supplemental Notice of the Second Extraordinary General Meeting of 2010 of the Bank dated 27 August 2010 and only serves as a supplement to the original proxy form for the Second Extraordinary General Meeting of 2010 of the Bank.
