Even if you have chosen (or are deemed to have consented) to read the website version of the Current Corporate Communication posted on the Bank's website but for any reason you have difficulty in receiving or gaining access to such website version, the Bank will promptly upon your request send the Current Corporate Communication in printed form to you free of charge.

For those Shareholders who would like to appoint proxies to attend and vote in their stead at the Second Extraordinary General Meeting of 2010 and/or the First H Shareholders Class Meeting of 2010 of the Bank to be postponed to 21 September 2010, please download the Second Proxy Form(s) from the Bank's website, and complete, sign and deposit the Second Proxy Form(s) at the H Share Registrar following the instructions as provided in the Notes to the Second Proxy Form(s). If correctly completed and lodged with the H Shares registrar of the Bank not less than 24 hours before the time fixed for holding the Secondary Extraordinary General Meeting of 2010 and/or the First H Shareholders Class Meeting of 2010 or any adjournment thereof, the Second Proxy Form(s) shall supersede the original proxy form(s) issued by the Bank along with the Notice of the Second Extraordinary General Meeting of 2010 and Notice of the First H Shareholders Class Meeting of 2010 on 29 July 2010 and the supplemental proxy form issued by the Bank along with the supplemental notice of the Second Extraordinary General Meeting of 2010 on 27 August 2010.
