## **ANNOUNCEMENT**

The board of directors (the “Board”) of China Longyuan Power Group Corporation Limited\* (the “Company”) announces the unaudited consolidated results for the three months ended 31 March 2011 of the Company and its subsidiaries (the “Group”).

This announcement is made pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.

For the three months ended 31 March 2011, revenue of the Group amounted to RMB3,536 million, representing an increase of 16.3% over the corresponding period of last year, among which, revenue from our wind power business amounted to RMB1,586 million, representing an increase of 43.4% over the corresponding period of last year, whereas revenue from our coal power business amounted to RMB1,854 million, representing a decrease of 0.9% from the corresponding period of last year, and revenue from other businesses amounted to RMB96 million, representing an increase of 46.0% over the corresponding period of last year. Net profit attributable to shareholders amounted to RMB635 million, representing an increase of 60.9% over the corresponding period of last year. Power generation on consolidated basis amounted to 6,515,782MWh, representing an increase of 21.68% over the corresponding period of last year. In particular, wind power generation amounted to 3,637,177MWh, representing an increase of 41.39% over the corresponding period of last year, whereas coal power generation amounted to 2,838,003MWh, representing an increase of 2.75% over the corresponding period of last year, and other renewable energy power generation amounted to 40,602MWh, representing an increase of 100.23% over the corresponding period of last year.
