The deferred amount will be accrued in the Bank’s accounts and withheld from the payment of remuneration to the said individuals for 2010. The deferred payment will be made having regard to the operating performance and status for the years 2011 to 2013, and the proportion payable each year will be one-third of the amount.
- Independent non-executive directors, Mr. Huan Huiwu, Mr. Gao Jianhong, Ms. Li Chunxiang, Mr. Li Jun, Mr. Li Xiwen and Mr. Wei Fusheng, received remuneration from the nominating party.
- Pursuant to relevant regulations, Mr. Xu Shanda, an independent non-executive director, did not receive any allowance from the Bank since 1 July 2008.
- The total remuneration before tax for 2010 for Mr. Zhu Lifei represents the remuneration received by Mr. Zhu for the period when he acted as the Employee Supervisor of the Bank in 2010.
- The total remuneration before tax for 2010 for Mr. Zhang Hongli represents the remuneration received by Mr. Zhang for the period when he acted as the Senior Executive Vice President of the Bank in 2010.
