ANNOUNCEMENT POWER GENERATION FOR JANUARY 2012

The announcement is made pursuant to Rule 13.09(1) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.

The board of directors (the “**Board**”) of China Longyuan Power Group Corporation Limited* (the “**Company**”) announces that, according to the Company’s preliminary statistics, the power generation of the Company and its subsidiaries (the “**Group**”) for January 2012 on consolidated basis amounted to 2,020,866MWh, representing a decrease of 14.85% compared with the corresponding period of 2011. In particular, the decrease in wind power generation and coal power generation registered 3.80% and 28.68% respectively, and other renewable energy power generation registered an increase of 128.66%. As at 31 January 2012, the total power generation of the Group for 2012 amounted to 2,020,866MWh, representing a decrease of 14.85% compared with the corresponding period of 2011. In particular, the decrease in wind power generation and coal power generation registered 3.80% and 28.68% respectively, and other renewable energy power generation registered an increase of 128.66%.
