Total on-grid power generation of the Group amounted to 45.5071 billion kWh, representing an increase of approximately 4.93% when compared to the corresponding period of the previous year. The increase in power generation of the Group was mainly attributable to an increase in capacity of the operational generating units of the Group and an increase in average utilization hours of the Group's coal-fired power generation units.
