ANNOUNCEMENT POWER GENERATION FOR APRIL 2013

The announcement is made pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Cap. 571).

The board of directors (the “**Board**”) of China Longyuan Power Group Corporation Limited* (the “**Company**”) announces that, according to the Company’s preliminary statistics, the power generation of the Company and its subsidiaries (the “**Group**”) for April 2013 on consolidated basis amounted to 3,070,342MWh, representing an increase of 13.06% compared with the corresponding period of 2012. In particular, the wind power generation registered an increase of 19.65%, the coal power generation registered an increase of 1.86% and other renewable energy power generation registered an increase of 3.76%. As at 30 April 2013, the total power generation of the Group for 2013 amounted to 11,219,958MWh, representing an increase of 15.88% compared with the corresponding period of 2012. In particular, the wind power generation registered an increase of 28.84%, the coal power generation registered a decrease of 3.48%, and other renewable energy power generation registered an increase of 0.41%.
